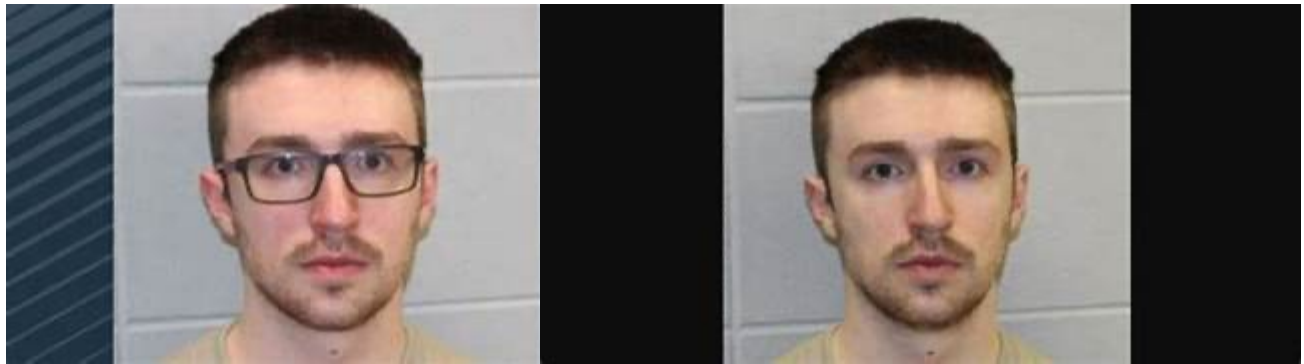


The Chandler Halderson Event was Faked

One of the things I have discovered in the past couple of years is that the CIA/Intel community has dummy courts in many large cities that it uses to run fake trials after fake events. We saw lots of evidence for this starting back in the 1990s, with the [OJ Simpson trial](#) and others, with mystery courts in Los Angeles leading the pack. They had been there at least since the fake Manson trials in the early 1970s. But since then we have seen it isn't just Los Angeles or Hollywood that has these dummy courts. Apparently all the major cities have them.

So I knew this 2021 event was faked before I even started researching it. It was televised on **CourtTV**, so I knew it was faked. Only CIA fake court cases are televised. The fact that CBS' *48 Hours* pushed it later just confirmed that. That is why these “news” shows were invented: to salt in these CIA fake events.

As you may remember, Halderson was convicted of murdering his mother and father, dismembering their bodies, and discarding their remains after a failed attempt to burn them in the family fireplace. Yeah, because that is what they teach Eagle Scouts to do, right? And if you do have to burn your parents in the family fireplace, be sure to leave some charred remains there for the police to find, as Halderson did. Because, you know, who can think of everything?

And what is the point of faking all these events across many decades? I have hit that hundreds of times as well: **Men Are Pigs**. Split the sexes. Create fear in women first and in everyone else second, in order to manufacture chaos. OPERATION CHAOS. Which is a real thing. Look it up if you don't believe me.

Strangely, although this event was sold big-time by CBS, Wikipedia has no page for it or for Halderson. I guess they didn't want to make this too easy for me.

I led with those two photos under title for a reason. They prove the fake without further research. Why? Because they are both fake. Each one disproves the other. Both were released by the jail as mugshots and are unretouched. I got them from mainstream sites reporting the story, not from conspiracy sites. The first comes from [FOX47.com](#). The other one is published all over the internet. You may think they just shot him with his glasses, then asked him to remove them for some reason.

Chandler's alleged girlfriend is given as Cathryn (Cat) Mellender, whose mother is listed as Dulce Mellender, aka Lopez-Alfaro. But if we check her listing, she isn't related to anyone named Lopez or Alfaro. So we immediately see evidence of scrubbing. If we search nationwide, we find only one Dulce L. Alfano, and she links us to Burlington, NC, and Tyler, TX. The father appears to be David Mellender, Apo AE. That's US military in Europe. Lori Mellender has the same military addresses as David, so maybe a second wife? Cathryn's siblings have links to Omaha, so they may be linked to the military base there. We also link to an Amara/Amira Anderson who links us to a Devon Anderson, 30, of DC. That's weird, because if we search further on him, we find him also listed as 36. Also of Oxen Hill, MD, which is probably Joint Base Andrews. We find an older Devon Anderson in DC, though I couldn't immediately make the link between them as father and son; but [this older Devon is a Principal at the Carlyle Group](#), which fits this event like a hand in a glove. He is formerly of KPMG and Arthur Anderson, ditto.

And, also as usual, it appears Halderson and Mellender are cousins, since we can link them through the Vandinters to Jakusz. The surname Jakusz is yet another princely name from Poland, [close cousins of the Konopackis](#).

There is your proof Cat and Chandler are cousins, straight from Geni.com. We even have the right location in Wisconsin. And that listing also tells us Jakusz=Cychosz, since they are pronounced the same.

We find out [here](#) the Haldersons are also **Townsend**s via marriage. Krista's cousin is given as Barbi Townsend. Instantcheckmate lists her in WI as Barbie or Barbara, not Barbi. Her relatives list is scrubbed, a huge red flag. But her location list includes Temple, TX, which would be Fort Hood. We are told by CBS she is now living in Southern California, but there is no listing for that. Fortunately, Intelius has more info on her, including a location of DC.

It is on the north shore of Lake Winnebago, and a lot of the people above are linked to it, including the Haldersons. Mellenders and Konopackis. See for example Tacia Mellender/Hill of Appleton, related to Dulce. All these Barbara Townsends, including the one above, are related to a Robert Townsend. And who is he?

Note the second one there has San Diego on her list, linking us to Southern California. Regardless, you can see that all these Barbara Townsends look like the same super agent, with about a dozen listings sometimes separated out by states. More proof of that is that the second Barbara Townsend just above is related to herself at least seven times, with Bobbi=Barbi.

Through the Tylers, this Barbi Townsend of California links us to the **Comstocks**, including Harold E. and Angela Comstock. These are the wealthy and famous Comstocks originally of the Comstock Lode east of Sacramento. See for example Harold Elwood Comstock, the famous fighter pilot who died in 2009. So we find yet another famous link of these nobody Haldersons in Wisconsin.

We also find Barbi Townsend of Newport Beach linked to Mariners Church: another red flag.

They test your intelligence again with this part of the story: we are told that Cat forced Chandler to put a Snapchat tracking device on his phone so that she could track him. This was allegedly due to him having previously cheated on her. For some reason he agreed to do that, though she was only 20. Not only that, but he took his phone with him when he tried to hide his mother's body. He decided to bury her in a place he had previously been photographed with a large hunting knife.



Because that makes sense, right? I mean, dis boy jus dat stupid. He hid his mother by his favorite swimming hole. Cat noticed on the tracking app he had been there and told police. They went there and immediately found the body. Wow, that was easy! They found his father's body even faster, we are supposed to believe, since he buried it during the day on Cat's parents' property, after talking to them and being seen by them there. Seems logical, right? I mean, isn't that what you would do under the circumstances? It was that or bury them on the town square, I guess.

Beyond that, we are supposed to believe Chandler carried his father's body in a tarp we have video of him buying that week. After burying the body, what did he do with the tarp? Well, what would you do? He threw it in the trash on site, on the farm. Brilliant. He disposed of a saw and scissors in the same clever way, by putting them nearby in a rusty oil drum.

But it gets better. Police also found a gun hidden on that farm, and we are told he killed the father with it.



That's the picture police provided, so Chandler did a bang-up job of hiding it, right? But there is bigger problem. Maybe you can help me with it. There is no silencer on that gun. No one heard gun shots at the house, so what are we supposed to believe happened? He took his parents out to the farm, killed them in the barn, then drove them back home and tried to burn them in the fireplace? That didn't work so he drove dad back out to the farm and buried him, disposing of the gun while he was at it?

Do you really think someone is going to hide a gun like that by leaning it against the wall in a barn? Why not throw it in a lake? Wisconsin is stiff with lakes. And is that gun legal? Was it registered to Chandler or his family? No, we are told it was a gift from military man Andrew Smith, who knew Chandler [from gaming online](#). Right. He just happened to give Chandler this \$500 SKS and 480 rounds of ammunition right before the murders, on their first meet-up. Makes perfect sense to me. Smith testified on the stand, and he is among the worst courtroom actors ever, cussing at the defense attorney and not being warned by the judge. All Hollywood, but no one saw through it.

And where was Smith stationed? Germany, which would be Apo AE, which we saw above.

They also need to dip into a bigger batch of names for these fakes, since the Crumbley fake at Oxford High School in November of 2021 also happened to include an Andrew Smith. [The Halderson event was in July of that year.] In the Oxford event, Andrew Smith was the COO of the real estate firm where Crumbley's mother worked. For some reason he testified in the case, though no one knows why. We are supposed to believe the mother was unloading on her boss about her son's problems?

Here's another case-ending problem: the detective is given as Brian Shunk. Unfortunately, the big computers have never heard of a Brian Shunk of Wisconsin. It is just a joke on Skunk. Another detective was Stacey Sadoff. We find her, but she is both very young and very spooky. She was just 35 and her father is Michael Sadoff of Appleton, giving us that link again. He also has Cheyenne, WY, on his list, possibly linking us to Warren AFB.

Also proving this was a fake is that the district attorney of Dane County was too busy to try this nationally televised case, giving it to his deputy DA William Brown. In fact, Brown had only been deputy DA for one year in 2021, having previously been just an assistant. But this is what we have always found with these dummy courts, going back to Marcia Clark of the OJ Simpson fake, who was also a deputy DA. The DA, Gil Garcetti, was too busy with real trials to get involved in that. We saw that Clark wasn't even a real deputy DA, having been inserted into that district by CIA just for that fake. I reminded you then and have reminded you many times that deputy DAs don't try high-profile multiple murders like this, except in the case they are manufactured by Intel.
