STUPIDEST STORY OF THE YEAR? AWARD GOES TO...

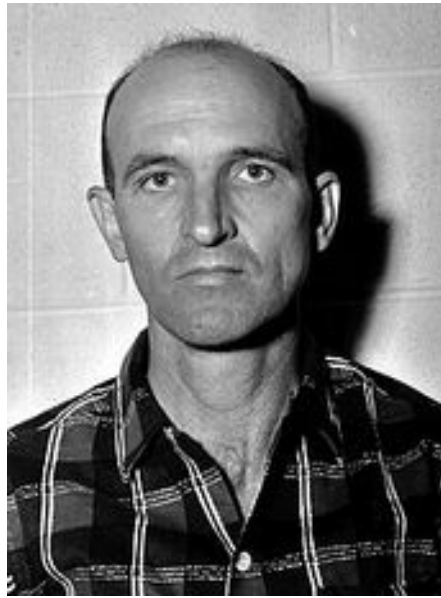
As usual, this is just my opinion. . . except for all the data collected from mainstream sites, which is not just my opinion.

You may need to put on a truss, because you are going to laugh so much it hurts. I know, [this Halloween story](#) from the *Washington Post* has a lot of competition in stupidest-story-of-the-year category. Every story the mainstream publishes is now a groaner, but this one may take the cake for 2019. It just happened to come out on Halloween by accident, I guess. It is about a Jewish black activist who allegedly convinced a [Jewish] Neo-Nazi leader to turn over the largest group in the country [57 chapter in 39 states] to him. They don't admit the Neo-Nazi is Jewish, but he is. A gay Jewish actor who may soon fake his death. Langley really needs to branch out a bit.

James [Stern](#) is the black guy and Jeff [Schoep](#) is the other guy in this theater production. Amazing they didn't even bother to change Jeff's last name to something that at least *sounded* Gentile, right? Like Smith or Jones or something. How hard would that be? There he is above, center, doing his best Jack Black impression. [They admit Black is Jewish, by the way.] They seem to have several bozos playing this guy, since he looks different in every picture in the article.

Anyway, Schoep was supposedly fighting a lawsuit from the Charlottesville incident, [which was fake](#). So the lawsuit is also fake. But this lawsuit was the wedge Stern was using. He would get the charges

dismissed in return for control of the organization.



And now for the backstory: Stern had been in the same jail with Edgar Ray Killen, the Klan leader who had orchestrated the Mississippi Burning murders in 1964. Stern was allegedly in for fraud, but for some reason we are supposed to believe he was in the same cell block as mass murderers. He convinced Killen to “sign over his life rights and legal power” in return for a book and movie deal. The writer, Katie Mettler, doesn't bother to tell us what “signing over your life rights” means. She can't because it doesn't mean anything. She also doesn't bother to tell us how Stern had any connections to Hollywood or publishers. Details. However, since the Freedom Summer murders were also fake and Killen was never in jail, we know this didn't happen either. Do you want to guess when Killen allegedly died in jail? January 11, 2018. Or, 1/11/18. Aces and eights. Chai. Also, do you think it is just a coincidence this guy has the name Killen? Killen=Killing. The fake isn't subtle here.

If you don't believe me, you might want to check out [Edgar Ray Killen's Intelius page](#). Although the mainstream tells us Killen was an ignorant saw mill operator, Intelius tells us he went to Mississippi State University and worked for the *New York Post*, NPR, MSU, KACST and the Andrew Goodman Foundation. Andrew Goodman is one of the Jewish kids he allegedly murdered, so it is interesting to see them hiring him to work for them from jail. KACST is the King Abdulaziz City for Science and Technology in Saudi Arabia. Other locations listed for Edgar Ray Killen, age 94, include New York, Harrison, AR, and Washington, DC. Do I really need to continue?

No, I don't, but I will just for fun. Notice Killen's middle name. I **guarantee** you that links us to James Earl Ray. In [my paper on MLK](#), I showed you that Ray descends in direct line from many Kings of England. He is *closely* related to President **James Earl** Carter. [The Rays are in the British peerage](#), being related to the Russells, Campbells, Cavendishes, Fitzgeralds, Husseys, Stuarts, Arbuthnotts, and Spencers, and James Earl Ray is one of them.

[At Findagrave](#), we discover one of Killen's 2great-uncles was **John Milton Mason**, son of Solomon Mason. Remember, I have shown you that the poet John Milton was Jewish and that he was ancestor of Daniel Boone. Another was **Isaac Presley** Mason. Here we also hit the **DeLeons**, who were

admittedly Jewish. Another ancestor is John MacDonald of Scotland, shipmaster of the *Boyd*. This may link us to the Boyd Massacre of 1809 in New Zealand, which also included a ship of the same name owned by a MacDonald. Curious that this ignorant sawmill operator has a genealogy known and posted back to the 16th century. We also find the names Hickman, Winstead, Sellers, McNair, Mann and Viverette. We find [Lancelot Viverette](#) was a large landowner in Virginia in the 1700s. He had a mulatto child named Jude.

On his father's side, Killen's 2g-grandfather was Elijah Elihu Smith. One of Killen's sisters married a Hardy, linking us to Conns (Cohens). That's about all we get on that side, though, since they appear to be breaking any link to the name Ray. But we have enough to go on, with aunts named Jewel and so on.

Also remember that in 1966 when this project was run the first time, Killen's trial ended in a hung jury. He was released and not retried. Finally, in 2005, almost 40 years later, a now 80-year-old Killen or someone his age was retried and found guilty. The judge was Marcus **Gordon**. Prosecutors were Jim Hood and Mark Duncan. You can be sure this was another fake. Hood got his JD in 1988, but his first case mentioned at Wikipedia is in 2004, giving us a 16-year gap in his bio. [After his conviction](#) in 2005, Killen was released on bond while he appealed. What? You don't release someone serving three 20-year sentences for murder on bond just because they have appealed. This is proof the trial was faked. Judge Gordon said it was because Killen was in delicate health, being in a wheelchair. But do you need great health and mobility to order the murders of people? That is what he was convicted of, remember? So this makes no sense, as usual.

[You may also wish to consult](#) *Payton v. State of Mississippi*, involving this same Marcus Gordon. Just read the case and see if you think it makes any sense. Here's the only clue you need, the first sentence of the appeal:

Before KING, C.J., IRVING and BARNES, JJ. Imhotep Alkebu-Lan, Chokwe Lumumba, Jackson, attorneys for appellant. Office of the Attorney General by Scott Stuart.

How many red flags can you spot there? Let's start with the biggest: **Imhotep**. This attorney for appellant was named Imhotep? It's a joke. They might as well have named him King Tut-Husseini-Khomeini. But all the other names are red flags as well: Stuart, Irving, Barnes, Jackson, King, **Lumumba**. Indicating the whole thing was another charade. It concerned a bank robbery where the robbers, led by Payton, also burned a nearby parking garage as a decoy and kidnapped the president of the Walnut Grove Bank, Ray Britt. First of all, how do you set fire to a parking garage? Every one I have seen has been made of concrete. Concrete doesn't burn very well, does it? Another part of the story is that police were unable to apprehend the suspects after they broke through a roadblock, so the police radioed ahead to two semi-trucks to drive side by side to block the highway. This allegedly worked, forcing the car to exit the interstate. Do you really believe that? These private truck drivers are going to agree to be part of a dangerous police chase, where they could have lost their rigs in a crash? No way. This whole story reads like bad fiction. Don't believe me? Who was driving the getaway car? Bank president Ray Britt. After exiting the highway, Britt allegedly grabbed the gun pointed at his head and purposely crashed the car. OK.

Caught dead to rights, all the robbers were convicted and given maximum sentences. So how could Payton appeal? Well, allegedly Payton's attorney Lumumba got in a heated argument with Judge Gordon, who cited him for contempt. Gordon then recused himself, though on what grounds is unclear. A judge who correctly cites an attorney for contempt doesn't need to recuse himself. The Supreme

Court appointed a special judge to finish the case, Payton was convicted again, and the special judge sent the case back to Gordon for resentencing. Again, that doesn't make any sense, because the appointed judge should have done the resentencing herself. Payton then appealed the resentencing, arguing Gordon had recused himself. The appeals court agreed with that, finding with Payton. So again, we are in the presence of law stories for the legally insane.

A search on Ray Britt takes us to Zoominfo, where we find one working at ONI, Office of Naval Intelligence, Chantilly, VA. But the Google listing for Ray Britt tells us we were going to find a CEO of Bank at Walnut Grove at that link.

But when we get there, he isn't there. We do find why they ran this fake event though. [At the Clarion Ledger](#), we find this article entitled “Walnut Grove: a correctional facility's closure would devastate the small Mississippi town”. Turns out, the local jail is the top employer in Walnut Grove, employing 200 in a town of 500. So they can't live without crime. If it doesn't manifest on its own, we see how they can create it. I would guess the second biggest employer is the court, which is why they manufacture all these cases and fake appeals.



OK, let's get back to the original farce here. We could segue into ever stupider farces indefinitely, but I have cats to feed. Next we learn that Stern, above, duped Schoep in 18 phonecalls. It was that or 33. We are told Schoep secretly replaced his top officers in his “incorporation paperwork” with Stern and another black activist, and fired his attorneys. Wait, neo-Nazi groups have incorporation paperwork? Good to know. That's for tax purposes, I guess.

But why would he fire his attorneys before Stern got the charges dropped? Details.

Also strange is the photo of Stern they lead with in the current article at the *Washington Post*.



Is that supposed to be avant garde? Sit your hero in a corner in a pink Hollister shirt in striped light? Is that some sort of hypnosis by patterning? Let me know what it does for you, because it ain't workin on me.

Now this really gets convoluted. Stern, a baptist preacher in Moreno Valley, CA, near Los Angeles, known for local initiatives, is also described as serving the projects of Watts. Well, which is it? Watts and Moreno Valley are about 50 miles apart. But the clue is probably that Moreno Valley is on the edge of March Air Force Base. My guess is Stern was assigned to this project from there. Anyway, in 2004, Stern

obtained a list of Mississippi barbers and hairstylists, then retrieved their financial information to print false bank statements. Although he always maintained his innocence, Stern pleaded guilty to five counts of wire fraud and was sentenced to 25 years in prison with 10 suspended. He wound up at Parchman Farm in Mississippi, the state's oldest and most notorious prison, where Edgar Ray Killen was confined.

I'm sorry, what part of that starts making sense? Why would this guy in California obtain a list of MS barbers? He was a fan of Cedric the Entertainer, and just loved *Barbershop*? Actually, anyone can obtain a list of MS barbers. Just go online or look in a phonebook. But how does that allow you to retrieve any financial information, or allow you to print false bank statements? And what does that have to do with wire fraud? I'm not seeing the con or the steal here. What did he do, fly to Mississippi and walk into local banks with false statements, requesting a refund? Where does the money come in? And why would he be sent to Parchman Farm, which is a maximum security prison? Is wire fraud now a maximum security crime? My guess it is because Parchman Farm has a fake wing, like ADX Supermax, Corcoran, and many others. In fact, we know it does by looking at its famous prisoner list, which includes not only Killen but Samuel Bowers of the same event. We have hit him before in my papers on [Ed Kemper](#) and [Pittsburgh](#). Also Curtis Flowers, whose has had six trials for one event and won appeals on all of them, but is for some reason still in jail. This sounds like another court cottage industry. His event was in Winona, which is famous for these questionable stories. See the MLK beating there, and the beating of Fannie Lou Hamer, a civil rights activist. She just happened to be a **Townsend**. Elvis Presley's father Vernon also allegedly spent time in Parchman Farm.

John Lewis, one of the original 13 Freedom Riders from 1960 and later one of the Big Six civil rights leaders, also allegedly spent time in Parchman's Farm. As Chairman of the SNCC, you should immediately peg him as an agent. His mother was a **Carter**. He has siblings named Ora, Rosa, Samuel, and **Adolph**. He is sold to us as the son of sharecroppers, but are told he took a childhood trip to Buffalo, NY. Why would sharecroppers be taking a trip to Buffalo? Anyway, the SNCC came out of Ella Baker's group at Shaw University, which in turn came out of the Young Negroes Cooperative League (YNCL) founded by George **Schuyler**. I hope that name looks familiar, because we have seen it many times. George, though part black, was likely descended from the superwealthy Schuylers of New York, related closely to the Hamiltons, van Rensselaers, van Cortlandts, and Livingstons—i.e. American crypto-Jewish royalty. George's mother was a **Fischer**, doubling that bet. His bio tells us George's ancestor simply worked for general Philip Schuyler, taking his name, but much more likely is that this ancestor was a bastard son of one these Schuylers.

Although we are given no believable story for how he got the job, George was hired early on by *The Messenger* to write a column. This was founded in 1917 in Harlem by **Chandler Owen** and **Philip Randolph**. They were part black, but note the names. Peerage names, all four. Owen went to Columbia in the 1910s, contradicting what we have been taught about blacks being denied admission to such places. He and Randolph were leading Socialists of the time, being known as the Trotsky and Lenin of Harlem. As we now know, that is enough to peg them as crypto-Jewish tools. Also in support of that, we find that by 1920, Owen was a Republican. No, the Republican Party was not progressive in the 1920s. Which brings us back to George Schuyler. He too soon became an “arch-conservative”, blowing his early cover. We can also peg him since his main target as a writer was Christianity and organized religion—making him an obvious part of the Theosophy project. He held both white and black churches in contempt and was an early promoter of the Jesus Myth. Schuyler opposed both MLK and the 1964 Civil Rights Act. He also argued *in favor* of apartheid. So anyway, that's the kind of people that the SNCC came out of. Ella Baker was director of Schuyler's group in the 1930s, so you can't argue she didn't know who he was. So it is very strange to see the SNCC and NAACP come from these roots. But we will have to hit that in more depth later.

Luke Woodham, alleged murderer in the 1997 Pearl High School event is also allegedly at Parchman Farm, telling me that was another fake. He was supposed to be a Satanist who killed his mother with a baseball bat. Others on the Parchman Farm list are also suspect, but I have made my point.

So Parchman Farm is a huge red flag, and finding Stern there talking to Killen as part of the current story is ridiculous. We are told they met in the medical unit in 2010, with Stern there due to cigarette smoke aggravating his glaucoma. OK. Stern decided to look after the old man, as you would if you were a black man. You would feel such sympathy for this old murderer, right? But note the contradiction. The main point of the larger story is that this black man Stern is roping the stupid Neo-Nazi Schoep into a grand fraud, by which he dupes him into turning his organization over to him. This would indicate a healthy hatred of these whites. But in the interior story he is protecting Killen. Zero continuity.

We are told that because Stern protected him in prison, Killen decided to open up to him. Right. This old Klansman decides to open up to a black man with a squirrely eye in prison. That makes perfect sense. Killen then allegedly signed over to Stern power of attorney, his life story, and 40 acres of land. We are told Killen's family filed a lawsuit denying that, but that it was dismissed. We aren't told on what ground it was dismissed, but it doesn't matter since the story makes no sense anyway. You can't sign over power of attorney like that. It has to be witnessed and notarized, so the idea that Stern could

just show up with a piece of paper and a signature is absurd. Same for the willing of land. The land would have to be willed, and wills don't work like that. You don't just hand over a piece of paper to a cellmate.

Stern then used Killen's documents as part of his presentation at the 2014 National Conversation on Race in Los Angeles. Except that someone at Langley still can't do math. We were told above that Stern was convicted in 2004 of fraud, sentenced to 25 years with 10 suspended. So he should have served until 2019. How was he in Los Angeles in 2014? We are told he was paroled in 2011, but that means he served only about six years of a 25 year sentence. So it wasn't ten that were suspended, it was 18. Anyway, more details. At this Conversation on Race, the Neo-Nazis who were being defrauded and mocked showed up and politely listened to the presentations, as good Klansman do, you know.

Next, we get to the big sale of the Charlottesville event, which I assume is why this story was written. Yes, it resells these old fakes like the 1964 Freedom Summer, but more importantly it sells this recent fake from 2017, which I obliterated when it came out. While trying to sell this event as real, author Mettler nonetheless continues to drop clues at a fantastic pace. We learn Schoep's ex-wife Joanna [Tazzia] has given an interview to the Southern Poverty Law Center, a CIA front, admitting she is ¼ Syrian/Arabic. She also has a daughter from a previous marriage who is half-black. Which means her previous husband or boyfriend was black. Since you can substitute Jewish for Syrian—Tazzia being a Jewish name—we have proof Schoep is who I said he was: a CIA actor of some sort. In answer, Schoep has stated he had never met the daughter. OK. Except that she lived with him for many months. The SPLC and *Washington Post* try to spin this as proof Schoep was mostly in it for the money (and because he hates Jews), but a better and cleaner reading is that it is proof this Neo-Nazi organization is a fraud from the ground up, created by CIA or DHS. We have seen that with other organizations going back many decades, including Commander [George Lincoln Rockwell's](#) founding of the American Nazi Party in 1959, **out of the Navy**.

Next we learn that a group called Integrity First for America allegedly sued Schoep and his group for . . . we aren't sure. There were allegedly fights on the street of Charlottesville, but you don't create a big civil suit over that. You arrest people at the time and charge them for battery or something. The only fake death in Charlottesville was the lady run over by the car, and there is no claim Schoep's group was connected to that. Integrity First has a nebulous page on this lawsuit, but its only claim is that some people were pushed or punched. Good luck collecting major damages for that. But since this lawsuit appears to be fake, anything could happen. In a fake trial, there are no limits. Integrity First has [a website](#), though its “about us” page tells us nothing. It does list officers, most of whom are Jewish. See for instance Meirav **Levy-Bernstein** and Susan Turnbull (Chair of Jewish Women International). Also **hedge fund** founder Monica **Graham**. Not feeling better about this group, are you? Remember, the Grahams are Dukes of Scotland, and we have seen them involved in dozens of major fake events. Also Dmitri Mehlhorn, head of angel investment network Vidinovo. Why are these investment people heading Integrity First? But it gets worse. Mehlhorn comes out of **McKinsey & Co.** and was President of **Bloomberg Legal**. He was senior advisor to Los Angeles mayor Gil Garcetti, who we saw briefly in my [OJ Simpson paper](#). This of course links us back to our current event, since Stern comes from Los Angeles. Mehlhorn is also a Senior Fellow at Progressive Policy Institute. We also find Doug Thornell, a head of SKDKnickerbocker, a big Democratic Party consulting firm that also works with TransCanada Corp (Keystone pipeline), the **Rockefeller Foundation**, AT&T, and Facebook. It was started by **Mark Penn**, former executive at **Microsoft**. He comes out of **Horace Mann** Prep and Harvard, if you want to add him to your list. But what interests here is that he is a founder of PSB, which stands for Penn Schoen Berland. It was founded in 1977 as a political polling firm. In 2005

Penn became worldwide chief executive of [Burson-Marsteller](#), which we looked at in my paper on the [Unabomber](#). It is the largest PR firm in the US, and has since merged with [Cohn and Wolfe](#).

But I bet you missed the biggest potential link in the paragraph above. I didn't, because while writing this I misspelled Schoep as Schoen several times. Do you see it now? Penn's partner is Schoen, and the Neo-Nazi is Schoep. I suspect there is a link there, though I can't prove it. But it reminds us that both names are Jewish. See for example [Hans-Joachim Schoeps](#), Jewish historian of religion who was a follower of Hitler—a Jewish Nazi. Even after his mother was allegedly gassed in Auschwitz, he continued to support monarchies, and he supported Konrad Adenauer's Germany Foundation. Also see Dr. Julius Schoeps, a Jewish historian and member of the German Interior Ministry. Also Julius Schoeps, director of the Moses Mendelssohn Institute for European Jewish Studies, who sued MoMA over the Picasso painting *Boy Leading a Horse*.

You may also be interested in [this page from ancestry.com](#), which has a bombshell to drop about the name Schoep. According to that page, the Schoeps lived in Wisconsin from 1880 to 1920. There were only three families. So Jeff Schoep would be the only Schoep in the entire US right now. How does that happen? Was he hatched from an egg dropped from the Moon?

If we check Intelius, we find only one Jeff Schoep nationwide, but it does not appear to be our guy. This Jeff Schoep is 48 and lives in Iowa, working for a heating company. The Neo-Nazi guy lived in Minnesota and Detroit. In fact, [I found a picture of this Jeff Schoep](#), and it isn't our guy. So the Neo-Nazi is a ghost. Intelius has never heard of him. This Jeff Schoep is looking to me like a total creation of the SPLC, which is in turn a creation of Intelligence. This may indicate Jeff Schoep's name was changed from Jeff Schoen, which would mean he may be a relative of Douglas Schoen of Penn Schoen Berland. Just an educated guess.

Anyway, we were looking at the poorly named Integrity First for America organization, which appears to be another Intel front. They are certainly not “defending longstanding principles of democracy”. With officers coming out of McKinsey and Burson-Marsteller, we can be sure they are defending the hegemony of the very rich. Plus, we find in the “latest news” banner there that the lawsuit is allegedly going ahead against the Neo-Nazis, so I guess Schoep fired his attorneys a little prematurely. My guess is this is yet another fake lawsuit that will lead to yet another fake court case. But we will tear that up when we come to it. For now, I will say that the Integrity First website looks to have been set up just to blow smoke about Charlottesville. It was created simply as backstory and background for this Neo-Nazi story we are having to read today.

For the next stupid subtext, we find Stern now has bladder cancer. We are shown a scar on his . . . chest, about six inches above his right nipple. We are told they gave him chemotherapy for his bladder cancer through this portal. Hmmm. In my body, the bladder isn't in my upper chest. How about you?

Next, we are told Schoep wanted proof Stern could deliver the lawsuit being dropped, so Stern produced emails from an attorney supposed to be involved. But when Schoep investigated the domain name, he discovered it led back to Stern, not to the lawyers in Charlottesville. So we are supposed to believe Schoep never once talked to any lawyers from the opposition, or got any confirmation from anyone but Stern? And when he asked Stern about it directly, all Stern did was get mad and break into Ebonics:

“Don't let somebody show you every little method that I do things,” Stern snapped back. “Because a lot of little methods I do things is not straight across the board. Okay?”

Schoep—a great lover of gibberish—supposedly accepted that as an answer. He transferred the organization to Stern, who then popped the trap. Schoep lost control and the members fled an organization now led by a black man. And the lawsuits proceeded.

If you are prone to believe any of that, you need to pray for help from the Neptune moon of edible bikini wax. This script makes Quentin Tarantino's script for *Once Upon a Time in Hollywood* look like a documentary. It is so full of holes it looks like prairie dog town on the planet of swiss cheese. Not surprisingly, Stern soon sold rights to his story to Mark Wahlberg. I guess he will package it as some sort of *Django Stern Unchained, First Blood Part 2* or something. It will also be a fitting sequel to the recent *Jojo Rabbit*, which no doubt came from the same writing team. Maybe Wahlberg can fit Anne Frank's ghost into Stern's closet somehow, along with Eva Braun's pet llama, Goebbel's gerbils, and the entire cast of *Time Bandits*.

Postscript: although the members of the Neo-Nazi group almost immediately got the “corporation” back—by simply starting a new one, duh—Schoep renounced white supremacy and joined **Parallel Networks**, a group that allegedly fights extremism. That's tidy. You may want to look at its board of directors, which includes Dr. Jessica Stern of the [Hoover Institution](#). We have seen the Hoover Institution many times before. It is one of the biggest bastions of undisguised fascism in the country, housed in the tower on the Stanford Campus. Also Dr. Marc Sageman, Senior Fellow at the [Foreign Policy Research Institute's](#) [FPRI] Center for the Study of Terrorism. Ditto for that. FPRI's key people are listed as [Dov Zakheim](#), Robert Freedman, Samuel Savitz, John Hillen, and Alan Luxenburg.



That's Zakheim. One guess what they all have in common. Anyway, all directors of Parallel Networks are ranking anti-terrorism specialists, which of course means they desperately need for terrorism to exist. If it didn't, they would be out of a job, wouldn't they? As for Stern, he conveniently died a couple of weeks ago, on . . . October 11. 10/11/19. So we can't confirm any of this with him.

And again, we find everything upside down. It looks to me like the anti-terrorism specialists are actually manufacturing fake terrorism, so they can get hired to fight it. It is the same old conjob we have seen over and over. The only terrorism that exists is this Hollywood-style fictional terrorism, either manufactured by crisis actors or manufactured by writers in cubicles somewhere. Unfortunately, the writers and actors are so poor none of it is the least bit believable. An episode of *The Simpsons* is more credible, seamless, and convincing.

But our research above pointed to the greater reason for these hoaxes. Money. When we see investment firms and hedge fund people involved, we know the big banks are involved. Anti-terrorism is big money, akin to Defense and Intelligence, and we are seeing it draws the same people. These policy groups and think tanks and consulting firms and semi-private institutes are just fronts for the giant international banks and colossal investment groups, which are in turn fronts the very richest families hiding behind them. These fake terrorist events are just one way they drink from worldwide treasuries. I don't know how to stop them, but you don't have to make it so easy for them. You can start by telling them to take their fake stories and shove them up the nearest portal to their bladders.
