That is Enrique Tarrío, supposedly given 22 years despite not being in DC that day. He just “managed” it. Big problem: even Wikipedia admits Tarrío had been a government informant back to 2012, **working for the feds**. Later he began working for Milo Yiannopoulos, a major gay Jewish spook who used to work for *Breitbart*. Real name Milo Hanrahan.

Milo has self-published many books, and despite being dropped by major publishers like Simon&Schuster, these books somehow went to #1. Again proving he is an agent. Two of the titles are *How to be Poor* and *How to be Straight*. I hope you get the joke. How to be poor and straight from a rich privileged gay guy. His next book must be *How to Tell the Truth*.

It is also worth reminding you that Milo is the one who said statutory rape laws shouldn't apply to gays, and that 13-year-old boys were fair game. I guess we should give him credit for honesty there, because that is the way many gays really feel. He was also nice enough to admit that a “disproportionate number” of pedophiles were gay, something you never hear in the mainstream. So back to the main event here. What is today's story at *Gateway Pundit* about? The usual cat and mouse they play with these fake prisoners. We saw it first in [my expose of Johnny Hovey](#), where they allegedly moved him all over the country, so you couldn't figure out he was never in jail at all. Maybe some real person wanted to visit these prisoners, so they had to pretend to move them out of state.

Eventually they will have to come up with some permanent solution to that, and the usual way is with faked suicides or deaths, as we saw with Jeffrey Epstein and many others. Either that or Trump will pretend to pardon them all.

And why do I keep coming back to this? Because it is a very easy way for me to remind you of the sort of world you are living in. And also because it allows me to ask you this again: are these the troops you are supporting? Is this what you thought your trillion dollars a year in “defense” was going to? Is that what you understood Special Ops to refer to? Your own troops running thousands of fake operations against you every year, funded with your own taxes. Is that what you support?
