Why the Trayvon Martin Case is not what it seems

<u>I began warning several years ago</u> that intelligence agencies were planning race wars to divert attention away from other problems. It is known that they have done this in the past. In times of high tension, the government can divert attention away from its proper focus by fomenting and increasing tension between blacks and whites. They have been doing this since the 1960's, both here and in Europe.

More recently, they have used similar tactics in the Middle East, creating and encouraging factional wars between the Shiites and Sunnis, for instance, to divert attention and manpower away from Muslims who should have been united in resisting Western Imperialism. That is what all the bombing of mosques was about. Real Muslims don't bomb mosques. Those were false flag bombings, done by our own CIA and Mossad. The bombings were then pinned on one of the local factions, creating civil wars. The Sunnis and Shiites were then too busy fighting eachother to fight us.

In precisely the same way, the intelligence agencies are now trying to divert anger and aggression here in the US against the banks, Wall Street, the government, and the other elite policy makers by channeling it into new race wars. If blacks and whites are fighting eachother, they forget to fight the elites.

It is for this reason that I intuit that the whole Trayvon Martin affair is manufactured. The mainstream media has been proved to be nothing more than a tissue of lies, and I can't imagine why anyone believes anything they are told. They can make up stories from nothing, and they often do. Maybe Trayvon Martin was killed, maybe he wasn't. Maybe George Zimmerman shot him, and maybe he didn't. But everyone who reads this story—and any other—should be very skeptical. For me, I have been fed so many lies over the years that I won't believe anything until I *personally* see a body. I don't take the media's word for anything. If they tell me it is night, I assume it is day.

[How could I think that, you will ask. Well, remember how we found out after the fact that John Hinckley, Jr., the guy who shot Reagan in 1981, was actually the son of John Hinckley, Sr., who just happened to be a close personal friend of the Bushes. Scott Hinckley, John's older brother, was to have dinner with Neil Bush the night after the shooting, and the Bushes were frequent guests of the Hinckleys, the two families having been in the oil business together in Texas. That information is not a conspiracy theory: you can find it at Wikipedia. Just another mad coincidence, right? No, these "coincidences" happen far too often to be passed off as statistical anomalies. The odds against the son of a close personal friend of the Vice President just accidentally shooting the President are astronomically high. As are the odds of George Zimmerman's dad just happening to work at the Pentagon for 22 years. That's right, USNews and MSNBC just reported today that Robert Zimmerman worked for the Department of Defense, *in the Pentagon*. The media is reporting that without comment, but it leapt off the page at me. Ask yourself what the odds are that George Zimmerman's dad would be a Pentagon lifer, and then do the math. It would be a strange enough coincidence in DC. In Sanford,

Florida, the odds are effectively zero. There is no Pentagon in Sanford.

Also telling is the video from George Zimmerman's arrest. Nancy Grace at CNN has used the video to imply that Zimmerman is lying about being beaten and injured by Martin. Why? *Because there is no blood on his clothes*. Grace even says that out loud, and it is in the title of the link, as you see. Strange that she has asked the right question, but nevertheless come to the wrong conclusion. Remember that Zimmerman is supposed to have shot Martin while in a struggle with him at close quarters. So here's a question Nancy Grace doesn't ask: how do you shoot someone to death with a Kel-Tec PF-9 9mm handgun while wrestling with him, and emerge with none of *his* blood on you? We are told that the clothes of both Martin and Zimmerman from him *before* he got to the station, could they? He is just arriving at the station in the video, and is still handcuffed. Are we to believe that the police just carry around bags of clothes in their cars, to give to those they arrest as a convenience? I don't think so. Police don't carry wardrobes in their cruisers. And towns the size of Sanford don't have mobile forensic units. This isn't CSI-Miami. And besides, MFU's concentrate on the victim and scene, not on the murder suspect. The murder suspect is already mobile himself, and can easily be transported to the real forensic unit at the station.

Here's another way it looks staged: Why are the officers giving Zimmerman so much room? They are treating him like a prince, not a murder suspect. They aren't pushing him or pulling him, no hands-on treatment in the entire video. I have been taken in for parking tickets and treated with less respect. These officers are giving him a three-foot bubble almost the whole time. He also doesn't look scared at all. He looks like he is going to the gym with some friends, and he just happens to have handcuffs on as a gag. The interactions are all wrong. I don't take this to mean that Zimmerman is a dangerous psychopath that even the cops are afraid of, I take it to mean that this event is staged, like almost everything else you see now.]

Even if Trayvon Martin was actually killed, as we are told, the whole media circus stinks of manipulation. Even if the initial event happened as we are told (which is doubtful), it looks very much like someone is *using* the event to create a race war. That someone would be the CIA, working for the elites that control your government. Given what we know of history, that is the most likely reading of this affair, and I will assume it is what is happening until I have evidence to the contrary.

As it is, we have lots of circumstantial evidence pointing to precisely that. Even without much research, I have already tripped over many things that don't make sense. For one thing, why is this case being tried in the media? Why is the media so aggressively causing and abetting racial tensions here? This is not the first time a young black man has been killed by a non-black. And besides, we have courts to decide these things. Since there are serious questions as to the legalities involved here, Zimmerman should have been arrested and tried. They arrest people now for failing to mow their lawns or paint their houses, or for yawning in front of a TSA agent, so why is he being given a pass? Very mysterious. Also mysterious is the governor of Florida appointing a special prosecutor, who comes in and *prevents* a grand jury. So this is not local racism at work, this is the governor of the state and a special prosecutor interfering to be sure Zimmerman is neither arrested nor tried.

You will say that this is what the New Black Panthers are so mad about, but I don't think they are seeing the whole charade for what it is. You see, it is not locals protecting Zimmerman because he is a good-old-boy racist. It is top elites purposely playing this event to create as much tension as possible. You may assume it goes much higher than the governor of Florida. The event is seen as a powerful tool for creating race wars and for further restricting firearms, and it is being played to the hilt in both

ways.

Also curious is <u>NBC's editing of Zimmerman's 911 call</u>, to make it look like Zimmerman was racially profiling Martin when he wasn't. Unfortunately, NBC got caught and the producer was fired, but the same sort of thing is happening in many other places, with no one getting caught or fired. From this alone we can see that the mainstream media has been instructed from above to try to make political hay from this incident, by inciting more violence and more racial tension.

The reactions and statements of black leaders are also suspicious. Everyone from Al Sharpton and Jesse Jackson to Obama himself has unnecessarily added fuel to this fire. Even Spike Lee seems to have allowed himself to be programmed by the CIA. We know they got to Obama and Jackson years ago. Obama was always a tool, and Jackson has been one since the sex scandal in 2001. Has Lee also been visited by the spooks, or has he been programmed from afar? The only sense here was spoken by Bill Cosby, who said that neighborhood watchers shouldn't be armed. True. I am all for the second amendment, but dopes like Zimmerman shouldn't be patroling neighborhoods with pistols. That is an accident waiting to happen.

The neo-Nazis and the New Black Panthers are also being played, at the least. I think it is possible that both the Nazis and NBP involved may be CIA plants, but even if these people are for real, they have obviously been infiltrated. They are playing a part set for them, either consciously or unconsciously.

To see how fake all this is, you only have to look at the report <u>that armed Nazis were patrolling</u> the streets in Sanford, Florida. This was picked up by papers all over the country and spun by the spooks at the Southern Poverty Law Center. Only one problem: it wasn't true. <u>According to the police in Sanford</u>, no one is patrolling Sanford, armed or not, except them. That is, no skinheads have been seen patrolling the streets. And these people are not hard to spot. The neo-Nazis we see in the news making public statements do not dress to blend in. If they were there, they wouldn't be hard for the police to find.

And the Nazis are not the only manufactured group here. After watching the New Black Panther video at youtube, I am left thinking that this is all another professional psy-op. For one thing, the rant by Michelle Williams sounds scripted to me. It fits too perfectly into the mold of what you expect from such a thing, as if the CIA hired someone to produce a movie. Williams should be patted down for an actors equity card. The graphics lead us in this direction as well, since they were put together very fast and yet look very professional. Even the roughness of the thing looks manufactured to me. I just don't buy it. The CIA also has to be running interference for this sort of thing, otherwise it would never pass the censors. Youtube is censoring people for burping or scratching, but we are to believe this video passes the youtube terms of service? Cmon! If the NBP were saying all these things without the protection of the government, they would have been arrested as terrorists. You can get arrested as a terrorist just for looking sideways at a cop, but these NBP spokespeople are shouting in public about vigilantism, violence against the government, pre-meditated murder, contempt of the courts, sedition, and racial hatred. I don't believe for a second that our new police state is just allowing this because it is now pro-blackpower or something. They are allowing it, and probably creating it, to foment race wars.

So be suspicious. Be very suspicious. And don't be led around by the nose like the poor Sunnis and Shiites. Stay focused on the real enemy. Whether you are black or white, your real enemy isn't someone of another color.
