


The Wetterling Kidnapping was Faked

Since I first discovered the writings/ research of Miles Mathis and his exposition of faked events, this one has crossed my mind many times, having grown up in Minnesota, and having heard about it when it happened in 1989. That picture under title was as ubiquitous as anything from my youth. Jacob was 11 years old when he disappeared and I was the same

age. News of this was everywhere: missing child posters were pasted up all over the place in every town, there was a song called “Jacob’s Hope” being played all over the radio that fall, along with other countless reminders that this scary mystery had happened, and no one would ever be the same henceforth. Well, after learning what we’ve learned about all the psy-ops and faked events courtesy of our friends in Intelligence, this one starts looking like more of the same, a seminal event in the “missing children” branch of the Operation CHAOS project. Let’s take a look.

Jacob was born in Long Prairie, MN, in 1978, to parents Jerry and Patty Wetterling. The family then moved to St. Joseph, a small suburb of St. Cloud. Patty was a “homemaker” and president of the local PTA, while Jerry was a chiropractor and the former head of the local Chamber of Commerce, as well as president of the **St. Cloud NAACP**. You might be able to tell from the photo under title that this family was *not black*. Why was he president of the NAACP? And exactly how many black folks lived in the St. Cloud area in the early/mid ‘80s? Not many I’ll bet. Sounds pretty spooky to me. The Wetterling’s were also prominent members of their local **Baha’i church**.

Jacob was kidnapped on Oct. 22, 1989. He was **11** years old. Supposedly, on the night of the abduction, **Jacob**, his younger brother, and another friend rode their bikes to the local Tom Thumb convenience store at about 9pm. On the way back home they were accosted by a masked man with a gun who “told them to lie face down and asked them their age”. OK, what? He then let Jacob’s brother go and said “run away and don’t look back or I’ll shoot you!” He then followed suit with the other boy, but kept Jacob. This doesn’t really make any sense. If he was going to kidnap someone, you think he’d get someone that was alone. Also, why ask their age? What would that matter? Two of the boys were 11, one was 10. I don’t understand the rationale for this type of behavior. **[The scriptwriters wanted to get the 1s in there, as part of aces and eights. Look for the 8s coming up]**. One interesting point is that the two boys could not provide a description of the attacker’s face. One week after the abduction, 225 National Guard troops were called in to “search for clues”, along with **80** MN DNR workers. **[That didn't take long, did it?]** That seems a bit odd. Is that standard operating procedure for a missing person? The FBI was eventually called in. Does that usually happen in these missing persons cases? I don’t think so. Actually, the FBI was called in *by midnight on the night of the kidnapping!* Now I know for a fact that the FBI does *not* normally get called in to investigate a missing child case *within three hours* of the report of the child having gone missing! The garbage they expect us to believe! Before dawn they were calling local radio and TV stations. By **11**am “reporters were arriving at the scene *en masse* and the abduction was blossoming into a full-scale media event.” I’ll bet it was. A police sketch was released of “a man who tried to abduct a boy earlier in the summer” in the same area, officials be-

lieving the incidents could be linked. Right. No further information on this “incident” is forthcoming. A month later “a more accurate sketch of the earlier sketch is released.” What? More “accurate” how? How did they know it was more accurate? Sounds like a bunch of bullshit to me.

Within *three weeks* there was a feature in *People* magazine about the tragedy, penned by William Plummer and Margaret Nelson. Both appear to have been pushing fake stories for the magazine in the '90s, the kind of tripe that's obvious to us now to be of the most blatant propaganda. This event was obviously being heavily pushed, not only in the state, local and national news media, but also by the Minnesota **Vikings** football team, **3M**, and the Lion's Club. In the article, we are told that, at the behest of then Governor Rudy Perpich, the National Guard, state and local investigators had executed the single largest ground search in the history of the state at the time. That's a lot of money the taxpayers are shelling out for this.



The supposed killer, a man named Danny Heinrich, was arrested in 2016, after confessing to the murder. The name Heinrich is Jewish. See [here](#). Also [here](#). He currently is supposedly being held in FMC-Devens, which is a federal medical facility. **He is listed there as Danny Heinrich, not Daniel, which is unlikely.** The listed inmates and former inmates includes a laundry list of fake inmates including [Dzokhar Tsarnaev](#), Anthony Weiner, Roger Stockham (fake Dearborn, MI, mosque bomber), Harold T. Martin III (fake NSA leaker) and several members of “organized crime” families as well as several people supposedly busted for insider trading and investment fraud including Steve Hoffenburt, Peter Madoff (brother of Bernie), Rajat Gupta and Raj Rajaratnam. **Allowing us to out all those events as fake as well, with no further research.**

Oh, one important piece of information courtesy of Wikipedia, **Heinrich was never charged for the kidnapping and/or murder.** He supposedly made a

plea deal by pleading guilty to possession of child pornography while also leading police to the site of the victim's remains. That makes absolutely no legal sense. Other murderers have made similar plea deals we are told, including Don Gene Miller, Gary Ridgway, Larry Bright and Jesse Matthew. We know about [Ridgway](#), but I will assume the others are faked as well until proven otherwise.

Since the case was now considered closed because they found the murderer and "police found and positively identified the remains", the Stearns County Sheriff's Dept. was going to release the entire 56,000 page case file to the public, but alas, the Wetterlings filed a privacy lawsuit to avoid exposing themselves as frauds... I mean "exposing themselves to further publicity over this tragedy." Of course they did. That last bit, by the way, is from *Crime Museum's* Crime Library, where we can also inform ourselves about such topics as: Early Warning Signs: Serial Killers, Jeffrey Dahmer, Ted Bundy, the O.J. Trial and other fake Intelligence projects.

Patty Wetterling's maiden name is very difficult to find on the internet. Someone doesn't want us to know that her last name was **King**. Any relation to Martin Luther King, or the founders of King Ranch, or the dozens of hoaxing Kings Miles has uncovered? We can't know for sure since there is no genealogy posted online for her. After the kidnapping **she ran for Congress**, receiving campaign contributions from none other than Barack Obama. So that's convenient. Wiki tells us that was one of only three political contributions he made that year.

I did recently stumble across an interesting possible connection. While researching a huge local corporate conglomerate, Watkins, I discovered that an Ernest Leroy King took over ownership of the company after the death of founder J.R. Watkins. E.L. King was a **banker** from Winona, MN. Of course I can't prove any connection, but it would stand to reason there is most likely some tie between the two. Incidentally, Watkins was later sold to a very rich Jew named Irwin Jacobs, who brought the company back to profitability after years of mismanagement. You can still buy Watkins cleaning products at Target, another Minnesota conglomerate. Last year Jacobs killed himself and his wife in his mansion. Could this be yet another fake? Possibly, since the mansion on Lake Minnetonka was just demolished a few months ago to make way for several new housing developments on this extremely valuable piece of land. By the way, that mansion was featured in the 1972 groaner, *The Heartbreak Kid*, starring Charles Grodin as a philandering Jewish newlywed who leaves his wife on their honeymoon for "blond *shiksa*", Cybill Shepherd.

On the tenth anniversary of the abduction in 1999, Patty wrote an open letter to the kidnapper, which was published in newspapers in Minneapolis. Get this, she supposedly consulted the FBI for "advice on how to word the

letter". What? I guess that means the FBI wrote the letter, which I'm sure they did.

In 2015, Patty Wetterling was the chairman of the Board of Directors of the International Centre for Missing and Exploited Children. On the board are some names you might recognize: a **Cohen**, a **Levine**, a Yannapoulos, a Baron de Lichtbuer, Jeff Koons as well as several corporate CEOs and current and former international politicians. Wikipedia also has a picture of the Board for this organization and you can clearly see Richard Branson in the front row. What, pray tell, might that portend?

Near the town of St. Joseph is a small town called Cold Spring. This little town is the home of Rocori High School, where in 2003 there was another fake school shooting. A music teacher at that same school was named a "person of interest" in the Wetterling case in 2004. His name is Dan Rassier. Even though the abduction occurred at or near the entry to the driveway of his home, he hadn't been thoroughly interviewed on the night of the kidnapping. Apparently, after this announcement, Rassier was unable to perform any more private music lessons because he had been named a person of interest in the now decade-and-a-half-old case, and people were freaked out that he might be a pedophile kidnapper, effectively ruining his career. All because of a giant fake. Nice.

Supposedly someone else was kidnapped and sexually molested in that same small town just nine months prior to the Wetterling abduction. A man named Jared Scheierl (also Jewish) claimed he was abducted and sexually molested 9 months before the Wetterling kidnapping. They later linked Heinrich to this, so we know what to make of that. In another nearby small town, Paynesville, there were supposedly *even more* sexual assaults, of seven boys, right around the same time. Not only were seven boys attacked and molested, at least one was attacked more than once. Yet despite the fact that several of these attacks were happening in this very small community, within a short amount of time, with several different victims, all claiming similar circumstances, no one believed any of them, or just didn't take them seriously. Right. They try to claim that "it was different time then", or "denial and indifference prevailed back then." I'm sorry, but I don't care what the "social climate" was in 1988, if my kid came home genuinely terrified, and said someone attacked him and threatened him with a knife, grabbed him off his bike and unzipped his pants, I guarantee, there would be no "community indifference", especially if I had anything to say about it. This whole notion of "it was a simpler time" sounds like the same garbage they are feeding us about the lack of presidential security during the fake [Lincoln](#) and [Kennedy](#) assassinations. No way I'm believing a lick of this bullshit.

In more recent years, this project has received a lot more promotion, salting in the old propaganda, lest we forget our fears and return to normal life. One “investigative reporter” named Madeleine Baran has been working this story more recently. And yes, once again, Baran is Ashkenazi Jewish. For example, see Paul Baran, engineer for **RAND Corporation**. Are they related? Well, we can’t know because according to the big computers at Intelius *and* Instantcheckmate, she doesn’t even exist! Perhaps a connection to this Baran or the Wealthy [Baran’s](#) of Los Angeles who owned the Southwestern Bag Co. is being scrubbed by giving her a fake first name. We’ll probably never know. [She might actually be a Baron or Barent, as in Sacha Baron-Cohen, aka Borat. That would be my first guess.]

She is a recipient of a Gracie Award, named after Gracie Allen, of Burns & Allen fame (they try to pretend Allen is Irish Catholic, but like her husband, and everyone else she is associated with in her career, she is obviously Jewish). Say goodnight, Gracie! Previous to this story Baran was working on [another one](#) that we have found to have some dubious claims. It is a story about three archbishops hushing up cases of sexual abuse by Catholic priests. For me personally, I am not sure that there is and has been no such thing as sexual abuse by Catholic priests. But Miles has [uncovered](#) that someone is trying to garner overdue fear of these priests by overhyping and manufacturing fake instances of abuse by Catholic priests and cover-up of those “abuses” by church administrators. Anyway, Baran had produced a documentary series examining the Wetterling case. The series had been hailed by the *New York Times* as “one of the year’s best”, and we are told by the *Columbia Journalism Review’s* Elon Green, that it is, “for my money, one of 2016’s great achievements of investigative journalism.” With **Jewish** endorsements like these, we can be pretty sure we are in the middle of a Langley production. In an interview with the *CJR* Baran admits that, regarding the investigation of Jacob’s disappearance, there were “TV crews showing people working 20 hours, working nonstop.” Hmm. Why would there be TV crews showing people working on a police investigation. Have you ever heard of TV crews documenting *any other police investigation? Ever?* Not me. Not unless it was on *Unsolved Mysteries* or *America’s Most Wanted*. Speaking of which, our good friend John Walsh will be making a brief appearance in this paper. See below.

In 2008, a barber named Vernon Seitz (Jewish) was found dead in his home of natural causes. However, in the basement was found a copy of a book about cannibalism, some children’s **shoes**, bondage equipment, child pornography and newly poured concrete. At his barber shop in Milwaukee was a picture of Jacob Wetterling, and Patty Wetterling claims he made the trip up to Minnesota twice to meet her soon after the abduction and claimed to be a psychic wanting to help. According to Dr. Victoria Fetter, who claims to have been his psychiatrist for **11** years, he confessed to her to killing a 14 year old boy when he was 12, and that he painted nude pictures

of boys because “you can’t touch little boys”, so he painted them instead. When asked about other confessions Seitz may have made, Fetter cited that she couldn’t divulge any other information on account of doctor-patient confidentiality. Right. The same confidentiality clause just didn’t apply to those other remarks. Obviously this is just a continuation of the project. Be afraid; be very afraid. Also remember writer Alex Seitz-Wald, who we saw in my Sandy Hook papers, getting his ass handed to him by yours truly.

Some of the other famous child kidnapping incidents I ran across were the disappearance of Etan Patz in New York, the disappearance of three Klein (Jewish) brothers in North Minneapolis. Also Megan Kanka, whose kidnapping/murder case spawned Megan’s Law. Since going through all these fake cases would totally swamp this paper, I will here just outline them very briefly to add evidence to our main line and show that this whole child kidnapping epidemic is one long CIA project, going back over half a century.

Quickly, Etan Patz (Jewish) was a young boy who was supposedly kidnapped on the way to the bus stop, two blocks from his home in SoHo, Manhattan. According to Wikipedia, his father, Stanley Patz, was a professional photographer and had many photographs of Etan, which were plastered all over Manhattan, including on Times’ Square projection screens, introducing the concept of “stranger danger” to the masses. Not surprisingly, a journalist named Lisa Cohen (you had to see that coming) was responsible for informing the public about this heinous crime via her first published book, *After Etan: The Missing Child Case that Held America Captive*. Right. She also covered “some of the biggest moments in recent history including the TWA 800 crash, the Oklahoma City bombing and the September 11 terror attacks”. I’m sure she did. Ms. Cohen now teaches at the **Columbia University** Graduate School of Journalism. Why am I not surprised? She was also a recipient of a Gracie Award. There are more ludicrous claims at Wiki regarding this case, but suffice it to say that we can see this particular case is more fraud. Now let’s hit the other two very quickly.



Megan Kanka of Trenton, NJ, was supposedly kidnapped, raped and murdered by a man named Jesse K. **Timmendequas**. Problem? There is no one on the planet with that name. It is admitted in this [article](#) by our friends at *The New York Times* that his father, Charles Hall, made up the last name “after seeing it on a tombstone”. You should really read this article for a couple of good yuks. It is the typical Langley tripe. The Emmy Award winning pic above is bought to us courtesy of Murderpedia. Where did he have that taken? A Hollywood studio? A “brother-in-law” of Jesse, Robert Parker (get it? Robbie Parker, the gleefully laughing bereaved father from Sandy Hook) of **Columbia**, SC, states, “Jesse can fry as far as we’re concerned.” Really? His “brother”, Paul Timmendequas is quoted here as saying, “Jersey has, what, lethal injection? Give me the needle.” You have to laugh. The whole article reads like this. Incidentally, I happened to stumble across some “court documents” online that are discussing Paul’s failure to register himself as a sex offender. So he’s a sex offender too now? Maybe he can give himself the needle this time. Jesse Timmendequas is incarcerated in the fake wing of the New Jersey State Prison, which also houses many fake inmates. Among them fake murderer and agent Sundiata Acoli, Rubin “Hurricane” Carter, subject of the [Bob Dylan](#) song and fake biopic starring Denzel Washington, Bruno Hauptmann, kidnapper of the [Lindbergh](#) baby, Fred Neulander, a rabbi who paid two guys \$**18**,000 to kill his wife, and a host of fake serial killers including Richard Fran Biegenwald, [Richard Cottingham](#), Charles Cullen and Leroy Snyder. Got it.

The three Klein brothers, ages 4, 6 and 8, went missing one winter day in Northeast Minneapolis in 1951. Police suspected the boys drowned in the nearby Mississippi River but no bodies were ever recovered. This led the family to speculate that they were kidnapped. We aren’t told what the parents did for a living, but if I had to guess I would say they were probably wealthy Jewish bankers or clothiers. That would line up well with our experience. Well, a certain (also Jewish) author named Jack El-Hai has taken

up a revival of the promotion of this project in a new (2019) book entitled *The Lost Brothers, A Family's Decades-Long Search*. Just so you know, El-Hai has contributed to *The Atlantic*, *Scientific American*, *GQ*, and *The Washington Post Magazine*, as well as given lectures at Yale, Harvard, Stanford, and the University of Maryland. He is currently writing books for the Mayo Clinic and the NIH. They make this way too easy.

In my research I came across some interesting information from the federal Office of Juvenile Justice and Delinquency Prevention. This 1200 page [PDF](#) appears to be a training manual from a seminar that was held at the Fox Valley Technical College in Appleton, WI. This was apparently a 5-day seminar in spook training for fake child abductions that took place evidently in the mid or late '90s, gathering together various government officers, police and spooks from across the country like our buddy Patty Wetterling. In the manual they speak of all the ways children become missing, in which they lump in "nonfamily abduction", which I assume happens or has happened rarely if not not at all, with other ways children go missing such as family abduction and runaways, which obviously happen in real life. The National Center for Missing and Exploited Children is involved here, indicating that this organization is also probably a spook project from its inception, as part of Operation CHAOS. According to this document, the history of child kidnapping in the United States has its humble beginnings with the abduction of 4-year-old Charles Ross, "son of a wealthy businessman", as well as the kidnapping and murder of [Charles Lindbergh, Jr.](#) Actually, we know that one is fake, and I am assuming the other is as well. This Lindbergh kidnapping was used to institute federal legislation on kidnapping, so, an intelligence project from the beginning, just as expected. Lindbergh is in good company with Etan Patz, [Adam Walsh](#) (son of John Walsh from *America's Most Wanted*), and the "murders of 29 Atlanta children" all making appearances in this seminar as "Missing Children Landmark Cases". The Adam Walsh fake was instrumental in getting Missing Children Act passed through Congress in October of 1982, another pilfering of federal funds that also acts as a giant, scary boogeyman to keep worried parents up nights. There is a graph included here that shows a 525% increase in missing person reporting with the National Crime Information Center from 1982 to 1995. If you think that's because there was a 525% increase in actual missing persons, I'm not sure how to help you.

There is one section in this large handout that contains what appears to be the paperwork of a missing child case from Portsmouth, NH. The investigation was headed by Bradley Russ.* I'm not sure if it is supposed to be comprised of real police and court records used as an example for this training session, or if it is a mock-up of a hypothetical case, but it is very detailed, with personal information of the victim and his parents and grandparents, including addresses and telephone and Social Security numbers, police reports from witnesses, arrest reports, evidence examination re-

quests, and even a highly detailed account of the arrest of the suspect, as well as an equally detailed account of this child's experiences of sexual assault by the alleged perpetrator. If it is a mock-up, it's sick. If it is supposed to be real, it's even more sick. I won't be reprinting this written account here but if you'd like to see it for yourself, this section is about a third of the way down the scrollbar on the PDF. 11 Year-olds don't talk like that. According to Intelius, neither of the child's parents exist. The child's middle name is given as Paul at the beginning, and then later his middle initial is given as "A". Whether it is supposed to be a real case or not, it's fake. And it's sickening. End of story.

This incredible piece of spook training material is loaded with all kinds of information, fake facts, statistics (real and fake, or maybe only fake?), and also fake stories of kidnappings, I suppose to convince rank and file policemen and other agents that these incidents are in fact real. Since they are using fake stories I am assuming they *have no real ones to use*. Unbelievably (or perhaps not so unbelievably), there is even a sales pitch for a whole computer system that communities and/or police departments can purchase to print very expensive color flyers to post around the community, spending copious amounts of public funds as well as scaring the bejeezus out of the local citizenry. The system is called TRAK and it included a state-of-the-art Hewlett-Packard Pentium PC, scanner, color printer, modem and CD ROM drive. That's big bucks back in 1997! And of course they give instructions on how to get funding from the suckers in spook organizations like the Rotary, Lions and Kiwanis, etc., as well as several other options for potential funders to buy their bullshit computer systems. This manual is also selling IT software for "Missing Persons" data, and also training how to use it. What's that old saying again? Oh right. *Never let a crisis go to waste!* That's right, manufacture crises, then capitalize on them: The standard playbook of the intelligence community from the beginning.
