THE UNIVERSITY OF TEXAS TOWER SHOOTING WAS FAKED

I went to the University of Texas from 1982 to 1984, staying on as a cartoonist at the *Daily Texan* until 1987. So this hits close to home for me, sort of like [the Buddy Holly hoax](#). Although the event had been 16 years earlier, in 1966, the top of the tower was still closed to visitors and students when I was there. I guess it still is.

As usual, I will start by going right down the Wikipedia page on this event, pointing out the red flags. I will then pull in other evidence. The first marker comes very fast, since this is the first sentence:

On August 1, 1966, after stabbing his mother and his wife to death the night before, Charles Joseph Whitman, a former Marine, took rifles and other weapons to the observation deck atop the Main Building tower at the University of Texas at Austin, and then opened fire indiscriminately on people on the surrounding campus and streets.

August 1, or 8/1, aces and eights, Chai, the usual Phoenician sign of a fake death. But that isn't the only red flag in the first sentence, since we also find that Whitman was a Marine. Supposedly ex-military, but we shouldn't necessarily believe that "ex" part. Like [Tim McVeigh](#), Whitman was likely active military, but undercover. We will see more on that later. In this event, 18 are said to have died and 33 were wounded.

Remember, the Richard Speck fake murders were just one month earlier, in July of 1966. I have already covered that one. All you need to know is that his stepfather was named Carl August Lindberg. Does that look familiar? It was also the name of pilot Lindbergh's father. So what we are seeing here is the CIA/FBI putting Operation Chaos into high gear in 1966. Their fake projects have continued to accelerate since then.

So we take the Whitman link, to find more immediate red flags. He was married to Kathy Leissner, Jewish. See for example Tim Leissner (below), banker and Chairman of Goldman Sachs Pacific division who is famous for marrying model Kimora Lee Simmons and costing Goldman about a billion dollars. In 2018 he was barred by the SEC and fined \$43 million. So that's who the Leissners now are. We will see more about them below.



That is what Leissners look like, just so you know. The second guy is Gerald Leissner, a Jewish South African bigwig who died recently.

Whitman's father was Charles Adolphus Whitman, also listed as Charles Adolph. Mainstream sites tell us Jews can't be named Adolph, but with research we have proved the opposite: all the Adolphs/Adolfs we have studied have turned out to be Jewish, including Hitler, so the name is actually a pointer *at* Judaism. To cover this, the story is that C. A. Whitman came out of an orphanage, so the genealogy is scrubbed that way. He was a Jr., so we know his father was also Charles Adolph. Which means our Charles Whitman may be Charles Adolph III, not Charles Joseph as we are told.

We find Whitman had been tested at age 6 to have an IQ of 139. Almost no one gets tested that early, indicating he was special, from connected parents. It also indicates he would have been tapped for Intelligence. Intel recruits high IQ, and we have seen that Tim McVeigh also had an IQ in that range.

We are told Whitman was Catholic, but that is the usual story. Jews most love to pretend to be Catholics. See the [current Supreme Court Justices](#), for example. None of them wanted to pretend to be

Protestants. We know everything about Whitman is a lie, since they tell us he joined the Boy Scouts at age 11 and was an Eagle Scout one year later, at age 12 years three months. That isn't how it works. As more indication Whitman was special—NOT the son of a nobody orphan—we find he was also an accomplished pianist by age 12. He also came out of West Palm Beach, indicating the same thing. So this kid was not your average Marine.

More proof of that is that he had an expensive new Harley in high school that he allegedly bought with money from a paper route. Right. He was obviously from wealth. Wikipedia conspicuously fails to tell us what his father did for a living, which is another red flag. His dad is complete ghost, though we may be able to find something on him.

Then there is the photo above under title, where they really went too far in this fake. That is our first jump-the-shark moment. You probably haven't seen that, but it is out there. They are trying to prove he was Catholic and a Boy Scout in the same fake, but they apparently forgot to remove his yarmulke.

Whitman allegedly joined the Marines right out of highschool, being assigned an 18-month tour at Guantanamo Bay, Cuba. Not the usual assignment for a new volunteer, who is normally trained in the States. After scoring high on all military tests, he was given a full college scholarship to prepare him for the officers' program. He entered UT as a freshman in 1961, studying engineering.

While at UT he dated actress Deanna Dunagan, which is yet another huge red flag. Dunagan was later in the Fox TV show *The Exorcist*. This also indicates Whitman was not your average UT student. He was special.

In 1962 he married Leissner in a fancy wedding in Needville, TX.



They had known each other only four months. We are supposed to believe Charles' brother Patrick lived with the newlyweds in their apartment in Austin.

Whitman supposedly had his scholarship revoked due to bad grades in 1963 and was sent to active duty in North Carolina. That is where the story goes off the rails and is probably false. He would have had to flunk completely out, and the story is that his grades were actually improving in his sophomore year. We aren't told what any of his grades were, and the story is extremely foggy at this juncture, leading to suspicion.

The story about his marriage is also foggy. He was supposed to be close to his adoring wife, but we [now know that at least as soon as July 1963](#), they were separated. If she went to North Carolina, it was only for a very short time. She returned to Austin and re-enrolled at UT. For at least 18 months she was on her own. Plus, at that link we find that Whitman wasn't actually in NC: he was at GITMO again. Guantanamo. Again indicating he was in Intelligence.

But Wikipedia skips over all that, telling us that in North Carolina he was allegedly busted back down to private for gambling, usury, and other malfeasance. He was then court martialed and honorably discharged, after which he returned to UT and enrolled privately in architectural engineering, rejoining his wife. He also worked as a bank teller and volunteered as a scout leader. None of that is believable. Why? Because his military records would be public after the court martial, and it would be known he was discharged for gambling and usury. In which case no bank would hire him to work with money. *Busted.*

As usual, they forgot to hire a continuity editor. They never saw someone like me coming.

Next, we are told Whitman's parents separated, with his mother moving to Austin. This caused Whitman to begin using amphetamines, which allegedly caused a brain tumor in just two months of "abuse". His mother arrived in Austin in May of 1966 and the event was three months later in August. That would be a fast-growing tumor.

So, if you like that story, you are welcome to it. It reads like the usual cover-up to me. What is it usually covering? A complete fake from the ground up. We may assume that this story—like all the others we have studied—was used to create fear and split the sexes. It was an early Men-are-Pigs script, joined closely to Operation Chaos. Chaos and Cointelpro were in full swing in 1966, as is now admitted. You will say they couldn't fake all those deaths, but they have done it many times since then, in even bigger and more fantastic fashion. See [Las Vegas](#), where the guy allegedly fired a machine gun out the window of a huge hotel. If they can fake that, they can fake a sniper dropping a few people from a tower.

You will tell me have [live film from that day](#). Yeah, so go watch it and tell me what you see. Nothing that couldn't be staged very easily. We get a good shot of the tower, but no one appears to be up there. A couple of squibs go off, but we see no stone chips fly off like would happen with bullets hitting the facade. Some damage was allegedly done, but again, that could be done either by people firing from the ground or from people going up there in the middle of the night creating the damage. It isn't proof anyone was up there firing. As with Las Vegas, they could have had someone up there firing blanks. We see some people carrying people. That isn't evidence of anything. In fact, if you watch [this longer one](#), you see that when the "dead bodies" are approached by those who want to help, most of them get up with no injuries and run off. See minute 2:16. What were they doing, playing dead? If so, why would they quit playing dead while shots were still being heard? At minute 3:10, Bran Ellison of Austin is interviewed as one of those who was rescuing these dead bodies. He is not described as a student but as a **Vietnam vet**. So yet more military presence that day. What was he doing on campus?

Buying Spam?

From that film, we also learn that Allen Crum, assistant manager of the University Co-op, was already in the Tower with a rifle as well when police arrived. What? Rather than arrest him as a potential accomplice or shoot him on sight, they deputized him. Really? We are told Crum was a retired Air Force tail gunner. Oh well, that's convenient then. More military involved. I guess we are supposed to believe assistant managers of University Co-ops just happened to walk around with rifles in 1966. In a variation of that story, DPS officer Dub Cowan provided Crum with a rifle before deputizing him. Weird, since we are told there were already dozens of police there, from Austin police to State Police to Sheriffs. You can just imagine. Austin has many overlapping jurisdictions and is crawling with cops of all varieties at all times. So why would they need to deputize an assistant manager? Well, notice the name of the DPS officer. You may have missed it. Cowan. Cowan=Cohn=Cohen. More signs of the fake.



And guess what? This William “Dub” Cowan wasn't just a DPS officer. He died in 2003 and the *Austin American Statesman* [ran his obituary](#). In it we find that, like officer Billy Paul Speed below, Cowan was actually Airborne. He joined DPS in 1950, but by 1966 he was an Agent in the [Intelligence Service](#). He had been an Agent Investigator since 1961. By 1966 he had been promoted to Assistant Agent in Charge. He was later Commander of the Criminal Intelligence Service (LEIU), and served the longest term as Commander up to that point in history.

They admit that many students on campus at the time thought the event was fake. Some told those on the ground to get up and quit pretending. That's odd, don't you think? From watching the films, you wouldn't have guessed that, since it seems clear that everyone was running around scared to death. But apparently that wasn't the case. Selective editing.

In other footage, we see three people loading a body directly onto a white hearse. Not an ambulance, a hearse. Aren't we a little early for the hearse? I guess they are going straight from campus to the cemetery.

Here's a clue most have missed. Wikipedia tells us Charles Whitman and his wife were friends of John and Fran [Morgan](#). Hmm. Is that Morgan as in J. P. Morgan? If you don't think so, read on.

Before we get there, you may wish to read his suicide note, part of which is reprinted at Wiki:

I do not quite understand what it is that compels me to type this letter. Perhaps it is to leave some vague reason for the actions I have recently performed. I do not really understand myself these days. I am supposed to be an average reasonable and intelligent young man. However, lately (I cannot recall when it started) I have been a victim of many unusual and irrational thoughts. These thoughts constantly recur, and it requires a tremendous mental effort to concentrate on useful and progressive tasks. [42]

In his note, he went on to request an [autopsy](#) be performed on his remains after he was dead to determine if there had been a discernible biological contributory cause for his actions and for his continuing and increasingly intense headaches.

There are signs of the fake all over that. First of all, Whitman knew he was not of average intelligence. He had been tested as a gifted child at age six, and he knew that. Besides, no one talks about themselves that way, crazy or not. Requesting an autopsy is also ridiculous. No one driven to murder his family and dozens of strangers would do that. If he had the presence of mind to psychoanalyze himself and request an autopsy, why not just turn himself into the police and ask them to lock him up until they figured out what was wrong with him? Also, he hadn't done anything very strange up to that point, or nothing that can be verified. This rampage allegedly came out of nowhere, which is why it was such a shock to everyone. So what does he mean by “actions I have recently performed”. Is he referring to “buying spam at a convenience store”?

Whitman allegedly began the rampage by killing his mother, but Wikipedia admits that “how he did so is disputed”. What? How can it be disputed? We are told that “officials believe he stabbed her in the heart”. What officials? Is there a death report or autopsy or isn't there? The way this is worded implies there isn't. Why such mystification 55 years later?

Whitman then allegedly stabbed his wife three times in the heart and left a note saying,

Maybe research can prevent further tragedies of this type [...] If you can find in yourselves to grant my last wish, cremate me after the autopsy.

Really? We are supposed to buy that? He has just stabbed his beloved wife to death and he is thinking about research on his body? And how convenient is it that he requested cremation, to prevent any later disinterment, and the discovery he is not in his own grave?

Whitman was also kind enough to call his wife's and mother's employers before heading to the Tower, telling them the ladies wouldn't be coming to work that day. As you do when you have just cut their hearts out.

Whitman allegedly had four long guns and three pistols on him that day. Two of the long guns he had purchased that morning, including the M1 Carbine and the shotgun, which he bought at two different stores. The shotgun he bought at Sears, and the Carbine he bought “at a hardware store”—where he told the cashier he was going to hunt wild hogs. Right. He also had a Remington 700 sniper rifle with scope and a Remington 14 repeating rifle. They admit he had so much equipment he had to dolly it into the tower on a handtruck, which he also bought that morning. So they are really testing your gullibility.

If you are not at the end of your gullibility yet, keep reading. He needed that dolly since he also brought with him his footlocker, loaded with the pistols, food (Spam), coffee, vitamins, drugs, earplugs, several jugs of water, lighter fluid, rope, binoculars, deodorant, and even toilet paper. No, seriously. I got that straight from the mainstream story. **He brought deodorant.** He had everything but silly putty and a goldfish in a bowl.

Once in the tower, the elevator had to be activated for him. Guess what the lady's name was who did that? Vera **Palmer**. Ah, beautiful, a peerage name! Any more of those? What do you think? One of those allegedly killed was Robert **Hamilton Boyer**. He was **33** and was a mathematician who would later become semi-famous for the Boyer-Lindquist coordinates. Strangely, he published that paper in 1967, *after* being killed in 1966. Guess who [the Boyers of the peerage are related to?](#) [The Morgans](#). The Whitmans were best friends with the Morgans, as we just saw. So this was another cousin production.

Curiously, we find a second Robert Boyer working in the math department at UT in the same years. He is given as Robert Stephen Boyer, and he too had an equation named after him. See the Boyer-Moore string-search algorithm, which came out in 1977.



That's Robert Stephen at about 50 and Robert Hamilton at about 30. Same guy? I don't think so, but they may be related. Robert Stephen seems to be at least five years too young and the ears don't match. But of course the second photo may be tampered with and the earliest dates of Robert Stephen may be fudged. If Robert Hamilton faked his death, he has to be somewhere, and this would be the simplest solution. We are told he headed to his position at the University of Liverpool, but that's all as maybe.

Also see [Barbara Chase](#), daughter of Harold **Stuart Chase** and Gertrude Boyer. She is just one of our many peerage links here. She married the 8th Marquess of Lansdowne in 1938. Her daughter Lady Georgina married Guy **Hamilton**. The Marquess was a Mercer Nairne Petty-Fitzmaurice, and his wife after Chase was Gillian **Morgan**. Lady Georgina's brother Lord Robert lived in Bellevue, Washington. The Boyers are also related to the Bournes of Boston. Also to the Howards, Earls of Effingham, and the Drummonds, Campbells, Murrays, Russells, and Gordons. Through Marie Boyer, they are also related to George Stanhope Molyneux Herbert, 5th Earl of Carnarvon, who famously died of a mosquito bite. He is the one who found King Tut's tomb.

So, we already saw the name Morgan a second time, confirming that the friends of the Whitmans in Austin were not just any Morgans. More confirmation of that is that the Leissner family is also related to the Morgans. They have been marrying Morgans for centuries and still are. Of course that also indicates Whitman and Leissner were cousins, though I can't say how close. As such, she may have just been a beard. This is yet another pointer at the Families, since normal people don't marry their cousins. But the Families almost always do. At that last link, we can see who the Leissners are marrying now, and it confirms my analysis: Dryden, Shaw, and Franklin. We are about to see those Shaws again. The Drydens are crypto-Jewish peers as well, think of the poet Dryden.

Here is another productive link on the Leissners. That lady, Judith Leissner, was born the same year as Charles Whitman, 1941. She just died in 2020. Note her mother's name: McLeod. Let's see, who else is a McLeod? That would be Donald Trump, whose mother is a McLeod. We also find the surnames Spencer, Ford, Meyer, Ryan, David, Broggi and Green there: a goldmine.

Also see the Dutch Leissners, who married the Kanns. Kann=Kahn=Kohen.

Finally, let's look up Kathleen Leissner at Geni and Instantcheckmate. Her mother is scrubbed, but her paternal grandfather is given as Hamilton Alfred Leissner, indicating the Leissners are also related to the Hamiltons. Her aunt is a Ziesemer. Although Leissner allegedly died in 1966, the computer at Instantcheckmate knows who we are looking for immediately, even before going through all its files. It asks us, "Is this person deceased?" Never got that question before. There is only one person with that name with any link to Austin, and her name is Katherine or Kay, not Kathleen. She was apparently born in Sugar Land, TX, and died in Massachusetts at age 49, not at age 23. That means she died in 1992. The computer finds no link to her with the Whitmans. But the Sugar Land listing confirms this is her, since that is where the Leissners in our story were from: Sugar Land and nearby Rosenberg. What about a search on Kathleen Whitman of Austin? Again, nothing. The computer has never heard of her. According to Findagrave, she has a stone at Rosenberg, TX. We get a picture of it. But this is also curious, since the headstone is very plain and cheap. The Leissners were rich, so why would she have this tiny cheap headstone? We are told that when Charles Whitman first met Kathy's parents, he commented on how "huge" their house was. Huge house, tiny headstone. But we do learn something else useful there: Kathleen's mother was a Holloway, which is also a Jewish name. Best guess is these people come from the King Ranch settlers we have looked at previously, which would link them to Bezos, Lance Armstrong, Matthew McConaughey, and many others.

Let's do the same for Charles Adolph(us) Whitman. He supposedly was born in Georgia and died in Lake Worth, FL. Intelius lists a Charles A., age 82, wife Betty, but someone named Kathleen M. Wagner is linked to him. Who is that? None of his wives or children were named Kathleen or Wagner. Could that be Kathleen Leissner's new married name? This Whitman is not linked to any of his sons, including Charles Joseph. Also not linked to C. J.'s mother Margaret. No record of A. standing for Adolph. Instantcheckmate has the same info, but also lists him as Charles R. Both places say he lived in Miami, which doesn't come up in his bios.

I also remind you where Lake Worth is. It is Palm Beach, about three miles from Donald Trump's famous Mar-a-Lago. Very rich people.

What about Margaret Hodges Whitman, C. J.'s mother? A search on Instantcheckmate takes us to a Dale A. Whitman of DC. Why does the computer think there is a link there? Otherwise we find no record of her in Texas or Florida, either as Hodges or Whitman.

The computers have no record of Charles Joseph Whitman of Austin. I am not sure how far back they go. I know they list people who died in the 1970s. And as we just saw, they appear to have a listing for Kathleen Leissner. Let's test that. Charles' brother John Michael allegedly died in 1973 in Lake Worth. Instantcheckmate takes us to a William J. Whitman, age 60, of Lake Worth when we search on him. Why? John Michael would be 71, so who is this William? Can't be his son. Could be a son of Charles Joseph, since he would be 80 this year. William does have NC on his list, so he could have been born while Charles was in the Marines there.

Injured with Boyer was **Devereux Maitland Huffman**. We get a three-for-one there, don't we? Remember, Maitland equals. . . **Stewart**. Think Jimmy Stewart, full name James Maitland Stewart. Devereux is a huge peerage name, since they are the Baronets of Castle Bromwich as well as the Viscounts of Hereford and Earls of Essex, closely related to the **Hamiltons**, Hughes, Shaws, **Morgans** (Barons Tredegar), Rices, MacDonalds, Wyndhams, **Kings**, and Copland-**Griffiths**. Back in the times of the Tudors, they were closely related to the Knollys and Walsinghams, including Elizabeth I's spymaster. Huffman=Hoffman, meaning it is Jewish. [This guy Huffman just died this year](#) at age 86 and his obituary conspicuously fails to mention he was injured in the Tower shooting. It is definitely the same guy, since it says he received his PhD from UT in the early 60s and taught management in the school of business for 20 years. Since getting shot by Whitman was the biggest thing that ever happened to him, you would think he would remember it.

You can tell none of this genealogy work is a coincidence, since we keep finding the Morgans and Hamiltons, and finding them *together*. The odds against that are astronomical. Yes, a big peerage name might pop up by accident in any research, but not *the same* peerage names over and over, linked in tight circles.

C. A. Stewart was another one injured. Is that Charles Adolph Stewart? Another allegedly killed was **Thomas Aquinas Ashton**. No really. Now we just need a Venerable Bede Bennett. But these Ashtons may be real, since the Ashtons of the peerage are related closely to the families we have already seen. See Dorothy Ashton, who married the Duke of Wellington in 1914. Her grandson Arthur married the Princess of Prussia. The Ashtons are Barons of Hyde, **running Barclays Bank**. So it is a big red flag to find one of them allegedly killed here.

Then we have the **Gabour** family listed as victims, though Zsa Zsa is not listed with them. One of the Gabours injured just happened to be an **Air Force** cadet, age 19, with no connection to UT. We aren't sure why these people were in the Tower stairwell above the 27th floor, unless they also had a dolly loaded with firearms and deodorant.

Another killed was Karen **Griffith**. Did we just see the Copland-Griffiths above? Yep.

Then we come to “passerby” Rita **Starpattern**, who allegedly helped Claire Wilson as her unborn baby died within her. Starpattern? Really? Instantcheckmate has a listing for her, but no information. No relatives, no locations other than Austin. So, a CIA insert from fake Hippietown, Langley, VA.

Another victim was Paul Bolton Sonntag, who just happened to be the grandson of KTBC news director **Bird Paul Bolton**. That's tidy, isn't it? That station was owned by President Lyndon Johnson, remember, and was the first TV station in Austin. Paul Bolton had just retired from KTBC in 1965. Which conflicts with the mainstream story that Bolton was anchor at KTBC in 1966 and learned of his grandson's death when his reporter read out the names on air. So that is false. Fake. Sonntag is a Jewish name, see Susan Sontag, nee Rosenblatt. Also see Jacob Sonntag, founder of the *Jewish*

Quarterly. Also “child Holocaust survivor” Philipp Sonntag. In support of that, we find Sonntag was killed with his girlfriend Claudia Rutt, who they admit was Jewish. The local Jewish community in Austin of course used her death to declare the event a Texas Holocaust. But one death isn't a holocaust, so they must be admitting many of these other victims were also Jewish, right? Which confirms what I have been telling you.

Also strange that we find three Eagle Scouts in this event: Whitman, Gunby, and officer Speed. The odds of that are very low. Billy Paul Speed was also Army, being **Airborne**. So military again. We are told he was ex-military, like Whitman, but according to the mainstream story he had been with Austin police only 13 months and was planning on quitting. That's unlikely.

Victim Harry Walchuk also looks military and Jewish, since he had received his bachelor's from UT in 1954 and was back in 1966 working on a PhD. What was he doing during those 12 years? Probably military, since we are told he was buried in Fort Snelling National Cemetery. Findagrave confirms that with a picture of his headstone, where we see he was born in 1928 and served in the Navy as a Fireman's Apprentice. He was married to Marilyn **Mason**. You might also ask why he was working on a PhD at age 38, after already having six kids. Possibly to enter the CIA, with this event as his entree. His wife's Findagrave page is strange, since it implies she remarried to someone named Warrington, but her page lists only Walchuk as her spouse, and her gravestone lists her as wife of Walchuk. So best guess is Walchuk just changed his name to Warrington and they moved to Minneapolis.

Another allegedly injured was Roland **Ehlke**, Peace Corps volunteer. The Peace Corps is of course a CIA front. This is [Roland Cap Ehlke](#) of Wisconsin, still alive. He seems like a shady character to me. We know he spent time at Hebrew University. Ehlke is a Jewish name, from the Yiddish for “honored”. See Gretchen Ehlke at the *Times of Israel*, who may be a relative. At that link we are told his Christian “writings have been endorsed by noted scholars such as Drs. Paul Maier, John Brug, Mark Braun, and Timothy Maschke”. Hmm. I wonder if they have been endorsed by any people who *don't* have Jewish names?

Speaking of the Peace Corps, we find [here](#) that the Corps just happened to have sent 76 volunteers to study at UT at that time. We aren't told why. Normally Corps volunteers are sent abroad for two years. Their three months of training is most often not in a university setting.

Claire **Wilson** and Thomas **Eckman** are two more spooky victims, since with more research we find they came out of SDS, **Students for a Democratic Society**. And when I say came out, I mean they had *just left* an SDS meeting when they were allegedly shot. SDS was yet another CIA front. It was a spin-off of the much older ISS, founded by Walter Lippmann, [Jack London](#), [Clarence Darrow](#), and Upton Sinclair. I have thoroughly outed all but the last as agents. Tom Hayden—Jane Fonda's old ex—wrote the first SDS manifesto. Paul **Booth** was the first vice president of SDS, a huge red flag. Yes, that is Booth as in John Wilkes Booth and the baronets of the peerage. Paul Booth's parents were both Socialist Party members, his father being an economist in Roosevelt's Department of Labor. So we may assume that Eckman is Jewish and that Claire Wilson is as well, perhaps from the famous Wilsons as in Woodrow Wilson. There was a second victim Sandra Wilson, allegedly no relation. But that is unlikely.

Don't believe me about SDS being a CIA front? Well, would you believe Tom Hayden? [The man himself wrote a 2014 article for](#) the *Nation* admitting many of his pals in the National Student Association and other Socialist organizations were CIA plants. He basically outs everyone but himself, including Donald Hoffman, Peter Eckstein (his predecessor as editor of the *Daily*), Harry Lunn, Gloria

Steinem, and Allard Lowenstein. All Jewish, of course. Actually, Hayden does out himself, if you read closely enough. He says,

Personally, I never made it into a CIA front group, though I tried hard enough. I was “unwitting,” in spook-speak. “Witting” was what the agency called people in the know. They first tested and recruited them into high positions in the student world, then administered a surprise security oath before telling them they were part of the CIA. Under the guise of the NSA, the CIA recruited me to write a pamphlet on the student civil-rights movement (“Revolution in Mississippi,” 1961) for global distribution.

And you thought I was making it up! Hayden figured why continue to deny it, I guess, after SDS had already been outed by everyone from Lyndon Larouche to Tucker Carlson. But I remind you that seeing it here is yet another huge red flag. You should be asking why all these victims in Austin were Peace Corps, SDS, military, or media. Victim Thomas Ray Karr was also military, having served in Taiwan from 1963-5. Like most of the rest, he wasn't even a UT student, being enrolled at Arlington State College.

So who are these Whitmans, really? How do they fit in here? Well, let's start at the peerage, where we find them related to. . . the Hamiltons. We saw that how many times above? Four? Those Whitmans in the peerage appear to be mostly in Australia, so let's keep looking. We do find a Frederick Crocker Whitman of the peerage, and he married the daughter of the Baron Vansittart. His wife was a Heppenheimer from New Jersey, daughter of banker and mogul General William Heppenheimer, Jewish of course. He was the head of several banks, insurance companies, steel and manufacturing companies, and the New Jersey Public Service Corporation. The Heppenheimers were vom Saals in Germany, meaning they were also nobility. But most interesting are older Whitmans in the US, who were ancestors of Abraham Lincoln. See Sarah Whitman, mother of Mordecai Lincoln, Jr., the 2g-grandfather of Abe. Which tells us why the poet Walt Whitman was selling the story of Lincoln at such volume. They were cousins. This line links us to Charles Seymour Whitman, governor of New York, whose picture now appears on some of Charles Joseph Whitman's bios by accident.



He is a later cousin of Walt Whitman and Abe Lincoln. He married a Hitchcock. His grandson is John Russell Whitman, husband of former New Jersey Governor Christine Todd Whitman. Her maiden name is Christine Temple Todd, meaning she is another cousin here, not only of her husband but of everyone we are looking at. She descends from Mary Todd Lincoln, of course. John Russell's father was Charles S. Whitman, Jr., born 1915, about the same time as Charles Adolph Whitman, b. 1919. So what happens if we search on Charles Seymour Whitman, Jr., at Instantcheckmate? You are going to love this. These Whitmans are from New York, as you know. But this Whitman who died at age 86 in 2001, also has on his list. . . are you ready? . . . Palm Beach, FL. Let's see, who else lived in Palm Beach, FL? Oh, that's right, mass murderer Charles J. Whitman.

That pretty much finishes off this story. We can see that these Whitmans in the UT story aren't nobody Whitmans from Georgia or Florida, they are THE Whitmans, related to Abe Lincoln and everyone else famous. Charles Whitman didn't come from an orphan who didn't know who his family were, he came

from these famous Whitmans of New York and Maine, and my guess is that Charles Seymour Whitman, Jr., above, is his father, not the ghost they call Charles Adolphus Whitman. Which explains why Charles Whitman in Austin was hanging around with Morgans and Hamiltons and Leissners, living previously in West Palm Beach, and being coddled by Marine Intelligence.

For more of that, we find that through his mother Margaret Hodges, Whitman was a **Graham**. In this line Geni takes us back to a Gershom Graham of Stockbridge. His wife was a **Dunham**. Obama's mother was a Dunham, remember. The Grahams are also from the highest reaches of the peerage, being the Dukes of Montrose.

Another important connection of the Whitmans is famous mathematician [John von Neumann's](#) daughter Marina von Neumann Whitman, who married Robert **Freeman** Whitman in 1956. She is Jewish, of course, and has been Vice President at **General Motors** as well as director of the IAS at Princeton, director of the **Council on Foreign Relations**, and steering member of **Bilderberg**. Her daughter is married to David Downie, son of Leonard Downie, editor of the *Washington Post*. The Freeman Whitmans are from Maine, descending from Gustavus Freeman Whitman, and are the Whitmans we have been looking at, related to Abe Lincoln, etc.

Charles Whitman allegedly had a younger brother named Patrick who died in 1989, but here is something strange. [Findagrave admits](#) that they had one of their own representatives walk the Whitman gravesites. They could not find this grave. **It does not exist**. Cue *Twilight Zone* music.

Can you figure out what that means? Meet me down below if you can't.

Whitman had an even younger brother John Michael, who was allegedly killed in a bar fight at age 24. I would assume he also went into intelligence, with this story as his cover.

Here's something else weird. Whitman was allegedly embalmed on the same day he died, August 1. That makes no sense, since not only had he requested an autopsy, but this was a famous criminal investigation. You don't embalm a body within hours of death under those circumstances, since forensics would require a body that had not been tampered with by anyone, *especially* embalmers. Why? Well, we are told an autopsy was performed on August 2, at which time blood and urine were tested for amphetamines. What? You can't test an embalmed body that way, since the process of embalming would *remove* all urine and blood, replacing it with embalming fluid. You can't test embalming fluid for amphetamines! We are also told that Coleman de Chenar, the neuropathologist who did the autopsy, did it at the funeral home. What? That is also a sign of the fake, since a prominent and important autopsy like this wouldn't be performed at the funeral home, which wouldn't have the proper facilities for a full autopsy, including an autopsy of the brain.

For more hijinx, see [this Atlantic article from 2014](#) about “the missing brains”. It admits Dr. de Chenar of the Austin State Hospital did his autopsies in his lab there, not in funeral homes. He collected over 200 brains, including that of Whitman. After his death in 1985, his collection was bequeathed to UT medical school, which had beaten out Harvard in the bidding war. Since then, over 100 of those brains have gone missing. Disappeared. Including, of course, the brain of Whitman. That's convenient, right? I guess they didn't want anyone checking up on the claim it contained a pecan sized tumor. So no proof of that exists.

[According to Findagrave](#), Charles Whitman “had an American flag draped over his casket at his Catholic funeral with his mother”. So, he was not cremated. And he got military honors! How does a

discharged soldier and mass murderer get military honors? Does that make any sense? I will be told that anyone discharged honorably qualifies for honors, but that brings us back to that. Since Whitman was allegedly thrown out of the Marines under court martial for gambling, usury, possession of a personal firearm, and threatening a fellow Marine, how is that honorable? A dishonorable discharge is defined as discharge for criminal or morally unacceptable actions, which perfectly describes the story we are told of Whitman's discharge. Gambling and the rest are illegal. So none of this story makes any sense. He should have been dishonorably discharged, which means his coffin should not have had the flag. Yet another sign of the fake.

Whitman's father remarried just three months after the fake death of his estranged wife. This woman, Ellen Ward, was divorced and pregnant when he married her. They were married for five months. His third wife already had three children, and one of them married Whitman's brother John. And yes, that is a guy marrying his stepsister. Is any of that true, or is it more part of the fiction about Charles Adolphus Whitman, to make it look like these people were hillbillies? You decide.

So I will now tell you the answer to the burial mystery. Since Charles Whitman faked his death, he was not in his coffin. Are you with me so far? It was an empty coffin. But in 1989, his family and the CIA saw a way to fill solve that problem. They put his brother Patrick in his coffin, so if anyone ever ordered a disinterment, they would find a body with the correct DNA.
