

Surprise! The DELPHI MURDERS Were Faked

The first piece of evidence is the fact that every other high-profile murder case we've studied has been shown to be fake. Hundreds of these headline-news cases have fallen to pieces with the slightest scrutiny. It is now incumbent upon any such cases to prove themselves true. Otherwise, we may—and should—assume them false from the first.

But let's take a stroll through the mainstream story and see how quickly it falls apart.

1. The murders occurred on February 13, 2017, and their bodies were found the next day—**Valentine's Day**. Abigail's obit says she died on February 14. This is a huge red flag right away, as we have seen many fake sexual events coincide with this holiday. Valentine is a favorite fake saint of the Phoenicians, and it gives them the opportunity every year to associate romantic love with all manner of ghoulishness. This was a man attempting to rape and murder two teenage girls. In other words, Split the Sexes 101. Also, Men Are Pigs 101, especially white men.
2. Abigail Williams was found fully clothed in Liberty German's clothing, while German was found nude. Hunh? I read that as some sort of signal of the fake, since there's no explanation for it otherwise. **Liberty Rose Lynn German? Oivay caramba. No listing for her in people searches, since she is underage, so they are free to make up whatever name**

they like. And with the clothing switch, I did another fake where this happened as well, though I can't remember which one. It must be some sort of CIA marker. Reminds me of Chevy Chase in *Fletch*: “♪ Strangers in the night, exchanging clothing ♪.”

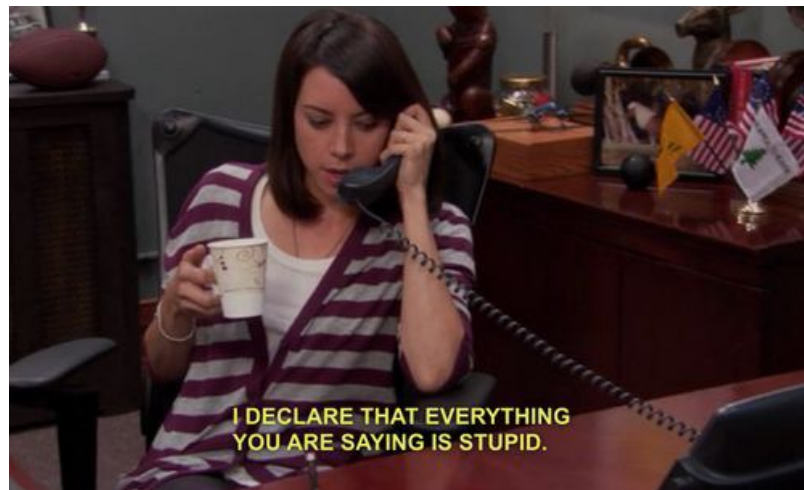
3. A sketch of the murder suspect based on the phone pic wasn't released until July 17, five months later. Why wait so long? To draw it out as long as possible. To stew the women in fear while they were still holding their Valentine's cards.
4. On the same day of the murders, a vehicle was left abandoned nearby at the former Child Protection Services office. Really? Isn't that clue a bit too on-the-nose?
5. The case had no new leads until September 2022, 5.5 years later, when “investigators reviewed a misfiled tip after a volunteer file clerk discovered the error. Richard Allen's last name was recorded incorrectly on the tip when submitted, and the file was therefore wrongly marked as ‘cleared’; the file clerk deduced that the tip from years earlier was regarding Richard Allen, and brought it to the case's investigator. In the tip, Richard Allen self-reported three days after the murders to being on the trails on the day of the murders and seeing Williams and German.” Make sense of that if you can. Do you really think a minor clerical error was preventing them from cracking the case? And the murderer tells you he was at the scene of the crime and saw the two victims right before they were murdered, and because his name is typed in the computer as “Allin” instead of “Allen”, the police investigators are completely bamboozled.



6. At Wiki it says “Investigators also found a “.40-caliber unspent round” less than two feet from one victim's body, but between the two victims. It was later determined that the round came from a gun owned by Allen.^[32] A witness said she saw a man walking away from the bridge “wearing a blue colored jacket and blue jeans and was muddy and bloody.” Another witness and a tip mentioned that a car was parked “oddly” and appeared to be parked in a way as if to hide its license plate. Investigators said the description of the vehicle matched a vehicle that Allen owned in 2017.^[33] Note the footnotes numbers, because you are being given a big whalloping clue. But wait, there were no witnesses or

unspent rounds, remember, which is why the case was dormant for 5.5 years. A witness seeing a bloody man should have called the police, but she didn't. There is no record of it. And a .40 caliber round is quite rare, so the police should have been able to finger Allen from a local gun or ammo sale. And that thing about the license plate is just stupid. If they could match the description of the vehicle to Allen, he would have been questioned 5.5 years earlier. When the judge unsealed a probable cause affidavit, it turned out police HAD question Allen for two hours in 2017, and he had admitted he was there. 7. That's right, the murderer's name is Dick Allen. Is that like "Dick All In?" Good one, guys.
8. Shortly after the murders, Allen told his wife that he was on the Monon High Bridge trail the day the girls went missing there. Really? Why? His wife told him he should call the police because the news said they wanted to talk to people with any information. No shit. What does Allen do? He reports his information to...the Department of Natural Resources. Yup. Don't bother calling those incompetent police, they'll just misfile your tip, anyway. I'm surprised he didn't go directly to the Parks & Rec Department. Or maybe lost and found at the public library.



Allen told authorities he had gone to the bridge to "watch fish". Too bad the bridge is an old train bridge 63 feet above the water. Don't think you can see much from up there. Why not just say he was going for a walk? Because that wouldn't be idiotic enough for the scriptwriters. It doesn't stir your brain enough.

9. Wikipedia's bio of Allen tells us he grew up in Mexico, IN, went to North Miami High School in Denver, IN, and worked at CVS pharmacies in Peru and Delphi. Let's see: Mexico, Miami, Denver, Peru, and Delphi. I smell another bad Langley joke here. Or perhaps this is an Air Force joke, since Grissom Air Force Base is a 35-minute drive from the site of the murders. Speaking of which, Allen had previously enlisted in both the

Army and the National Guard. He worked at a CVS 10 minutes from Grissom AFB. In other words, he's a cloaked Air Force intelligence recruit.

10. Same for Liberty German's father Derrick, who has Flora, IN, on his list, the nearest town to Grissom AFB.

11. I looked Allen up at Pendleton Correctional Institute, and they did fake a listing this time. But strangely they don't seem to know his middle name, which would be useful since they have six other Richard Allens. No one seems to know what day he was born either, since his DOB everywhere is 9/1972. Unfortunately, the big computers don't know he is in Pendleton, since that prison is in Fall Creek Township and he doesn't have Fall Creek on any of his lists. Radaris, Instantcheckmate, and Intelius all agree he is 52 and still living in Delphi. Instantcheckmate says he has also lived recently in Greenwood, Peru, and Nappanee, but none are near Pendleton. In fact, Peru is just outside Joint Base Grissom.

12. Allen's arrest was announced by the police on **October 31**—the Phoenician Navy's other favorite holiday after Valentine's. His trial began the following year on **October 18** and his conviction was on **11/11**. Gotta get those Aces and Eights in there somehow.

13. Prosecutors said that Allen had admitted to the murders more than 60 times while incarcerated, confessing to “his wife, his mother, family members, the prison warden, the psychologist who treated him in prison, other prison employees and other inmates.” I've never been in prison, but I'm pretty sure you don't go around bragging about trying to rape underage girls. That kind of thing will get you buttsore real quick. **Or murdered. Allen must have been paid by the confession.**

14. “The defense hired a neuropsychologist from Carmel who testified at trial that Allen had ‘pretty severe depression’ and work-related stress and anxiety.” And that drove him to murder two underage girls? Millions of American men are depressed and have “work-related stress” – are they all on the verge of raping and murdering underage girls? That's what they'd like you to think. Depression and anxiety tanks your libido, by the way, so as usual the story makes no sense.

15. Not only did Allen self-report his presence at the crime scene and admit to the murders literally dozens of times after his arrest, but he had the suspect sketch printed out and pinned to a wall in his house, which just happened to make it into a photo of himself posted on social media. Whoops.



16. Carroll County Circuit Court Judge Benjamin A. Diener [submitted an order of recusal](#) to the Indiana Supreme Court, requesting a [special judge outside of Carroll County oversee the case](#). That “special” judge was Frances Gull, who earlier that year just happened to participate in a [“cameras-in-court pilot project”](#). In other words, she allowed video cameras to film her court cases, which is normally prohibited. That just tells us she was presiding over a DUMMY COURT, since real courts don’t allow that. They simply made up this hogwash about a pilot project to explain it away. Diener recused himself because he was told to—or because he realized it was a fake case and wasn’t interested.
17. [Gull refused to change venue, gagged everyone, and then dismissed both defense attorneys for no real reason, though she had no authority to do so. The Indiana Supreme Court had to reinstate them, but in the meantime many more months went by.](#)
18. This means that [Allen](#)’s case was tried in [Allen](#) County, instead. Coincidence? Hardly. By the way, the prominent Allens of Indiana trace back to Nathaniel Allen, one of William Penn's commissioners, who landed at Chester Creek all the way back in 1681. These Allens were [Quakers](#) and freemasons for many generations, both big red flags.
19. Allen was moved out of the Carroll County Jail and placed in the custody of the Indiana Department of Corrections for most of the time before his trial, allegedly for “safekeeping”. That’s a convenient cover in case employees or inmates at the Carroll County Jail start wondering why they never saw Allen there. As a result of his “safekeeping”, his defense team later claimed, [Allen was denied his right to counsel](#): “Allen’s wife had hired an attorney from Lafayette and that both the Carroll County sheriff and prosecutor knew that and had spoken with the attorney. However, the defense motion says Allen’s attorney was not notified of his client’s initial hearing or the efforts

to transfer his custody.” All of this is illegal and highly suspect. The simplest explanation for it all is that the case was FAKE.

20. Abby and Libby are both fake-buried in IOOF cemeteries. In case you don't know, that stands for **Independent Order of Odd Fellows**, a major spook organization. Its seal features two females and the words “Bury the Dead”:



Strangely though, Libby and Abby are buried in *different* IOOF cemeteries located in *different* towns, despite living in the same town and being best friends. Make sense of that. [The cemetery where Libby is allegedly buried](#) contains several deceased people with the last name Allen, indicating the local Allen family was also IOOF. Which means the murderer and the victims were all from IOOF families. Nothing to see there, folks.

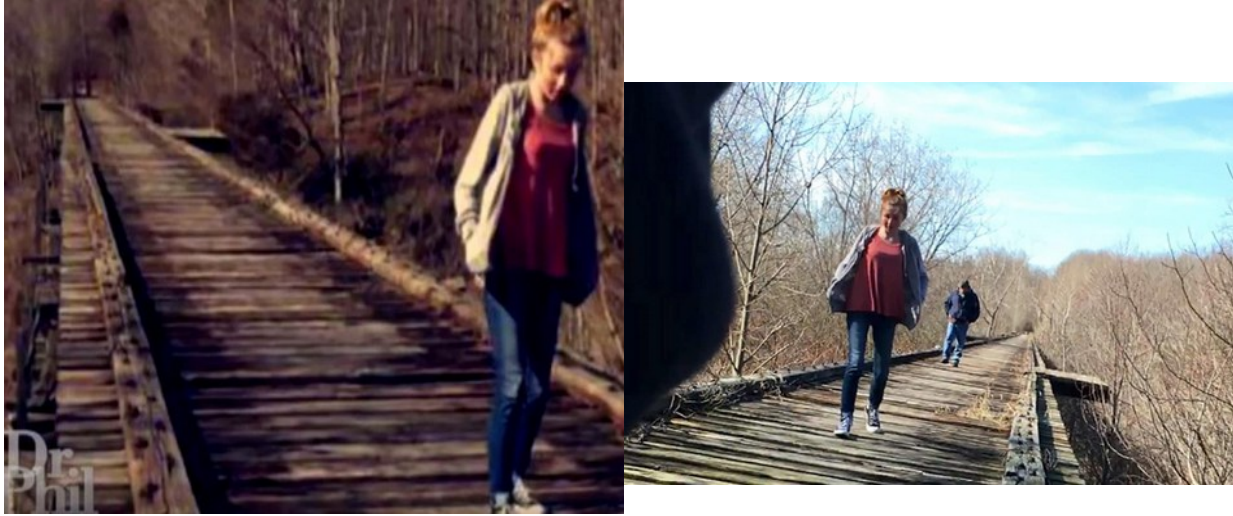
21. Abigail Williams shares her name with the teenager who incited the Salem Witch Trials. **Played by Winona Ryder in the movie.** Just another signal that we are in hoax land.
22. Peruse the findagrave.com link and you'll see these IOOF Allens in Delphi are related to McCains. Two years after the murders, Delphi Historic Trails [received a \\$1.2 million grant](#) from the state to restore the Monon High Bridge trail where the murders took place. The president of Delphi Historic Trails is...Dan **McCain**. No joke. These grants were provided by the Indiana Department of Natural Resources, whom we saw earlier. Remember Allen inexplicably called the DNR instead of the police to report info on the murders. It sounds like the DNR is getting involved in these fakeries for their own benefit now. I also draw your attention to this strange paragraph in the above-linked article: “The Monon High Bridge had been on the Indiana Landmarks 10 Most Endangered list in 2017, when the Indianapolis-based preservation group negotiated with CSX to start plans to shore it up. Those negotiations, Indiana Landmarks officials said at the time, had been

in the works for several years and that **the transfer was not timed to the homicides earlier that year.**” I’m not even sure what that last bit means, but it’s odd they’re even implying a link between the murders and the restoration of the bridge. My gut tells me there are lots of hands in this cookie jar, one of them being the city of Delphi. This would be a great way to attract publicity and get additional funds to improve its scenic attractions.

23. The last nail I’ll bother hammering in this coffin is the photo under title. It’s a still shot from the video footage Libby took on her phone showing Allen walking toward them on the bridge. Study it closely: do you notice how both Abby’s and Allen’s feet don’t seem properly grounded on the bridge, as if they’re sort of floating? It’s a telltale sign they were CGI’d into the video. **FAKE, FAKE, FAKE. But even if it is real, it is again way way way too on-the-nose. We are supposed to believe these two girls just accidentally got a photo of their murderer right before the murders, and he didn't bother to take the phones or throw them in the river?**



Then we have that problem. **I found that photo** in a story about Abby's parents appearing on Dr. Phil. What happened? Where's Allen now? And why does the bridge now look like a painting? Let's put the two side by side:



Hmmm, the first one is about 20 seconds later, since Abby has moved past that tab sticking out on the side of the bridge to your right. So I guess he walked right past them? But that begs the question: why was Libby walking backwards for all that time, photographing . . . basically nothing. Her friend walking. But then when this spooky guy walked past them, she ignored him and kept her back to him?

[Next day: In a reread, I noticed something else that blows this wide open. In those two pics of Abby, *she is exactly the same*. Just rotated. Same foot forward in the same position, arms same position, head same position, and all the shadows on her are the same. You realize they have computer programs that can rotate images just like this, right? Which explains why the first image looks so strange: it has residue from the computer on it: compression changes or something. They used the same photo for both, but it was the second one, from the front. They wanted more, so they just rotated it. It is also curious the way the first one is cropped, so we can't see the sky and can't see how her shoes meet the boards. Those were probably problem areas they needed to get rid of.]

Here's something odd from that page. Liberty German's grandparents are given as Mike and Becky Patty. You might think they would be maternal grandparents, since they are not Germans. But no. They are the parents of Derrick German. So how does that work? Why is he not Derrick Patty? Not sure, but on those pages we link to more Germans not on the first lists, including a Torey Lynn German of Bel Air, MD, who is both 33 and 64, with two listings. She then links us to a Robert German, 97, of Austin and Bethesda, with a son also Robert, 65. Grandfather Michael Knarl Patty, 59, of Delphi, husband of Becky, strangely has no Germans on his list, including his alleged son Derrick German.

Middle name Knarl? You will say the Pattys must be the parents of mother Carrie (Timmons) German, but no:

We are told her maiden name is Timmons and she isn't related to any Pattys. Plus, Mike Patty isn't old enough to be the father of Carrie, unless he had her at age 12. Not old enough to be the father of Derrick German, either, since Derrick is listed as 48. So who are these people who appeared on Dr. Phil? Well, Becky Patty is related to Sachas and Lotz, which gets us started: they are Jewish.

You will tell me Mike Patty died a few years ago, so he would be older now. I found no indication of that, since he has no obituary or Findagrave page. Radaris confirms Mike Patty is 59 and living in Delphi. Becky Patty is also not old enough to be the mother of Derrick, since she is now 65. Unless she was 17, which is very unlikely.



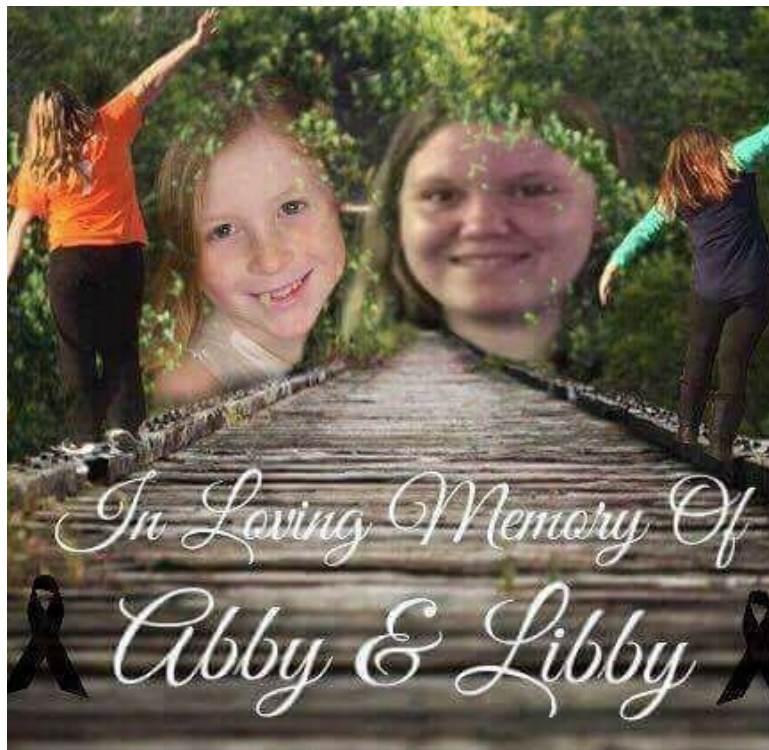
That's Mike and Becky Patty in 2022. For [a story](#) posted **October 31, 2022**, to be precise.
