

Fake Las Cruces Police Shooting

On August 2, 2022, 36-year-old **Presley C. Eze** was allegedly shot in the head by a white **Las Cruces** police officer in New Mexico. Las Cruces is home to NASA's White Sands Test Facility and **White Sands Missile Range**. The latter was built in 1941, formally known as the Alamogordo Bombing and Gunnery Range—it is the location of the Trinity test site, [act one of the nuclear theater](#).

The name Eze is a continuation of the joke as it means "king" in Igbo. It is also a Jewish name, a short for Ezekiel. So, not even his surname is Nigerian. Odds are our black friend here is an [Igbo Jew](#). The Jews have been documented in parts of Nigeria since pre colonial times.



The name of the white cop is [Brad Justin Lunsford](#). He has a massive Oni tattooed on his forearm, the typical spooky artwork. Oni are essentially demons in Japanese folklore that are known for their inclination for murder. Fitting, since Lunsford is depicted executing Eze in cold blood. As for his surname, there once was a man named [Sir Thomas Lunsford](#), the 12th great-grandson of King Henry III. Sir Thomas and his brothers are thought to be the inspiration behind Alexandre Dumas' novel *The Three Musketeers*. Another search on the surname provides various Geneanet suggestions. 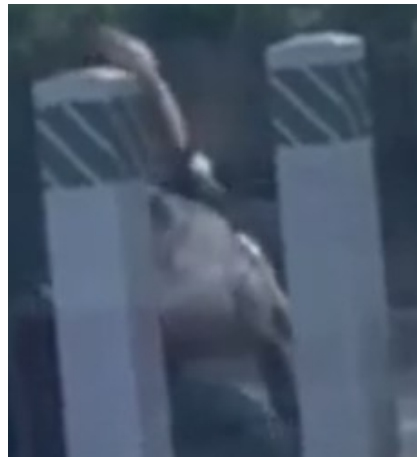

The above image is the frame of the shot. It is hard to make out due to the quality of the video, which is the standard subpar; however, if you go frame by frame, you can see where Lunsford’s hand meets Eze’s head. His head is tilted toward the left and is concealing the pistol. Judging by the position of the gun, I don’t see how Eze was shot in the back left side of his head as reports claim. The gun isn’t even pointed at the back left side of his head, which is completely visible. It is pointed at the ground with the barrel extending down past the front of Eze’s head. The weapon would need to be elevated to the point of exposing the muzzle in order for the bullet to hit where they say it did.

The second officer’s cam gives us a slightly better view of this exhibition match. As is customary, the acting leaves much to be desired. “Stop it!” Oh, no! “Stop it!” As they try not to inflict road rash on one another. The WWE is more believable. Having said that, take note of the shape these guys are in. These aren’t your everyday cops, neither is our alleged perp who is also in decent shape. Look how vascular their arms are. It is almost as if their job is to take PED’s and workout so they can look good for the cameras. We get a glimpse of Lunsford’s taser at the ready, but he opts for his pistol. Why? Because this story is to be a white man killing a black man, not subduing one. Again, the \$500 body cam fails to

provide us with anything of real value, something Lunsford's attorney admits: "**The body worn camera videos can't and don't show much of anything.**" You can be sure that was done on purpose.

We do get to see what looks to be blood gushing out from Eze's head from this officer's perspective, though it is unclear where exactly the blood is coming from. If there is a hole in his head, his arm is covering it. They want our imagination to fill in the blanks, forgoing all logic by getting lost in the ensuing chaos. Eze's "wound" gushes profusely, but only for a second, then it magically stops bleeding once we get a good view of his head. The puddle does continue to grow in size, though I'm not sure how as there is no hole in his head.



Do you see a hole in his head? I sure don't. If you do think you see something, I advise you to watch the video because the recording is full of compression artifacts. The magic bullet must have conveniently nestled itself inside of Eze's ear because that is the only opening present on the left side of his head. But that would of course conflict with the office report. We are specifically told he was shot in the back left side of the head, not his ear. Also, [the blood looks odd](#), doesn't it? Most notably in its viscosity and the way it interacts with its surroundings. It looks like a 3D fluid simulation render, and that's probably because it was added in post via CGI. Once more, I will point out ***the lack of blood splatter***. Blood is only seen in a puddle around Eze's head. I guess it is too difficult to make computer generated blood splatter look believable when inserted into live action footage due to it potentially introducing continuity problems from different camera angles, like the one I'm about to show you.



Wow, the amateur cameramen went all out to get these immediate crime scene films/photos. Except for one thing: bystanders wouldn't be allowed to get in there like that, and cop cams are not used for that purpose. The first image is the blood puddle created the moment Eze's head strikes the ground. Which is already a decent size, might I add. But, more importantly, note the long thin blood streaks that stretch out on the pavement. The second image is 4 seconds after the first (the time it took the officer to stand up), and as you can see—the long blood lines have disappeared without a trace. They have been replaced in a matter of seconds with a short and stubby protrusion, eventually forming the curvy puddle previously shown. It seems the AI was unable to extrapolate from the initial blood puddle correctly, forming two completely different patterns. I will be told the blood continued to flow and thickened the line, but it is still too short compared to the first image. Not to mention, the blood flow contributing to that side of the puddle had significantly subsided.
