

# A Compendium of Fakes

I've been piling up a lot of events to write about. Sometimes there isn't much to say or dive into with these fakes, so I thought I'd try a compilation paper. I'll cover a few historical events and then finish off with a couple recent interactions with YouTube. The internet is getting incredibly spooky with increasing amounts of bot generated content. Miles covered this a few months ago with his paper [Operation Chaos Shifts into Overdrive](#).

Let's start with the Paul Getty III kidnapping in 1973. The film that brought this to my attention was *All the Money in the World* from 2017, directed by Ridley Scott. Scott has directed many historical dramas such as *Black Hawk Down*, *American Gangster*, *House of Gucci*, and *Napoleon* (2023). It was an excruciatingly boring film with a gray tone added in post processing or something. Mark Wahlberg, who plays the Getty's security adviser Fletcher Chace (Chace=**Chase**), and **former-CIA operative** trying to recover Getty, has less charisma on screen than a two by four with googly eyes attached to it. Getty is pictured above and looks like he has googly eyes doesn't he. Apparently, Paul suffered a stroke in 1981 due to an overdose on a cocktail of valium, methadone, and alcohol. This caused him to become quadriplegic, partially blind, and unable to speak. I suppose this is possible being that these rich kids have a lot of drug issues, and he may have overdone it at some point.

Anyway, Wikipedia tells us that the 16-year-old Getty was kidnapped in Rome at 3am on July 10, 1973. Getty is the grandson of oil tycoon J. Paul Getty. We're immediately clued in on a fake when the next sentence states:

According to his girlfriend Gisela Schmidt, he had toyed with the idea of having himself "kidnapped" by petty criminals when the couple were struggling to make ends meet, but

changed his mind when both began working as models for photographers. She stated that "Paul didn't want to be kidnapped anymore, but the kidnappers continued following him."<sup>[9]</sup>

So this is already reminding us of the [Heineken kidnapping](#) ten years later that I blew the cover of last Christmas.

Getty was blindfolded and imprisoned in a cave in Calabria. **A cave! Right. Strictly Hollywood.** The kidnappers then issue a demand for \$17 million dollars. The Getty family asks for the grandfather (oil tycoon) pay for his return, but he refuses, scared that paying could lead to either more kidnappings or that young Paul here is trying to swindle him out of money. By November, after demands were not met, the captors cut off Paul's right ear and sent it to his family. His ear allegedly became infected so his captors gave him large doses of penicillin. Finally, the grandfather agreed to pay no more than \$2.2 million, **the maximum amount that was tax deductible**, and this money lent to his son would be repaid at four percent interest. What a guy!

Shortly after the money was paid, Paul was found alive on December 15, 1973 at a gas station in Lauria, located in the province of Potenza. From an article by the [Daily Mail](#), covering the death of Getty in 1999, we're shown photos sent from the kidnappers as well as photos of Paul after recovery.

The first photo is pretty laughable. The sweater looks 2-dimensional. How many bandages did they put on him?! **He looks more like the Elephant Man. You can't even tell what is going on with that head. And what's the deal with his hand? It just dissolves.** There is also no way to verify that is even Paul. The second photo of Paul with the "missing" ear is very grainy. They could easily black out part of the ear to match with his hair.

Below is a photo of the “bewildered” Paul with Italian police. Note that you can’t see his right ear.

Other than the dumb look on his face, he doesn't seem all that bewildered or emaciated to me, supposedly having an ear infection for months. This is after five months of being held in a cave. You have to laugh at the hands in his pockets as he strolls down the stairs. I guess that is to hide the dissolving hand.

Soon after his release, nine kidnapers were apprehended. Not sure how they could find them so quickly. Two of the kidnapers were Girolamo Piromalli and Saverio Mammoliti, high-ranking members of the Ndrangheta crime organization in Calabria. Only two kidnapers were convicted and sent to prison while the others were acquitted for lack of evidence. I'm guessing the Ndrangheta are a subsidiary of Italian Intelligence and is a make-work project, much like the Mafia in the US. Wikipedia states Piromalli was a member of the Italian Freemasonry.



There are a couple profile pictures of Paul with the missing ear that I could find (shown below) and they both look tampered with. You'll notice how much brighter and washed out the area around his injured ear is.



After the recovery of Paul, he continued to live a rich kid hippy/bohemian lifestyle, always photographed with long hair, which covers his injured ear. The photo below shows Paul at an [Andy Warhol](#) party. Why is he holding sunglasses? Can he even wear them without his right ear?

In the photo under my title of this paper, you'll see that Paul's ear looks fine. In 1977, Paul had plastic surgery to rebuild his ear, which is a convenient way to cover that he never lost his ear.

For one more hilarious factoid, Wikipedia states that, "[Paul] never fully recovered [from his stroke] and remained severely disabled for the rest of his life. By 1987, he had regained some degree of autonomy and was able to ski when strapped to a metal frame. <sup>[18]</sup>"



I remind you that was caused by the overdose, not the kidnaping.

Next up is a [helicopter prison escape in France on May 28<sup>th</sup>, 1986](#). The things they expect us to believe!



The escapee is Michel Vaujour, who was serving a 28-year (some sources say 18) sentence at the high-security section of the Santé Prison in Paris for bank robbery and attempted murder. It is reported that Michel had already tried to escape three times before this, but we're never told any details about them. His fourth attempt is shown in the picture above. I guess the prison guards have portable cameras on hand. The pilot is his wife, Nadine Vaujour, who had learned to fly a helicopter in order to break him out.

Didn't know it was that simple to get on the roof of a maximum-security prison. From the article linked, it is said that, "Michel, armed with a fake gun made out of plastic and painted black, made his way to the rooftop. He had persuaded his guards to let him out for 'exercise', a ruse that would allow him to be in the right place at the right time." Ya OK!? Prisoners have specific times outside and don't get requests like this, plus he had already tried to escape. Other reports I found state that Michel had painted nectarines to look like grenades, threatening to detonate them if not allowed on the roof. Even if any of that were true, the timing of a helicopter flying in just as he gets on the roof would have to be insanely precise. Clearly this whole thing is staged with the cameras ready to roll. Just look at this other photograph below.





Who even took this photo? It's probably a paste since it doesn't look like he's holding on for dear life; almost floating in the shot. His jacket also shows too much light since he should be in complete shadow behind the helicopter. Why are the prisoners wearing street clothes? The article I linked also said they used a rope ladder, which I can't see in any of these photos. This whole event is absurd from the first word.

Another photo [I found here](#) doesn't even come close to matching the photos above. The chimney is missing and the lighting is completely different. The guy with the white shirt (I'm assuming) is supposed to be Michels prison buddy Pierre Hernandez, who lost his nerve and surrendered.





Apparently, the couple were captured again 4 months after the escape. Michel was sentenced an additional 17 years in prison. He attempted to escape prison again but failed. In 2003, for whatever reason, Michel was released after 27 years. He wrote a biography titled, "*Love Saved Me from Sinking*", where he shares how the power of yoga helped him deal with being held in isolation for the remainder of his years in prison. Oi Vay!



I was listening to a podcast when I heard the name Kim Dotcom (real name Kim Schimtz), born in Germany to a Finnish mother and also a dual citizen of Finland. His whole persona "*Internet-Playboy-Badboy*" looks completely fake to me; exacerbated by all the strange photographs I've found of him.



He is the founder and CEO of file sharing/hosting servers [Megaupload](#) and [Mega](#). He's most famous for being an "internet entrepreneur" and hacker/hacktivist. Kim claims that during his teen years, he hacked into NASA, the Pentagon, Citibank and corporate PBX systems in US.

His run-ins with the law don't seem to make any sense. From Wikipedia we are told:

He rose to fame in Germany in the 1990s as a [hacker](#) and an Internet entrepreneur.<sup>[7]</sup> He was arrested in 1994 for [trafficking](#) in stolen phone calling card numbers. He was convicted on **eleven** charges of [computer fraud](#), **ten** charges of [data espionage](#), and various other charges in 1998 for which he served a two-year [suspended sentence](#).<sup>[7]</sup> In 2003, he was [deported](#) from Thailand to Germany, where he pleaded guilty to [embezzlement](#) in November 2003 and after five months in jail awaiting trial he received another 20 months suspended sentence [as well as a €100,000 fine from other sources].<sup>[8]</sup>

Five months in jail awaiting trial? Really? He couldn't make bail with all the money they claim he made? His family couldn't help him either?

From a [Wired magazine article written in 2012](#), we are told soon after his ordeal with German authorities, Kim landed a security contract for Data Protect with the airline Lufthansa by demonstrating an apparent security vulnerability. Data Protect was a company started by Kim, eventually changing it's name to Megaupload. There's a section in the article detailing Kim's "rags to riches", which I'm sure is complete fiction; as usual for these privileged brats. Schmitz and Data Protect led the development of a Megacar, "an Internet-connected luxury car system." In 2000, Kim sold an 80 percent stake in Data Protect to the German conglomerate [TÜV Rheinland](#). Kim would take the cash made from this sale to make horrible self-promoting movies about himself and his lavish lifestyle.

In 2001, we are told Schmitz bought 375,000 euros worth of shares in the LetsBuyIt.com, a company said to be close to bankruptcy. Kim announced that he would be investing an additional 50 million euros. After stock prices surged, Kim cashed out, making a profit of 1.5 million Euros. I'm not sure why anyone would care or listen to Kim as an investor but I don't know. Apparently, the German authorities

would charge him with insider trading, extraditing him from Thailand where he moved to escape charges (shown previously in the paragraph from Wikipedia above).

The *Wired* article continues:

[Just after the LetsBuyIt grift], another pet project was getting ready to crater. Schmitz had launched Monkey AG and Monkeybank, an e-payment company with venture capital from German private equity company [BMP](#) (which held a 35 percent stake). Monkey also shared the address, and most of the employees, of Data Protect—which was owned by TÜV.

By June of 2001, BMP and TÜV went into damage control mode, cutting Schmitz's management involvement in Monkey and the rest of the companies. "Everything that has grown up around Mr. Schmitz is, to say the least, somewhat dubious," TÜV spokesman Tobias Kerchoff told the German business site Handelsblatt.com. And there was plenty of reason for that dubiousness: somewhere in the confusion, Schmitz got €280,000 in the form of an unsecured loan to Kimvestor. He would later claim to have been "dazzled," unaware that he would be unable to repay the loan.

Somehow after all this, Kim claimed that in September of 2001 his net worth was \$100 million. None of this makes any sense to me. For more hilarity, we are told in the wake of the September 11, attacks, Kim created a group called Young Intelligent Hackers Against Terrorism (YIHAT), and to have hacked Sudanese bank accounts belonging to Osama Bin Laden. He also offered a \$10 million reward for information leading to Osama's capture from his kimble.org site. You have to laugh.

Eventually, Kim got into the file-sharing scam, changing Data Protect into Megaupload in 2005. At this time, Kim changed his last name Schmitz to Dotcom as well as moving to Hong Kong. In 2007, he met his first wife Mona Verga, a model originally from the Philippines. Below is a photograph I found from an article at news.com.au.





Wow does that look fake or what? They had four children together, **all using IVF**. Because getting it up for pretty Pilipino model is difficult right? Or maybe she couldn't find his cock in all the rolls of fat. The couple would move to New Zealand by 2010. His Megaupload site and other ventures led to extreme wealth. From [International Business Times \(UK\)](#) we are told Kim was leasing a mansion and a helicopter, as well as purchasing dozens of cars. He allegedly invested \$10 million in New Zealand in order to receive permanent residency. By 2012, Megaupload is reported to have over 150 employees, \$175 million in revenues, and 50 million daily visitors.

From Wikipedia:

On 5 January 2012,<sup>[70]</sup> [indictments](#) were filed in [Virginia](#) in the United States against Dotcom and other company executives with crimes including racketeering, conspiring to commit copyright infringement, and conspiring to commit money laundering.<sup>[71]</sup> Two weeks later on 20 January, Dotcom, Finn Batato, Mathias Ortmann and Bram van der Kolk<sup>[citation needed]</sup> were arrested in [Coatesville, New Zealand](#) by the New Zealand Police, in an armed raid on Dotcom's house involving 76 officers and two helicopters.<sup>[72]</sup> Seized assets included eighteen luxury cars, large TVs, works of art and US\$175 million in cash. Dotcom's bank accounts were frozen, denying him access to 64 bank accounts world-wide, including BNZ and Kiwibank accounts in New Zealand, government bonds and money from numerous PayPal accounts.<sup>[73]</sup>

Dotcom was [remanded](#) to [Mt Eden Prison](#) and alleged poor treatment by the authorities.<sup>[74]</sup> On 22 February, North Shore District Court Judge Nevin Dawson overturned previous rulings and released Dotcom on bail, reasoning that Dotcom had neither the ability nor desire to flee the country.<sup>[75]</sup>

From here on forward things get increasingly weird. The entire section at Wikipedia entitled "Megaupload arrest and extradition proceedings," rambles on and on and on: Hight Court rulings, Courts of Appeal, Confidential settlement with police, Supreme Court decisions, as well as being spied on by Government Communications Security Bureau (GCSB). By 2014, Kim had spent \$10 million on his defense. Despite all these crazy legal problems Kim is facing, one year earlier (2013), Kim would aspire to enter New Zealand politics by starting the Internet Party in 2014, which pretty much landed dead on arrival, winning zero seats. Their party color is **purple**. Kim would provide NZ\$3.5 million in funding the party, the largest personal contribution to a political party on record in New Zealand. The party appointed [Laila Harré](#), a former Alliance MP and cabinet minister. Harré joined the Labour Party in 1982, working in the party's New Zealand Council, working in the [Beehive](#) (shown below) as an advisor to disarmament minister [Fran Wilde](#). Reminds me of the Miles guest writer, Gerry, on [Ancient Spooks](#).



The “Extradition” section on Kim’s Wiki page is also absurd. After 3 years of delays, extradition proceedings were finally pushed through in September of 2015. This section covers 9 years of legal battles, finally ending in 2023 with:

The two executives charged for operating Megaupload along with Dotcom, namely Mathias Ortmann and Bram van der Kolk, agreed to a [plea bargain](#) with New Zealand and US prosecutors that June, <sup>[144]</sup><sup>[145]</sup> and were sentenced to two years seven months and two years six months in a New Zealand prison respectively on 15 June 2023, <sup>[146]</sup> leaving Dotcom as the only party still defending his innocence in the case. <sup>[145]</sup>

On 15 August 2024, the new Minister of Justice, [Paul Goldsmith](#) signed Dotcom's extradition order. <sup>[141]</sup> Barrister [Clive Elliott KC](#) commented that Dotcom cannot appeal the decision, but can seek judicial review of the process. <sup>[147]</sup>

Around the time Kim’s extradition papers were finally pushed through by the courts in 2015, I found [this article](#) by the *New Zealand Herald* from the same month and year. In it we find this ridiculous photo below of Kim, who’s obviously pasted in with his IVF “children” at a birthday party.



Kim Dotcom fears he will be separated from his five children: Kaylo, 8, Kobi, 5, Keera, 3, Kimmo, 6, and Kylee 3.

Just a pitiful paste-up.

In 2014, Mona and Kim would divorce. In 2018, Kim would marry a woman, Elizabeth Donnelly, on the same date as the infamous raid where he was arrested. Donnelly is about 20 years younger than Kim. He eventually had a child with her in 2022, **also via IVF**. Clearly this must indicate he's gay. Many of the photos I found of them together are horrible paste-ups, such as the two shown below.







“Y’all be jealous of my IVF baby making!”

The last entry from Wikipedia reports Kim suffered a stroke in 2024. Kim posted a photo with his family on X, celebrating his recovery. Elizabeth is clearly pasted in there. You have to laugh.

So like Musk, this guy is a total fraud, only fatter and with more hair.

Ok let's finish off with some of interactions on YouTube. The first algorithm suggested to me is a fear-mongering police bodycam channel EWU (Explore With US); probably not AI generated, but likely funded and acted out by the usual suspects. Here is the mission statement of the channel:

We're a news agency committed to delivering factual information about police procedures and local news events. This video aims to educate the public without bias.  
**Our goal is to empower viewers with a clear understanding of what's happening in**

**their communities.** This is news piece in the public's interest. This video was created with the intent of educating the public.

I bolded the sentence above, because you're about to see how scummy this channel is. Here's the first video that I want to report on: <https://www.youtube.com/watch?v=OZ2al59QGoM>. The title of the video is **Man Walks In On Killer Sawing His Roommate's Neck**.

As of today, 6/18/2025, you'll see of views and publish date on the page.

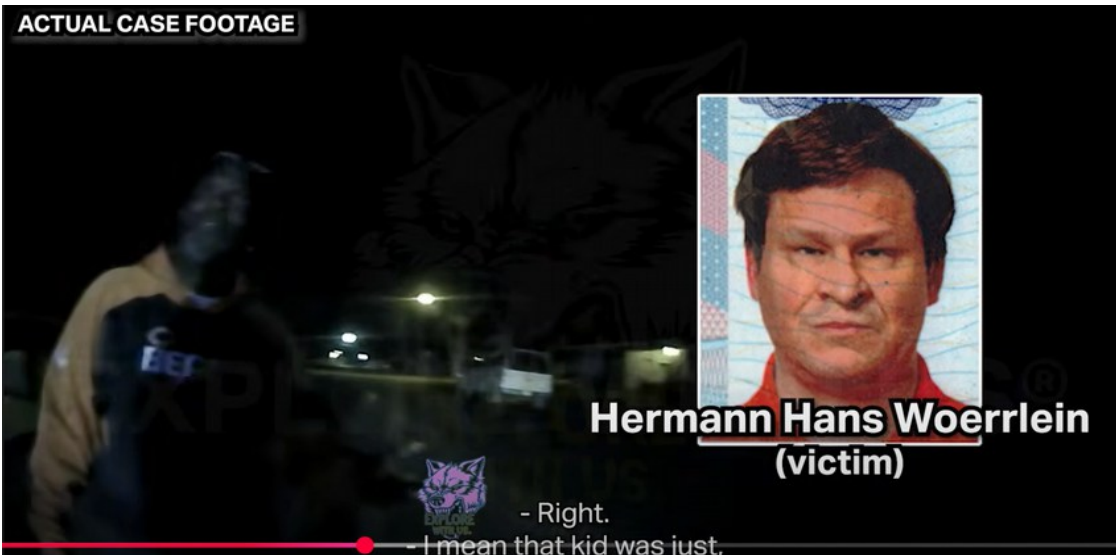
In today's true crime documentary and body camera video, we're covering the arrest of Douglass Taylor.

This "crime" footage was recorded on March 10<sup>th</sup>, 2020 in Idaho Falls, ID. The video starts with a man named Aaron on the phone with police dispatch. The house he lives in is an alternative housing project called the Graduate House, with 4 other roommates, including our vicim Hermann Hans Woerrlein (age 51) and the perp Douglass Taylor (age 32). Aaron relays that Douglass ran down the street towards the Common Cents (i.e., use some common-sense dear viewers; this is obviously staged). None of the officers take off towards the Common Cents, but instead clear the house and stand around Hans bleeding out in the kitchen.

The paramedics realize that Hans is still alive. At minute 5:20, the paramedics start CPR...on a guy who is apparently been cut across the throat. One paramedic is doing compressions *while standing with bent knees* over Hans. Ya, that's not how you perform CPR buddy. You also might want to stop the bleeding before that too. No one on Earth would ever call this 51-year-old man a good kid. An Intelius search finds one matching Hans Woerrlein with the right age and locations. You'll notice that Hans is 56, even though he died at age 51. Looks like the big computers don't know he's supposed to be dead. The usual mistake in these fake killings.

Even though Hans is blurred out, there is almost no blood, even though his throat has been severely cut. The whole scene is just embarrassing, with the paramedics saying things like:

"When we get that top off, let's work on vascular access" (while his partner is *still doing compressions* on a dummy)

"All right, good lung sound"

- "Nice, nice" There we go boys, just hold that f\*\*\*ing spot"

"Dude, I can't believe we got a rhythm."

notice there is not one speck of blood on him (even when they arrested him, shown in the video a few minutes earlier). Douglass of course acts completely deranged; talking about metaphysics, German mythology, and his desire to remove anyone who would start a Nazi cult.

At minute 24:31, "Officer Schwicht" asks Douglass,

"After stabbing a guy like this, what do you think would be the right thing to do with you? What do you think that the police, law, judges, you know and all these people who sit and make decision about all of this, what do you think is the right and appropriate thing to do is?"

Douglass responds "I'm not sure, Jail then Prison?"

"Do you think that's the right thing for you?"

WHAT?! By the end of the video, we're told this teaser of a plot twist: while in jail awaiting trial, Douglass wrote a letter to Schwicht, explaining it was Aaron that stabbed Hans! Aaron had threatened Douglass, as well as giving him a jacket with blood on it.

There are an incredible number of videos on this EWU channel, which I'm guessing are all completely staged and fake.

I was browsing YouTube on my phone, looking at videos underneath to see what I wanted to watch next and noticed some bizarre stuff. Around June 1<sup>st</sup>, there were three videos with AI generated thumbnails from three different channels.

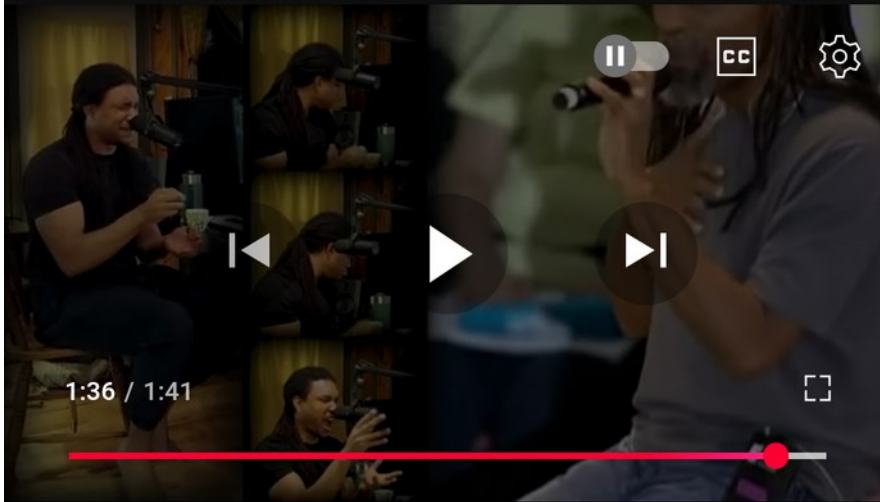

I was having a conversation with a friend of mine about this growing problem. He suggested that this may be Problem/Reaction/Solution attempt, in order to bring in Web 2.0 based on blockchain technology. Honestly I don't know, but it seems like the Google and all the major media distributors have no problems unleashing this new version of CHAOS onto the Internet.
