THE HANUKKAH STABBING IN MONSEY WAS FAKED *and they tell you why*

Which means you are now living in the age of what used to be called the Chinese internet: an internet where all freedom of information has been forcibly squelched by the government. The mainstream isn't reporting on this, since of course the mainstream media is part of the squelch. The media has been squelched, and the media is doing the squelching.

Yes, in two years we have seen a sea change on the internet, and no one is reporting on it. No one is being allowed to. They want you to think this is a response to "fake news", with various agencies and companies pushing back on purposely lying bloggers and other trolls. But of course just the opposite is the truth. This is purposely lying agencies, companies and governments illegally shutting down free speech to protect their lies. It is mainstream news that is fake, and most bloggers (that aren't themselves government plants) are just trying to educate you about that.

For the time being, I am still here, since I am not connected to Youtube, Facebook, or any of those places. I have an independent website, which is so far beyond the reach of these people. But the search engines are making it harder for you to find me. Either the spiders are being told not to walk down my street, or the search terms are simply blocked. I don't come up on searches that I should

come up on. Which is why word of mouth is now more important than ever. Talk to your neighbors and friends: give them my website by mouth, phone, email, letter, telegram, or message in a bottle.

Anyway, if we check the Wikipedia page for the Monsey stabbing, we don't get much. They are figuring out the less they say the better, because everything they say will be picked apart by yours truly. You may have thought this happened in a synagogue, but it didn't. It was in a private home at 47 Forshay Rd. We are told over 100 people were there to watch Rabbi Chaim Rottenberg light candles. Hmmm. Must have been a big house. Can you fit 100 people in your home? According to zillow.com, this house is 2,400 square feet. Large, but not super-large. You can't fit 100 people in that house, unless you also pack them into upstairs bedrooms and bathrooms. And you can't watch candles being lit if you are in an upstairs bedroom. 37-year-old black man **Grafton E. Thomas** allegedly walked in and started swinging a machete. With a hundred people packed into the living room, he wouldn't have much room to swing a machete, would he? And why light the candles in a crowded house? The synagogue was right next door, and that is what synagogues are for, remember? Sounds like a fake name, doesn't it? They probably just reversed the name. He is more likely to be Thomas Grafton, isn't he? Anyway, a search on him at Intelius finds him related to Kim Thomas, and [Instantcheckmate lists](#) her as Kim. . . **Kennedy**. But why does the computer pull up Thomas S. Taneff along with Grafton Thomas? It must know something we don't. This Taneff is related to a Mould along with Taneffs. That is suggestive, seeing that the Moulds in the British peerage are related to the Stuarts. How do I know that? Because I researched Philip Mould, star of the BBC's *Fake or Fortune*, finding he was a direct descendant of King Charles II. A search on this Thomas Taneff of Columbus, OH, finds he is an adoption and probate attorney. He is a trustee of Jewish Family Services, but other than that I couldn't find his link to this story. According to Instantcheckmate, there is only one Dale Mould in the entire US, age 69, also related to the Evans-Teagues and the Spychalas. The Spychalas are of New York and Ft. Myers, FL, and are Jewish, related to the Zulskis, Zabrons, Gluzaks, and Kaminskis. I can't get any further than that, so I will just say it is strange the computer would bring up a Jewish person along with Grafton Thomas, for no apparent reason.

The FBI tells us that on November 9 of this year—that is, just about six weeks before the event—

Thomas used his phone to search “Why did Hitler hate the Jews?” Really? This 37-year-old man didn't know the answer to that question? He didn't understand why the Jews were hated just one month ago, but this month he hated them enough to try to kill dozens of them in cold blood? This dude's mind works fast. He doesn't sound like a mental patient, he sounds like some sort of savant. To see how quick he was on the uptake, we find he searched on “prominent companies founded by Jews in America” only the day before the event. So, he didn't know the answer to that on Friday morning, he learned it on Friday evening, and by Saturday evening he had murderously attacked a large group of Jews? Wow. That's what I call decisive.

You can also read the arrest warrant [here](#). Don't you think it is kind of strange that this Jewish website Matzav.com was able to post this warrant in full on the same day it was issued? The judge issued it on Dec. 30, and by 3:11pm it was already posted here. How does that work? Also curious is that according to the mainstream story, Thomas had already been in custody for a day and a half at that point, so I don't know why they needed an arrest warrant. I guess so that they could post it on this Jewish site.



[That is supposed to be the 70-year-old victim of Thomas.](#) Does he look 70 to you? He has no wrinkles or gray hair. His mustache and eyebrows have full color. He looks about 50 to me. And how does someone swinging a machete cause those parallel cuts? He would have to hit him in almost the same place twice. Plus, if you got hit in the forehead twice with a machete, you wouldn't just have cuts, you would have serious bruising over a split skull, which we *do not see*. In fact, if a big black man hit an old Jewish man in the forehead twice with a machete, **he would be dead**. His brains would be all over the carpet. And why would Thomas attack a defenseless old man? Doesn't seem very sporting, does it? And what are those lines on his head? They tell us they are part of the operation, drawn by the doctors, but the line turns to your left, away from the wounds. I can't make sense of that. Since I know this event was faked, I know this is not what we are told it is. We have no indication this is Josef Neumann, so I assume it isn't. I feel sorry for this poor guy, but my guess is he fell and hit his head on the curb, or crashed his motorcycle, or something. Just because they publish a picture of some wounded guy doesn't mean the event has been authenticated. There are hundreds of wounded people

lying around in hospitals in the New York area on a daily basis. And this isn't dated. It could have been taken any time in the past 30 years. I do like the roll of toilet paper perched on his head. That is a nice touch.

Next, we search on this Rabbi Chaim Rottenberg of the event previous to December 2019, and we find that Rottenberg is a very prominent name among rabbis. The Chief Rabbi of France before the current one was named. . . Chaim Rottenberg. His father was the Chief Rabbi of Antwerp. His son Mordechai Rottenberg is now the Chief Rabbi of France, and he married Bella Yoskowitch, daughter of the Chief Rabbi of Poland. So the Rottenbergs are not some down-market small-town Rabbis, holding prayer meetings in tar shacks. They are top Rabbis and are *connected* worldwide.

They tell you the suspect had been charged in 2018 with weapon possession, endangerment, and menacing a policeman. He had been arrested seven times since 2001, for assault, resisting arrest, killing or injuring a police dog, and possession. You can be sure that never happened, and that Thomas is just another guy from actor's equity. But they are leading you in. You are supposed to read that and go, "Then why in hell was he on the street?" Because they have an answer for you. The page includes a section on it:

The crime has sparked a discussion about the impact of recent [New York State bail reforms](#) which require courts to release individuals on non monetary conditions for almost all misdemeanors and non violent felonies, as well as burglary and robbery in the second degree, regardless of whether the crime is a [hate crime](#).^[20] Thomas had previously been released from police custody after being arrested for a number of minor violent crimes.

If we take that link on New York bail reforms, we find out two things. One, that isn't true. Courts *aren't* required to release violent or dangerous individuals, and judges aren't being stripped of discretion. Just reading Wiki, you would come to the conclusion that everyone short of murderers and rapists were being summarily released until trial, and that there was nothing judges, courts, or governments could do about it. But just ask yourself if that makes any sense. Why would New York's legislature do that? They just like to create chaos? They like for criminals to be on the streets causing problems? No, of course not. It doesn't make any sense, so it can't be true. But it is being reported that way, why? . . . to create fear. They want you to *think* people are being stabbed all over the place by psychopaths on the loose, and they want you to think that legislators are their accomplices in this psychopathy. Because if you think that you are easier to control. You will pay more for protection, you will pay more for police, you will pay more for military, you will buy more guns, you will buy more stuff across the board.

Governor Andrew Cuomo was quick to play on this fear, calling the fake event an act of "domestic terrorism". Jewish lawmakers demanded a state of emergency. For one guy with a machete, who was in custody? Where is the emergency? Even if the event were real, it wouldn't qualify as terrorism, since it was just some lone nut stabbing people for no good reason. Cuomo needs to look up the definition of terrorism. But of course Cuomo is Jewish as well. His mother, maiden name Raffa, is scrubbed, but [New York Magazine](#) admits her father died at the Jewish Institute for Geriatric Care. His wife's maiden name was Gitto, another Jewish name from Sicily.* Andrew's sister married a Maier, his brother married a Greeven (Jewish), and his wife is a . . . **Kennedy** (daughter of RFK). See the link above. And now do your dance.

Two, if we take that link to New York's bail reforms, we find that the reforms *haven't taken effect yet*. However, we are told

New York state judges reportedly started releasing criminal suspects in November 2019 due to the impending law implementation. It is estimated that 25,000 people will be released by the time the law takes effect.[\[6\]](#)

That's convenient for the current story, isn't it, since according to that, those awaiting trial started being released in November, and by December one of them decided to stab a bunch of Jews for no reason. What are the odds? In fact, [if we take that link at footnote number 6](#) for confirmation of that story, we are taken to Pix11.com, and a story posted on . . . December 26. *Two days before the alleged stabbing.* So, Pix11 reports on release of prisoners on Thursday, and by Saturday one of these released prisoners stabs a bunch of Jews? Also suspicious is this outlet Pix11. If New York judges were really being forced to release dangerous prisoners, don't you think bigger outlets than Pix11 would be reporting it? Why no link to the *New York Times* or *The Post*? In fact, I encourage you to take that link to Pix11, and not just read the story, but study the website itself. It looks to me like a fake website, one just put up by some cubicle spooks at Langley. They didn't even bother making this website look real, since the headers and footers are non-existent. No sidebars. Almost no links in or out.

There, it is “estimated 25,000 people will be released by the time the law takes effect” (Jan. 1, 2020). Estimated by whom? And why are they being released *before* the law takes effect? Does that make any sense? If the judges are really concerned that this is a bad law, why rush into it? Wouldn't you expect them to resist it as long as they can, not bow to it before they have to? But no, we are expected to believe they are in a hurry to get all these dangerous people on the streets as soon as possible, preferably before Christmas and Hanukkah, so they can do the maximum amount of damage over the holidays?

So what is this really about? My guess it is about money lost from bail. Most bail used to come from minor, non-violent offenses. I know someone who recently had to pay bail for getting in a shoving match with his friend and neighbor while they were both drunk. Neither were injured, but the loser in the shoving match got his dander up and got the police involved. They blew it all out of proportion, lawyers were hired, thousands of dollars went down the drain, bail was posted, and an indictment was filed. That's right, he was indicted. It all went nowhere, but several people made a lot of money for nothing. Bail bonding is a big business, and we can guess who owns most of it in New York: Jews. They obviously don't like losing this big slice of business, so they have created this fake event (and others) to try to reverse the law. They want bail to come back. If it were up to them you would have to post bail for parking tickets. So now you know.

[**Addendum January 25, 2020:** a reader just sent me this link to [an Atlantic article](#) from 2017, which confirms my assumptions here. There, we discover these interesting facts: 1) 70% of those in jail nationwide have not been convicted of anything. 2) Between 1990 and 2009, the percentage of those required to post bail rose from 37% to 61%. 3) In one small state (Maryland), \$75 million dollars were stolen from citizens who posted bail, were acquitted, and whose bail was not refunded. 4) Blacks pay up to 84% of bail premiums and fees. 5) Storefront bailbond services like those found in poor communities are run by large global insurance companies. And who owns those companies: the Phoenician Navy, of course.]

You may also be interested to know that *Haaretz* is reporting in Israel that [Most US Jews Don't Care About Anti-Semitic Violence against the Ultra-Orthodox](#). “The muted response to the string of attacks in NYC shows that mainstream U.S. Jewry is indifferent to Haredim and hesitant to condemn those who target them.” Really? And you believe that? I don't. I'm not even Jewish, but if I believed this

attack was real, I would condemn it. No one condones pointless violence, so why is *Haaretz* claiming this? Because *Haaretz* is itself any enemy of orthodox Jews, and misses no opportunity to diss them. They want you to think orthodox Jews are so unpopular, even with their fellow Jews, that no one cares if they get stabbed or killed. Lovely sentiment, right? Compare it to the way the mainstream in the US misses no opportunity to slander the Amish. Same thing.

In fact, I am advised that this may tie into current elections in Israel, where they are having trouble forming a government, due to Netanyahu's criminality, but more importantly due to feuding between major Jewish factions. One of those factions just happens to include Orthodox Jews of the sort we are looking at in Monsey. So it may be no accident the Israeli press is using the event to blackwash the Orthodox and create fear in that community. Even if Mossad didn't manufacture the event itself, it never lets an event go to waste.

What is really happening in the US is that normal Jews, *and everyone else*, have a muted response to these stories of violence because. . . they know they are hoaxes. No one pays the news any mind anymore, because we know it is all manufactured. We know all these stories are fake, so why bother to have any response to them, muted or not? The only response worth having is anger, and that is the response I wish you had. Instead of ignoring these stories, you should force them back down the mainstream's throat, like I do. *As a surname, Gitto is an Italianization of Gitter, Yiddish for "good". Also linked to Gittelman, Gitlitz and Gitlin. Mario Cuomo's mother Immacolata Giordano is also scrubbed at the genealogy sites, for obvious reasons: Giordano is also a Jewish name, linking us to the Gordons, Dukes of Gordon, in the British peerage. Same for his grandmother Maria d'Elia. D'Elia is a Jewish name, see actor Chris D'Elia (NBC's *Whitney*), who *Washington Jewish Week* pretty much [admits is Jewish](#). His mother is a Dombroski. Also see Luis D'Elia of Argentina, who is playing the part of opposition control on the Jewish question there, pretending to be anti-Semitic. His mother is a Prieto, which is Jewish. His parents were top Peronistes, and I have shown before [the Perons were Jewish](#). Luis is a protege of Nestor Kirchner, and of course Kirchner is a Jewish name. D'Elia's contacts with Ahmadinejad tell us he is also playing the pretend opposition. Ahmadinejad's mother is given only as Khanom, but my guess is that is a variation of Komnene/Cohen. [I am informed by a reader that Khanom means "Lady" in Farsi, as in Lord and Lady. So that is her title, not her name. Wikipedia is hiding not only her family name, but all names. Turns out, Khanom is an aristocratic title, indicating a bloodline going back to Muhammad. So I may still be correct: Muhammad himself may well be a Komnene; or the aristocratic bloodline may point back to Komnenes, with Muhammad as a dodge.] Also see actress [Sofia Black D'Elia](#), admitted to be Jewish.
