Fake L-Train Attack, the sequel

Just ten weeks ago a black guy fake-stabbed a pretty girl on an L train in Charlotte, and that was so popular with the public they decided to do a sequel. Some people seem to be keen for a manufactured race war, and they don't look too closely at these things to be sure they are real.

Even better is the picture of him, which was chosen for the same reasons, in reverse. You are supposed to hate him: that is what the horrible Medusa dreads are about, the closed eyes, and the weird grimace to make him look extra crazy. They need to key you every way they can, short of making sense. Because this makes no sense. It is supposed to be his mugshot, but mugshots don't look like this. If you close your eyes or grimace, they make you retake it. They have to see your eyes for the recognition. Even a computer would have trouble making a match with the eyes closed and the face screwed up to that extent. Plus there is no card or height line, so this looks more like a bunged passport photo. Or CIA actors' guild photo.

So this event is already exploded, but I will continue on just for fun. The first thing I did is look up this Bethany MaGee of Chicago. Already the spelling is a clue, since the "g" isn't normally capitalized. It is normally Magee. I found nothing for a Bethany Magee of Upland or West Lafayette, IN, age 26, at Radaris. Also nothing for Chicago. Instantcheckmate has her listed, but not for West Lafayette, where she is said to have gone to university at Purdue. Her father is apparently Gregory Scott Magee, 56, but

most of his addresses are Texas, not Indiana. He lived in Austin recently, for instance. He is also supposed to be a Sunday School teacher, though they don't say where. I confirmed he is a professor at Taylor, and there we learn he spent ten years with Campus Crusade for Christ in the US and Asia. We have seen that before as a red flag, since it was started at UCLA by the spooky Brights, who had no previous qualifications for this, coming out of the candy business. I have asked before why UCLA would allow these people to start such a thing on their campus, and I wasn't able to find any logical answer to that. You can read about that on Bill Bright's Wiki page, at the last link.

Remember, they admit Bright started CCC (or Cru as they call it) in part "to combat Communism" in the 1950s. A crusade for Christ to combat Communism? What? Just looks like more proof to me that the CIA was behind this. Don't believe me?

Cru became known for its conservative evangelical theology, strong anti-Communist stance, and the development of evangelistic tools such as the Four Spiritual Laws (1957), one of the most widely distributed religious booklets in history, with over 2.5 billion copies printed in more than 200 languages. Over time, Cru diversified its ministries, launching initiatives such as Athletes in Action, the Jesus Film Project, FamilyLife, and international outreach programs, while also playing a prominent role in large-scale events like Explo '72, often referred to as the "Christian Woodstock."

What part of that doesn't scream CIA? How else could they get such incredible promotion? How else to explain the publishing and film connections?

By 1952, Campus Crusade saw 250 UCLA students join them in following Jesus Christ including decathlete and future film actor Rafer Johnson.

Hmmm, we have also seen Rafer Johnson involved in other CIA projects, haven't we, including the fake RFK assassination. His autobiography was co-authored by Philip Goldberg.

Some notable former Campus Crusade staff members have included the evangelist Hal Lindsey, author of the apocalyptic *The Late, Great Planet Earth*, and Marabel Morgan, the author of *The Total Woman*.[19]

More obvious spooks, in other words.

Grounded in evangelical Christianity, Morgan taught that "A Total Woman caters to her man's special quirks, whether it be in salads, sex, or sports,"[3] and is perhaps best remembered for instructing wives to greet their man at the front door wearing sexy outfits; suggestions included "a cowgirl or a showgirl."

What? How is that evangelical Christianity? I seem to have missed that recommendation in my reading of the New Testament. And Hal Lindsey was even worse:

During 1969, he wrote his first, and best-known book, *The Late Great Planet Earth*. Published during 1970 by Zondervan, this book became a bestseller. Coming on the heels of the Six-Day War, the book fueled the popularity of dispensationalism and its support of ethnic Jews as the "chosen people of God".

Do you see it now? Are you following me here? If not, you can keep clicking on links at Wikipedia, where you will find Zondervan publishing house was started by the. . . Zondervan family, who were closely related to the Eerdmans family of publishers from the Netherlands, both of whom came from textile billionaires. In other words, cloaked Jews. They published some of the first books about the

fake sinking of the *Titanic*. More recently they are famous for publishing hundreds of Christian books written by Jews. See their author Margaret Feinberg, as just one of the easiest examples from Wikipedia. Why would anyone be reading books about Christianity by Jews? Your guess is as good as mine. One of Zondervan's other authors is Andy Stanley. My readers will love that. Also Craig Keener, Thomas Schreiner, Nijay Gupta, and Lynn Cohick. Keener and Schreiner are Jewish names, Gupta we have seen many times as superwealthy Jewish/Indian, and Cohick may be the same as Cohen.

Don't believe me that Zondervan is a Jewish name? Go here and do a lot of clicking, starting with Friedrich Zondervan there. Notice his wife is Frieda Sara de Levie. Levie=Levi. Jewish. Or see Benedikt Zondervan, mother was a **Goudstein**, wife was a Wolff. Also links to DeVries, Jong, Groonheim, Jacobs, Zandbergen (Sandberg), Vermeer, DeBoer (DeBeer), DeHaan (Hahn), and Meyer.

But back to the Campus Crusade. The Four Spiritual Laws consisted of the following points:

- •God loves you and has a wonderful plan for your life.[citation needed]
- •Man is sinful and separated from God, thus he cannot know and experience God's plan for life. [citation needed]
- •Jesus Christ is God's provision for man's sin through whom man can know God's love and plan for his life.[citation needed]
- •We must receive Jesus Christ as Savior and Lord by personal invitation.[citation needed]

I'm sorry, but you don't need Cru for that. That is straight out of the Bible. Except for the last part, which is garbled. Personal invitation from whom? God? Jesus? Will it come in the mail, or by phone or email? Scripture is already all the invitation you need, and it isn't really personal. It is the "glad tidings", remember? Gospel. Actually, the second one is garbled as well, since although you cannot know beforehand God's plan, you *can* experience it and know it that way. You can know God's plan by just keeping your eyes open and seeing what happens. What happens IS God's plan.

The Brights were actually living in Henrietta Mears' mansion in Bel Air when they started Cru. Again, what? Mears came from the Mears bankers of North Dakota and she too was a spooky person who now looks like some sort of agent. Her mother was Margaret Keen Burtis Everts (formerly Evarts), which is a big clue. We have seen them before, as cloaked Jews, spreading dissension and schism on purpose. See for example Margaret's famous father, William Wallace Everts, Baptist minister and author, who liked to write things like *Jesus Christ, No Exorcist.* He may be most famous for fanning the flames in Louisville, KY, during the Civil War. We are told Margaret was a Baptist laywoman, so we aren't sure why her daughter Henrietta became a huge Presbyterian in Hollywood. The two denominations have almost nothing in common.

At age 36 Mears took a sabbatical (from what we aren't told) to consider whether to enter Christian work full-time, and guess what, Stuart MacLennan, pastor of the First Presbyterian Church of Hollywood, immediately offered her the directorship of Christian Education there. What luck! And what was she doing in Hollywood? Just visiting, you know. She had just driven in from Minneapolis with her sister, as you do when you are offered the directorship of the fastest growing megachurch of the 1920s. She increased attendance to 4,200 a week and the Sunday school grew from 400 to 6,500 in just a few years, though we aren't told how. We are told she had no money, her family losing it all in the Panic of 1893. Right.

At any rate, I encourage you to see the parallels here to TPUSA and the <u>Charlie Kirk fake</u> <u>assassination</u>, which was also manufactured to create schism and which also concerns the infiltration of

Christianity by these cloaked families and the CIA/Intel.

I took you down this little rabbit hole to remind you what a huge clue it is to find Bethany Magee's father working for Campus Crusade for Christ. It really couldn't be any worse unless we found him working at Langley. And notice he also worked for them in Asia, meaning he was some sort of "missionary". It is known these missionaries are often spies. I have no proof he is a spy or spook, but the markers are there and you will have to read them as you will. Finding him involved in this event is proof enough for me.

Bethany's mother Emily Magee is apparently nee Hartsock, since she is related in the first position to Anita Hartsock, 52, wife of Scott Hartsock. So Anita may be her sister. Anita is from Silver Spring, MD, and Washington, DC, which is another possible red flag, Silver Spring being a common address of agents. Scott also has Alexandria, VA, on his list. You can research these people more if you like.

But let's move over to Lawrence Reed, 50, the black guy. We are told he had 72 prior arrests, pleading guilty to at least nine felonies over the years. Pretty difficult to believe. They admit he spent time in jail only twice, for a total of 2.5 years.

According to court records viewed by the outlet, Reed was released with an electronic ankle monitor in August after knocking a social worker out cold at a psychiatric hospital where he had been committed. He left her with "likely optic nerve damage and a concussion, causing her to experience memory issues, headaches, and daily nausea," a detention petition viewed by the outlet read. Prosecutors asked that Reed remain locked up, but a judge overruled them.

Again, that makes no sense, since these private jails for profit are always in need of more prisoners. It is how they get your taxes, you know. So the stories don't add up. One year you get a lot of stories about people getting ridiculously long sentences to fill these jails, with Europeans shocked at how many people are in jail in the US, etc., but the next year you get a lot of stories about judges releasing all these violent and insane people on purpose, just to be clever. Zero continuity.

We are told Reed is facing federal terrorism charges. Why? The story is that he is a crazy man who likes to set young white girls on fire for no reason: how is that terrorism? Looks like attempted murder to me, so why not charge him with the right thing? Just to keep you confused, of course. They can't have anything making sense, because then you might wake up from your stupor.

"I'm not aware of him ever being declared mentally incompetent in connection with any of the other extensive criminal history," he [US attorney Andrew Boutros] added.

Really? The guy who they just admitted had been committed to a psychiatric hospital, where he nearly killed a social worker? How do you commit someone to a psychiatric hospital without finding him mentally incompetent? Again, no continuity with these stories. They are written by a retarded AI, which can't remember what it said in the previous sentence.

Reed was arrested on Tuesday and appeared in court on Wednesday – local newspapers reported that he was disruptive, shouting over the judge, insisting he wanted to represent himself and claiming he was a Chinese citizen. At one point, Reed repeatedly yelled, "I plead guilty!" as the judge attempted to advise him of his rights.

What's wrong there? Anyone? Has anyone out there watched Perry Mason or the Paper Chase or CSI

or Law and Order? The judge doesn't read him his Miranda rights, the cop who arrests him does that, when he is taken into custody. When he appears in court, he should already have been assigned an attorney, who would advise him to remain silent again: the judge would not and could not do it. In fact, if he hadn't been advised of his rights before appearing in court, they already have a serious problem. And again, I would think his actions there would indicate mental incompetence, as they were meant to—though I would say he is overacting just a bit, as these guys like to do.

Because he is obviously crazy at sight, even the reading of Miranda rights becomes a special case. A sane person can decline certain rights, but an insane person cannot. In that case the police and courts have to assume all rights *for* him. Because he cannot rationally decide anything, he cannot rationally decide to decline having a lawyer present, etc.

We are told the female judge "was forced" to release Reed in August because the attack on the social worker was a misdemeanor.

Under Illinois' Pretrial Fairness Act, judges can't hold a defendant in jail unless they are charged with a felony and meet a slew of other criteria, including having a criminal history, posing a risk of endangering the community or being a flight risk.

But they admit he DID meet all those criteria, since the charge was upgraded to a felony:

The charge against Reed for the assault on the social worker was upgraded to felony aggravated battery less than a month later, on Sept. 17. He pleaded not guilty.

Again, no continuity. If they had him in court at that time on a felony, and they did for his plea, then the judge again had to decide on his release. That should have been updated as well, and if this had been real he should have not been released. But the article glosses over that, hoping you don't notice that big contradiction. In my opinion, that proves this whole story is fake. They are just making this crap up, as usual, and if that court exists at all it is just another CIA dummy court, of the kind we have seen over and over.

I did a search on this Lawrence Reed, and he actually comes from Evergreen Park, which you wouldn't expect. It is a fairly wealthy area of Chicago, with a median family income of about \$100,000! His sister or mother Lakesha Reed has been scrubbed at Instantcheckmate. How do I know? Because when you do in-page searches on certain terms, you get results but they don't show up. The result bar says the word is on the page, but it no longer is. It has been scrubbed. I have seen this many times before, and it tells me the spooks have been there recently. The computer knows the word was on the page recently, but it can't put it in yellow for you because it is hidden. Looks like it may be his daughter, because I found a Lakesha, 28, related to Lawrence, 50, at Radaris. He is Lawrence B. Reed, with lots of relatives listed:

I clicked on Mark William Reed, who takes us to Audrey, Larry, Latoya, etc., and they have many full addresses, which I will not republish, though I could without doxxing anyone. They are public records, so you can go there yourself if you wish. I looked up a bunch of them up on Google Maps, and they are not in the projects. Most appear middle class and some are even better than that.



That's one example. Better than where I live. His sister or cousin Latoya is listed at LinkedIN. She graduated from Indiana University and works for the Social Security Admin. Another relative Tyrone Reed is a graduate in computer science from University of West Florida. So if you thought this guy was from a bad family who just left him on the streets, well you would be wrong. He appears to be from a very good family, though they want you to think otherwise.

FastPeopleSearch was good to us last time, so let's try that again. They tell us Lawrence Reed, 50, is now living at Southwest Nephrology in Evergreen Park. Is that a home for the insane? No, because nephrology is study of the kidneys. Plus, that Southwest Nephrology in Evergreen Park returns a 404 error "page can't be found". So something is wrong there. Another recent address is 1007 State Street, which doesn't exist. It is an empty storefront next to OrangeTheory Fitness. Another address is a nice little house on S. May St, Chicago. Another address is a StorageMart across from the park on S. Cottage Grove Ave. Another is a condemned and empty building at 222 W. 75th St. Tellingly, none of these addresses is of a mental institution where a social worker would be working. Once again indicating this is all a fake.

So this fake event is doing double or triple duty, as usual. Not only is it being used to drive the race war ahead, it is being used as part of the Men-are-Pigs project and the project to federalize all law

enforcement in Chicago, and elsewhere.
