

The Ahmaud Arbery Murder Was Faked

This newest fake “hate crime” was allegedly perpetrated this past February. I had heard nothing of it till today, while searching for the latest propaganda on the Corona hoax from my local spook mouthpiece, Minnesota Public Radio. The Corona project is obviously winding down enough to insert this newest fake into the news cycle for the brain-washed masses to focus on, now that the previous one is finally beginning to have run its course. This most recent hoax is a continuation of the [Charleston](#) and [Trayvon Martin](#) shootings, and the [Charlottesville](#) fake race divisions project. Let’s take a look at what the mainstream has to offer us on this latest conjob.

The story is this poor black man was minding his own business, jogging, when suddenly two white rednecks decided to kill him for burgling a nearby home. As you do on a slow afternoon in the South. Interestingly, no charges were filed until just a few days ago, when the video of this incident was released. Here is the [video](#) of this preposterous fake. I encourage you to take the link to see it for yourself. I feel I shouldn’t even have to comment on how ridiculous this staged hackjob is, but if you got blasted with a shotgun several times at such close range, it would do some serious damage, with blood and guts exploding everywhere, and the man would have been blown back and fallen dead or incapacitated right where he stood. This is obviously not what happened.

Miles: So let me see if I have this straight. A black guy burgles a house in a rich white neighborhood by himself, while in gay jogging togs, then runs off down the street with a camera crew in tow. He sees a white pickup parked in the middle of the street with a white guy standing in the back with visible guns, so he runs *toward* it? Wiki tells us the

men in the truck were pursuing Arbery, but from the video it looks like he was pursuing *them*.

Plus, who murders an innocent black jogger on purpose and films it? They thought it was a good idea to supply video evidence to their prosecution? Or are we supposed to believe there was an unconnected car following close behind, and no one noticed? Maybe it had camo paint and so was invisible? Its engine also couldn't be heard, I guess. It was on stealth. It stops only about 15 feet back of the pickup, but no one looked around to see if there were witnesses? The guys never once look back. Also, why is the video cropped? If this is genuine video, why crop it? And why do those filming it keep panning away? They saw a pretty squirrel?

So what about the supposed victim, Ahmaud Arbery? According to Intelius, he is related to a Jasmine Arbery, same age, 26, who has worked at Albany State University and **Liberty House**, both of Albany, GA. Liberty House is a **domestic violence** association. In other words, possible intelligence front. These people are related to a Marcus Arbery, age 28. But if we switch over to Instantcheckmate we find the same Marcus C. Arbery as well as another Marcus C. Arbery, 56, aka Marcus A. Arbery related to an Evon Abeary, Charley Abrey, Paulette Arbery, Kennely Cummings and Diane Jackson. Hmm. If we take some of those names back to Intelius, we find an Evon Abeary, no info, Charley Abrey doesn't exist, and one Paulette Arbery, 46, from Brunswick, GA, as well as another Paulette M. Arbery, 67, also from Brunswick, GA. Looks like some funny business going on here.

Miles: are Jasmine and Ahmaud supposed to be twins? If they are siblings, how could they be the same age? Looks like Paulette may be the mother, so why is she scrubbed from her children's Intelius lists? And why is Marcus, apparently the oldest sibling, going to a community college (Feather River College) in Quincy, CA? Normally if you are so poor your brother is burgling houses in his jogging togs, you go to local community colleges, not ones all the way across the country. Besides, it is out in the middle of nowhere. The college is by far the biggest thing there, but the town's Wiki page doesn't even mention it. Whatever the case may be, it isn't the kind of place impoverished blacks who are robbing houses go.



The 2020 out-of-state costs *after receiving financial aid* for this community college are \$22,300, which makes it one of the priciest 2-year colleges in the nation.

And here's something superweird. Let's go back to Liberty House, where Ahmaud's sister Jasmine works. If we check their Board of Directors, we find a Kevin Casey listed, Marine Corps Logistics Base, CID Chief. Also Tiffany Stewart Crittenden, Marine Corps Logistics Base, Senior Logistics Analyst. Since Liberty House is supposed to be a domestic violence shelter, I am not clear on what that has to do with the Marines, especially the Criminal Investigation Division. I can see why the Marines might get involved if their soldiers are involved in domestic violence in Albany, but I don't understand why the base CID Chief and Senior Logistics Analyst need to be on the Board of Directors of Liberty House. But it does give us a possible military link to our current hoax.

I checked IMDB for Ahmaud. He isn't there, but there are four Arberys listed. They all appear to be white, but there may be some connection. We can be sure Ahmaud is an actor, though he may just be a military actor. It is also a clue that his name is Ahmaud and that several of his connections also have Muslim names: he is probably connected to Nation of Islam, which is another Intel project, also created to promote race wars. Think Ahmad Rashad, born Robert Earl Moore, a protege of Rashad Khalifa. Khalifa had been a chemist for UNIDO (United Nations) before he became a self-proclaimed messenger of God. He wrote a book in 1981 which claimed God was talking to him through a computer. In it, he claimed the Quran was incorruptible because it was based on the number 19. Khalifa was fake-assassinated in 1990, and two men were separately convicted for killing him. One of them was allegedly part of Jamaat ul-Fuqraa, a fake Muslim group that fake-killed Ahmadiyya leader Muzaffar Ahmad in 1983. This is amusing since another Muzaffar Ahmad who was *also* involved with Ahmadiyya was also almost assassinated. But this second Ahmad ended up being Vice President of the World Bank. Such a small world, eh?

The town where this event took place is Brunswick, GA, a small community on the Atlantic coast. This city is home to the **Federal Law Enforcement Training Center**. This huge, sprawling compound is part of the **US Department of Homeland Security**. If Intelligence wanted to pull off a murder hoax, this would be an extremely convenient place to do it. Also remember that Brunswick is the location of Jekyll Island, so it is a very spooky place. The Club is still there, surrounded by 33 buildings. The *Walking Dead* has been filmed there, which I would say is *apropos*. There are no blacks or hispanics living on Jekyll Island, so I guess the Arberys don't live there.

The [piece](#) from Minnesota Public Radio contains some very juicy nuggets. It reports that some folks are running (in socially responsible distanced groups, I'm sure) 2.23 miles to honor the deceased, including both the mayors of Minneapolis and St. Paul. The number is said to signify the date of the alleged slaying, Feb. 23. Miles: I wonder what that is backward? Could it be... 322? As in *Skull and Bones*, the Brotherhood of Death. Some pretty interesting folks are interviewed as part of this piece. Let's take a look at them. First we meet a couple named Sha Cage and E. G. Bailey. Cage has this to say about the whole thing:

It can be very comfortable sitting in your house and the safety and security of it. But what happens when you put on your shoes, put on your tights and start jogging around, you sort of imagine what that scenario is, and it's incredibly frightening.

Incredibly frightening indeed. I'm sure this Cage is just a random person participating in this community building event, meant to bring us all together, in a time of racial tensions. So, let's check and see if we can dig anything up on her. Well, we find out she worked at one point for an organization called Intermedia Arts. This group was a multi-purpose arts venue in Minneapolis that was popular with poets, painters, actors dancers and **activists**. So we know what's going on there: Modern Art and activism (see Miles' [exposé](#) on Frances Stonor Saunders and the CIA's role in the propagation of Modern Art), or in other words, Intel operations disguised as *culture*. As more evidence of this, a recent program held at the center was called "*Up & Out: A Showcase for Transgender and Queer Young People*". Ensnare them while they're young, confused and impressionable. In 2017 Intermedia allegedly went bankrupt, which is good to see. But it is also curious. We are told they overspent their \$1.4 million budget, but that never stops these people. They exist to overspend their budgets.

According to Intelius, Cage attended Neal F. Simeon Vocational High School, in the south-side of Chicago. This place has "spook-feeder" written all over it. The school is well known for one Ben "Benji" Wilson (as well as many other NBA and NFL players over the years), a star basketball player, thought to be the "*best basketball player in the world*" at the time, who was tragically shot and killed just before the start of his senior season there. Man, this story sounds all too familiar. Could it be this event was faked as well? I don't have time to fully unwind it here, but I will take a short diversion to cover a couple things. Firstly, as we have seen, the NBA is rife with spook activity (see Lebron James [Surprise, he is now in on this Ahmaud Arbery act!], Kobe Bryant, Michael Jordan, Shaquille O'Neill, Jason Collins, who was promoting the [fake](#) Matthew Shepard murder, etc.). A movie was made about this incident in 2012, entitled *Benji: The True Story of a Dream Cut Short*. Intelligence loves to refer to its own previous fakes in newer projects, so I would consider this a red flag just on its own. The film was directed by Coodie and Chike. Coodie, real name Clarence Simmons, Jr. (any relation to Russell Simmons?), was also born and raised in Chicago. No information is available for him on Geni. He attended Northern Illinois University but was kicked out after a a year for academic and behavioral issues. Nice. Chike Ozah is from New Orleans. Nothing on Geni for him either. He attended Rhode Island School of Design, or RISD. This is a big spook school boasting such alumni as Shepard Fairey (see Miles' [exposé](#) on him), Seth MacFarlane, Heather Henson (daughter of spook Jim Henson), Gus Van Sant, actors Martin Mull and James Franco, as well as spook bands Black Dice, Lightning Bolts and Talkingheads. These two jokers have been involved with Kanye West and Lupe Fiasco, Fiasco being another rapper. Lupe Fiasco has been involved with Jay-Z (also most recently involved [promoting](#) this event) and Prolyfic, another Neal F. Simeon grad. Small world, huh? Fiasco's father was a member of the **Black Panthers**. See Miles' [takedown](#) of that fake spook organization. So anyway, we know what we are dealing with here.

Oh, one more thing before we move on, another person interviewed by MPR in the aforementioned article, Anthony Robinson, obviously a plant, says he thinks that "every person of color who runs has had an experience of discrimination or racial profiling running through a neighborhood they 'don't belong in'". Really? He also claims

Today is just for me to get out, run my 2.23 and reflect on what it means to be a person of color in this country, in this time and place. Which is, quite frankly, a bit unnerving," he said. "It's scary to think that I can feel safer running on an empty street in some other country in the dead of

night, versus running in broad daylight in certain parts of America where I could lose my life.”

Obviously another randomly selected runner sharing his thoughts on this memorial run promoted by Facebook, Change.org, et al. Oh, by the way, I checked Intelius for Anthony Robinson from Minneapolis and I found one, aged 45, which looks to match the age of the guy in the photograph of the article, and lo and behold, he worked at **General Dynamics Corporation**. And there you have it.

A friend of Arbery, Akeem Baker, supposedly started the #Irunwithmaud meme, highlighted in the MPR piece above. An article featuring the story of Baker and Arbery’s friendship, run by the *New York Times*, details some aspects of the adolescent life of Baker and Arbery. This [article](#) is blatant, transparent propaganda and reads like bad fiction. The author is credited as Richard Fausset (think Farrah Fawcett, of the peerage Fawcetts, who IS listed in the peerage*). This guy has spook credits upon spook credits. According to this [blurb](#), he writes about the American South, and focuses on “politics, culture, race, poverty and criminal justice”. He also covered the fake **Charleston shooting**, handled in-depth coverage of **El Chapo** in a series from 2014, and wrote extensively about “working-class voters in the run-up to the (fake) 2016 presidential elections”, something to do with black folks being pressured or bullied into voting a certain way. But if the powers that be were worried about how people were voting they wouldn’t be [stealing elections outright](#), so this is obviously more misdirection from Intelligence. So in other words this guy is pushing projects straight out of Langley. Check out this [page](#) where we get a picture of him. According to Intelius, this guy is 50 years old. I guess he drinks a lot of cranberry juice. Interestingly, there is another Richard Faussett (this guy spells his last name with two T’s) who also worked for the *New York Times*, Richard Grant Faussett, 61 years old. Any relation? Who knows.

Anyway this Akeem Baker has some interesting information for us to discover. If we check Intelius for this guy we find two Akeem Bakers, both having lived in Georgia. The one listed to be from Brunswick is listed as being 26 (same age as Arbery) with no other info available. The other is 23 years old, also has no relatives listed, has studied at Morehouse College (as stated in the article), has lived in Boston and has worked at the **Boston University School of Medicine**. Hmm. In that last article above, there is a picture, supposedly of Akeem Baker and Arbery, apparently at a grad party for Rafeal Baker, Jr. They both look to be about graduating age. Instantcheckmate indeed has a Rafeal Baker listed as a relative. So let’s take that name back to Intelius and see what we find. Ok, we have two Rafeal Bakers, one 45 and one **26**. Ok, so we definitely have some funny business going on here. I suspect the younger Rafeal to be the same person as the 26 year old Akeem. This Rafeal has worked at the **National Institutes of Health**. Which of course takes us back to the corona hoax.

The two alleged perpetrators of this murder are a father-son duo, Gregory and Travis McMichael. They have since been arrested. Supposedly Gregory, the elder McMichael, was a 20-year former investigator for the local **District Attorney’s office**. He had also worked for the Glynn County Police. I guess that is why it was originally reported that police did it. [We now know that the Glynn County Police Department was advised by the District Attorney’s Office to make no arrests.](#) That of course indicates an ordered stand-down from above. The fact that McMichael worked for both entities is conclusive evidence this event was faked. You will be sold the idea that that is because whites don’t

care about the murders of blacks in Georgia, but that is not the way to read this. The way to read it is that this was a manufactured event, and local police are being told to stand down by higher authorities. We see more evidence of that when we are told that a local attorney gave the video to WGIG, which put it on its website. That also makes no sense, since the video should have been seized as evidence when the Bryants in the following car were arrested as accessories to the murder. The “local attorney” should have been arrested as well, for interfering with an investigation. By law, he would have been required to turn over the tape to the police, or face charges for obstruction of justice. Somehow none of that is ever mentioned.

No charges were filed for 74 days on purpose, you see. That was part of the plan, since it played into the racial profiling/blacks don't matter angle. That is precisely why local police were told to stand down.

And what was the burglary or “string of burglaries” Arbery was suspected of? McMichael reported a gun stolen *weeks earlier* from an unlocked vehicle, but no suspect was seen, black, white, or otherwise. So there was actually no evidence of any crime by anyone, and McMichael could have easily made the whole thing up as part of this event.

District Attorney George Barnhill has already been caught lying in the case, since he claimed Arbery was on surveillance video right before the incident burglarizing a home under construction. But the owner of that home contradicted that claim, saying he had never had anything stolen from the site. Of course this is being used to prove that authorities in Georgia conspire to cover up the murders of blacks, but I see it a different way: it is proof the whole event was manufactured, and Barnhill is doing his part to manufacture it. The most likely reading of the evidence is that the actor Arbery was using the empty house as ground zero of the staging area, while waiting for other actors to get on their marks. Wikipedia is already confirming that with numerology, when it tells us 911 calls were made reporting Arbery in the house at . . . 1:08pm. Aces and eight, Chai.

All this is interesting for another reason: McMichael having been with the DA's Office gave the DA for Glynn Co., Jackie Johnson, the opportunity to recuse herself from the case. Convenient. Enter Tom Durden, prosecuting attorney, or DA, pro tempore (any relation to Tyler Durden?). Actually, as this situation develops, more information is continually being released even as I write this. Now the prosecutors' case has changed hands again. [I now find that before Durden, the case was handed to a George Barnhill, but he wound up recusing himself because his son also worked for the District Attorney's office.] Now the prosecuting attorney is Joyette M. Holmes, a black woman who has worked for the **National Black Prosecutors' Association** and the State of Maryland. She has a lengthy resumé, including having studied at the University of Georgia, Southern Illinois University, University of Maryland and **George Washington University**. I think the case should now be in sufficiently capable hands.

[Some more new [information](#) has now been released. This is from the *Honolulu Star Advertiser*. We now have an “autopsy” report! According to the report, Arbery was hit by three shotgun blasts, one of which grazed his wrist, the **other two struck his chest**. This is not confirmed by the video we just saw, where only one patch of blood may be seen to one side of his torso. Shotgun blasts from point blank range would cause far more damage than that. The white shirt should be shredded, for a start. But all we saw was a small dark patch on one oblique.

We now also find that the **Southern Poverty Law Center** has become involved, demanding **hate crime** charges be filed, sinking another nail into this coffin. State Attorney General Chris Carr is requesting Federal authorities investigate how local police and prosecutors handled the case, ensuring this fracas will drag out for many months, occupying the time and minds of the citizens that will have been freed up after the coronahoax has left the collective consciousness of the general public, and while the [present heist](#) continues in full force]
