

They're ALL Ghost Companies

Before we get to the main topic, I have a story for you as a lead-in, which tells you again why I so hate the Modern world and the creeps that created it. A good reader from my physics site who lives in Sacramento suggested we take a trip down to Yosemite last week, and we did. He was talking about just a day trip, but I suggested we rent a little cabin for the night, so that we didn't have make both drives in the same day. I loathe driving. In my vivid imagination, the outskirts of Yosemite would be dotted with cute little affordable cabins, to accommodate the crowds. And being that it was still May, before school let out, I figured we wouldn't even need reservations, as long as we weren't too picky. Which we aren't.

I know, you are already laughing in my face at that word "affordable". How could I be so naive in 2026? Well, it is because I am remembering a time not so long ago when this was still possible. The mistiest watercolor memories are from the 1970s and 80s, when we would go to Colorado for the summer, never with any reservations, pull over in the late afternoon at the cutest cabins you have ever seen in a mountain idyll, and pay something like \$30 for the whole family. When I moved to New Mexico in 2007 I stayed at the Adobe Wall in Taos while looking for a house to rent, and paid \$50/night. But even just a decade ago I remember finding a similar thing in Lake City, CO, when Bonnie and I drove up there on a whim to get away from some forest fires in NM. A glorious little cabin at the foot of the mountain at 9000 ft, for about \$80/night for the both of us. Clean sheets and a little kitchen, all you need in the mountains. But that was not to be found in the great state of California last week. Inside the park, you could camp in a tent or pay \$1000/night at the lodge, paying \$16 for a beer. We saw some cabins nearby, but they clearly hadn't been open in years. They were overgrown and flaking paint. I suggested we squat in one of them anyway, but my older friend wasn't up for that. He isn't the scofflaw I am. So we asked around, being told that the cheaper accommodation was outside the park. So we made the long drive out, only to find that this cheaper accommodation was a double for \$500. At that point we gave up and drove back home, arriving after midnight.

I still don't understand how there can't be any cabins for rent on the outskirts of Yosemite. It makes no sense. You would expect there to be dozens of little lodges. My guess is one of two things: either the people who own the big hotels bought up all the cabins and tore them down; or California killed all the mom and pops due to over-regulation and Covid rules. But if it had anything to do with Covid, you would expect the cabins to still be there, just abandoned. That wasn't the case except for those inside the park. As for the first scenario, we know these rich people do that, but it can't be because they believe the cabin people are going to pay \$500/night. They won't because they can't. So it must be a bigger Phoenician scheme to punish the middle class and ultimately wipe us out. For now they want us to just stay home and out of their way, but in the long term they want us all dead. The New World Order and future isn't for the middle class, it is only for the very wealthy and their slave and robots. If it were up to people like Trump, he would no doubt bomb Yosemite and turn it into a New Riviera of golf courses and high-end malls.

By ghost companies I mean pretend companies, that either have no real product or that may have a photographable product, but it doesn't do anything you are told it does.

I got into this by going to the Wikipedia page for Palantir, which makes it very easy. Like me, you may have thought Palantir was a company worth billions, producing super high-tech products. With Peter Thiel as the “genius” behind it, it would have to be, right? Not really. Did you know that for the first twenty years of its existence, **it made no profit**, and actually survived only by being propped up by the Department of Defense with your taxdollars. Like almost everything else these days. Although we are told it was valued at \$20 billion by 2016, it didn't make any profit until 2023, when it made a few million. So what was that valuation based on? Nobody knows. The computer made it up. In 2025 they reported \$1.4 billion for operating income—which still isn't much for a company supposedly supporting a guy worth \$30 billion and all his pals—but almost all of that still comes from the treasury, meaning your taxdollars, since Palantir's main clients are DoD and Intelligence. Since we know a large part of the defense budget is mist (remember the \$500 toilet seats and things like that), shouldn't we ask if Palantir is just another gigantic fog? Well, yes we should, since its section on “products” at Wikipedia begs that question in every line.

The company has four main operating systems: Gotham, Foundry, Apollo, and AIP. Gotham is an intelligence tool used by militaries and counter-terrorism analysts, including the United States Intelligence Community and United States Department of Defense. Among other things, the software supports alerts, geospatial analysis, and prediction. Gotham has also been used as a predictive policing system, which has elicited some controversy over racism in their AI analytics.[94]

Gotham is Palantir's main service, but that's all they tell us about it. Nothing. It supports alerts, analysis, and prediction? Yeah, so does a file cabinet, a rolodex, and binoculars. What major crimes has Gotham predicted? None. Or no real ones of course, but lots of fake ones like the ones FBI and CIA manufacture to scare you. They also helped predict the Covid thing, but again, that wasn't hard since we now know from leaked documents the whole thing was planned years in advance. Not predicted, *planned and executed*.

Thiel isn't the only one who founded Palantir: there are four other Jews, including of course a **Cohen**,

though three of them were proteges of Thiel at the *Stanford Review*. So here's a question for you: if Thiel is a Christian, why are all his proteges and business partners Jewish?

A gifted rhetorician and provocateur with a bottomless pocketbook, Thiel has drawn upon his wide-ranging and idiosyncratic readings in philosophy, history, economics, anthropology, and culture to become perhaps America's leading public intellectual today, assuming a mantle once held by the likes of Thorstein Veblen or Norman Mailer. The conspicuous difference is that Thiel—a libertarian, gay Christian—espouses views that are far harder to anticipate, and he has earned his pulpit largely through commercial rather than literary or scholarly masterworks.

[That's from a 2014 article](#) at *Fortune* with no byline. You have to laugh. I wonder how much Thiel paid for that? America's leading public intellectual? “Earned” his pulpit? Earned it how? And where can we witness him being a gifted rhetorician? Not in this article. Not in [any interviews I have ever seen](#). He has always come across as the creepiest of one-dimensional creepazoids, and as he has aged he has just gotten creepier.



He makes Elon Musk almost seem human.

And why would *Fortune* mention Veblen and Mailer as previous examples of public intellectuals? Did this anonymous author just draw names out of a hat? Not only do neither one of them have any similarity to Thiel, neither one would be in anyone else's top 100, or top 1000. Mailer, as a public intellectual, was most famous for his shouting matches with Gore Vidal, and no one has heard of Veblen these days. As a critic of capitalism (see his *Theory of the Leisure Class*, 1899), he has been buried with malice. Buried with the same giant shovel that is now trying desperately to bury me.

Thiel was noted as a smart, but lonely, withdrawn boy, with whom others would not mingle because they knew he would not stay long in the town.[33]

Yeah, or maybe there is another reason they didn't wish to hang with him. Go listen to him speak and it may occur to you.

In a 2025 [series of lectures in San Francisco](#), Thiel admitted his core beliefs were modeled on the work

of Carl Schmitt. Thiel is gay and claims to be a libertarian Christian, so this is the craziest thing ever. [Schmitt was a Nazi party](#) “jurist” noted

as a critic of [parliamentary democracy](#), [liberalism](#), and [cosmopolitanism](#).^[5]

That's from his Wiki page. So we are getting two different stories from this master rhetorician. A libertarian who bows to Schmitt. Wow. But we knew Thiel was either lying or a very confused person, since you can't be a libertarian and a big Trump promoter at the same time. Nor do I think that anyone who promotes Trump and comes out of a venture capital career can claim to be a major intellectual. The categories are mutually exclusive. But let's stick with this Schmitt thing, since it is decisive all by itself. That is why I have included it. In case you don't know

Schmitt claimed that urgency justified the following:^[29]

1. **Special [executive powers](#)**

2. **Suspension of the [Rule of Law](#)**

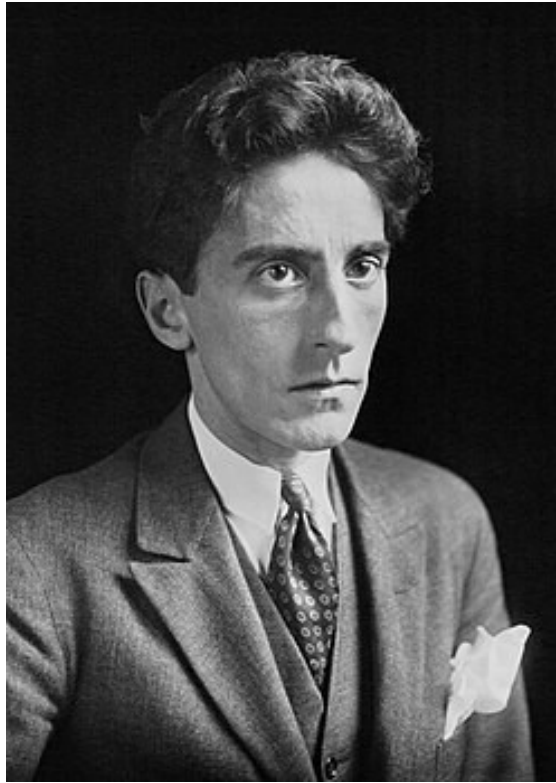
3. **Derogation of legal and [constitutional rights](#)**

Schmitt's doctrine helped clear the way for [Hitler's rise to power](#) by providing the theoretical legal foundation of the [Nazi regime](#).^[29]

So there is Thiel's admitted “libertarian Christian” core right there.

During the [German occupation of Paris](#), a "round-table" of French and German intellectuals met at the [Georges V Hotel](#), including Schmitt, the writers [Ernst Jünger](#), [Paul Morand](#), [Jean Cocteau](#), and [Henry de Montherlant](#), and the publisher [Gaston Gallimard](#).^[47]

Yeah, that figures. There is the “intellectual” group Thiel aspires to. Not only Schmitt, but Morand, who kissed up to Petain like Thiel kisses up to Trump. And of course the gay Jewish Cocteau, who thought Hitler was a pacifist and patron of the arts and called Stalin the “only great politician of the era”.



Which reminds us that Cocteau was a leader of the avant garde, and as you may know the avant garde in 20th century art was later sold as progressive and liberal. They never were. Like Cocteau they were the children of wealthy Jews, ultimately only interested in maintaining their power structures. Modern art was never progressive, it was always wildly *regressive*, since it depended on the exclusive promotion of these talentless pretenders to the exclusion of all real artists. It was the promotion of painters who could not paint, writers who could not write, and thinkers who could not think. This is what caused the Wasteland Thiel often talks of, misdirecting you furiously from its real causes.

But back to Schmitt on the way back to Thiel. Did you know that Schmitt was accused of being a pretend anti-Semite? Oh, [you mean like Hitler, who was actually Jewish himself?](#) Wiki scrubs Schmitt's parents and claims he was a Catholic, but one of his sisters was named [Auguste](#). So he was a Phoenician. I would guess his mother was a Cohen or Hildesheim. We have confirmation of that guess from his two wives, neither of whom were German: Pavla Dorotic and Duska Todorovic. Both Serbian Jews.

Another big influence on Thiel was Irving Kristol, Bill Kristol's father. Kristol funded the *Stanford Review* where Thiel got his start. Kristol died in Falls Church, which gets us started. CIA.

After his death, he was described by [The Daily Telegraph](#) as being "perhaps the most consequential [public intellectual](#) of the latter half of the century".[\[4\]](#)

Hmmm. That again. Just as silly, since Kristol was just another Jewish confounder of the middle classes, being tapped by his people to play the part of a fake Trotskyite in the 1940s, like others we have seen. He wrote for Eliot Cohen at *Commentary* and then went to *Encounter*, both of which have since been outed as CIA fronts. See my papers on the [Stolen Century](#), the [Beats](#), and the [Cultural Cold War](#). Wiki even admits it:

Following [Ramparts'](#) publication of information showing [Central Intelligence Agency](#) funding of the [Congress for Cultural Freedom](#), which was widely reported elsewhere, Kristol left in the late 1960s and became affiliated with the [American Enterprise Institute](#).^[10]

Which of course tells us what to think of the American Enterprise Institute. So it looks like Thiel was funded by the CIA from the crib. As for Kristol:

One of his early books, *Two Cheers for Capitalism*, asserts that [capitalism](#), or more precisely, [bourgeois](#) capitalism, is worthy of two cheers. One cheer because "it works, in a quite simple, material sense" by improving the conditions of people; and a second cheer because it is "congenial to a large measure of personal liberty".

So much for that, eh? Have the conditions of the people in the US been improved since 1970? No, just the opposite. The middle class has been eviscerated, with more and more money moving up the ladder. That is the real function of capitalism: the capitalists take it all, leaving you with bupkis. And that isn't despite the best efforts of people like Kristol, it is *due to* the efforts of people like Kristol and Thiel. Same for the point about personal liberty: it has been demolished in the past 50 years, and was in tatters long before Covid dealt it a death blow. Which is not to say I am a Communist: I have shown you that is a false dichotomy built by these people to make you think those are the only alternatives. If you don't like the rich people stealing everything, you must be a dirty Communist. That's why they invented Communism. Same reason they reanimated Flat Earth: so that they could tar anyone who questioned mainstream science or NASA as a Flat Earther. This is the level of their rhetorics. They know only a few raw feints like this and then tap out.

Jay Bhattacharya also comes out of the *Stanford Review*, so beware of him as well. Despite his pushback against Covid lockdowns, he is not to be trusted. You should have known that as soon as Trump appointed him to anything.

[Like Musk](#), Thiel's early bio makes no sense. He allegedly rose from nowhere to found Paypal, with backing from the banks like Deutschebank, but why would the banks "venture fund" a competitor to them? If they thought it was a good idea, why not do it themselves. It is just a slight variation to online payments, so it is hard to believe it was patentable. I can't figure out why the banks would allow these guys to come in and siphon off a bunch of their profit. It is the same question I have asked about Saudi Arabia: why would the British Empire allow these goatherders in white robes to siphon off trillions of dollars in profits every year? They had no army, so the British could have taken that area overnight at any time. The only possible answer is that the Saudis are just a front, and I come to the same conclusion with Thiel at Paypal. The whole enterprise had to be a feint to make you think the big banks weren't doing this. They wanted you to think it was a private enterprise, not only to make you more likely to try it, but to explain the rise of Peter Thiel. It was this Paypal springboard that explained the illustrious start of Palantir in 2003.

Thiel admits Palantir was created to combat the new terrorist world after 911. Which of course means it was all part of that vaudeville, manufactured by Cheney, Rumsfeld, DHS, and all the rest. The manufactured rise of terrorism and the concomitant rise of the security state. Or, as it has been called many times before me, [security theater](#). The DoD, Intel, and DHS needed many more new money pits, and voila, Palantir pops up on cue with a whole list of pretend products nobody needs or wants, but that the government is itching to buy in your name with your money because, well because that's what they do. New Osama bin Ladens are rising up in the mists, new Ted Bundys are hatching in the suburbs, and if they aren't it doesn't matter because FBI and CIA and DHS can create them regardless, as they

always have. And you will fall for it because, well because you always have. You just can't help yourself. It is on the screen, so how can you not believe it? Peter Thiel and his Jewish gaypals swear to you it is true, and *Fortune* said they were all geniuses, so who are you to say no? *Fortune*, founded by CIA agent Henry Luce*, they wouldn't lie to you, right?

More recently Thiel made the news for giving lectures on the Antichrist. But if you listen closely, you can see this is all upside down as well. What these people fear—and they really do seem to fear it—is not the rise of an Antichrist, but a second coming of Christ himself, or a similar figure. Someone who will arise and throw them down. Yes, what the fake Christian Thiel fears most is Christ, or the Christ message, which is anti-rich, anti-tech, and anti-control. I remind you of the camel walking through the eye of a needle being more likely than the rich man getting into heaven. Or Jesus turning over the moneychangers tables. A venture capitalist and his Jewish buddies can't like that story. Or the story of the fowls of the air, who neither sow nor reap, but the Lord takes care of them. So clearly it isn't the Antichrist he fears, it is the Christ. And Thiel confirms that, defining his Antichrist as a misguided altruist or Neo-Luddite or wild crusading Amishman who wants to limit technology to combat the New World Order Mordor—so basically the same thing the Pharisees said about Jesus. Thiel pretends to condemn the New World Order, continuing to claim to be a libertarian, but he says this Luddite response is even worse, since it sparks Armageddon or End Times or something. Conveniently this lecture blackwashes his opposition and sells rich guys like him as saviors. Who could have seen it coming? I guess this is an example of his vaunted skills as a rhetorician.

So is Thiel right to be scared? Yes, but not of a new Christ or Antichrist. The revolution isn't in an external future, it is eternal and ongoing, with Nature bringing down the Phoenicians one by one, from within, for foolishly daring to ignore her. It is not some upcoming superman that is Thiel's doom. Thiel's thoughts and actions are their own doom. It is the mirror that is destroying him, as it does with them all.

That's the main place Veblen was wrong: he argued that in economics the individual was not important, what was important were the greater movements of culture and the modes of human interaction that caused them. Another reason economics is beside the point, and another reason I have always ignored it. In a society defined by the con and the steal and the lie, there is no economics. There are no forces at work other than those, so all economics is a cover story. But my point here was that Veblen was wrong in a far greater sense, because—as Jesus correctly taught—all the important things go on at the individual spiritual level, with the world as only a backdrop. Economies and cultures come and go, but they aren't important because they are abstractions. They are important only insofar as they impede enlightenment or support it. The current culture strongly impedes it, which makes it a problem to be solved. You aren't an ant in a hill, a statistic, or a predestined automaton. You are an eternal manifestation of spirit, currently matter ensouled, and what you do matters. And spirit is not wuwu, it [is real photons, as physical and material as anything else](#).† But the Phoenicians long ago arrayed themselves against that fact, because it did not suit their schemes of profit. To collect their wealth, they had to treat all other objects—people, animals, trees, and the very Earth herself—as empty shells and tokens, to be traded and consumed and tossed aside. For them everything was a commodity, even their own wives and children, and nothing was ensouled. Nothing was alive, everything dead, both before and after death, including themselves. So you can see why they would age poorly. You could see why these people say the strange things they do. You can see why they are cursed: they have cursed themselves with their own unnatural beliefs.

But back to Palantir:

Palantir Foundry is a software platform offered for use in commercial and civil government sectors. Foundry gained prominence in healthcare through deployment in the National COVID Cohort Collaborative, a federated network of electronic health records. Research using this platform generated extensive peer-reviewed publications and won the NIH/FASEB Dataworks Grand Prize. NHS England also used Foundry in dealing with the COVID-19 pandemic to analyze the operation of the vaccination program.[95]

That just proves my point, since they admit Palantir *generated* peer-reviewed publications. You may read that as “the platform was used by scientists to publish their research”, but that isn't what it says. It looks to me like they are admitting all that research was faked, reviewed, and published by AI—which would explain why it is such a garbled mess, contrary to all previous science and medicine. You will say I am making it up, but we have seen many reports in the mainstream in the past two years admitting all sectors of “science” are being flooded with fake AI research, either created *in toto* by computers or created in collaboration with humans, the humans mainly acting as fronts for the computers.

And that analysis of the vaccination program didn't really pan out, did it? Both the computer and human analysis of the vaccination program was bought out by Big Pharma, which is still telling us it is safe and effective, as people continue to drop dead by the millions all over the world. Foundry and other systems didn't analyze data, they scrubbed it. Many caught them doing it with VAERS, including me: huge numbers of reported deaths were simply jettisoned from the system overnight, with the excuse that they were unverifiable. But none of the data in VAERS was verified, though it was always verifiable: meaning, they could attempt to verify it, *but they didn't*. VAERS wasn't created to collect “verified” data anyway, it was created to collect raw reports. To verify it would require calling all those who reported to verify it. So all this talk of verification was just a smokescreen. In the end, they just erased large parts of the data that didn't fit their narrative. As is usual with mainstream “science”. I know because [we have seen Air Force erase 75% of sunspots since 2020](#), to try to fit their predictions and foil mine. This is what mainstream entities do. Business as usual.

But the full joke is that they didn't need Palantir to do that. Everything was fully automated before Palantir ever arrived, so the government was fully capable of faking, fudging, or jettisoning data before they came along. They were capable of it before the first computer was built: you don't need computers for this, document shredders or bonfires work just as well.

In April 2023, the company launched Artificial Intelligence Platform (AIP), which integrates large language models into privately operated networks. The company demonstrated its use in war, where a military operator could deploy operations and receive responses via an AI chatbot.[103][104]

More mist, like everything to do with LLMs. Instead of you using the computer to run a search, which you can then scan for yourself, the computer runs the search in the dark, pushing a promoted result on you even more brazenly than the search already was. It then speaks to you in your favorite chosen voice, to further hypnotize and massage you into accepting that result. That isn't progress, except in the matter of force-feeding the world propaganda. The search engines were already compromised before the LLMs arrived, and you should have been going back, not forward. You should have been returning to the card catalog at the library, doing your own physical search, then reading the books and deciding for yourself.

And again, other than the pretty voice interface, there is absolutely nothing new about any of that, nothing would justify the sales pitches or the data centers or all the money being thrown at this. It is

just an abbreviated search in the dark, with 1-4 results instead of thousands, the computer making all your choices for you by following pre-programmed routes and responses. It could have done that 30 years ago except that they thought you wanted to maintain some autonomy. Covid cured them of that misconception, as a majority of people gave up all autonomy with glee.

But back to the claim using a chatbot will help military operations. Do you really think AI is going to help in a war? AI, which we must assume has been fed all of Caesar's fake battles and [Napoleon's fake battles](#), and the [fake battles of the Pacific Theater](#), and the [fake attack on Pearl Harbor](#), and so on. Any AI that had been trained on mainstream history and science would be as stupid and confused as the rest of us, having no idea how to deal with any reality, military or not. Which is exactly what we see from the chatbots, which can't make heads or tails of us and our world. To them it just looks like a constant bluff, so that is all they know. Every answer from AI is an authoritative bluff. You can't blame them for thinking human existence is just one long bluff and con.

AIP lets users create LLMs called "agents" through a [graphical user interface](#).

That's a bit revelatory, isn't it?

Palantir's TITAN (Tactical Intelligence Targeting Access Node) is a mobile command vehicle equipped with AI and analytics software for military field intelligence operations. Developed with IRAD funding in partnership with Anduril Industries and Northrop Grumman, TITAN integrates intelligence and targeting data to support tactical decision-making. The company claims that TITAN can improve customers' ability to conduct long-range precision strikes. [111] Palantir is under contract to deliver 10 units to the U.S. Army.[112]

I guess they used that to triple tap the 180 schoolgirls in Iran. Good job, TITAN!

Which takes us to Anduril. Tolkien is turning over in his grave. Anduril was founded in 2017 by Palmer Freeman Luckey, who was 24 at the time:



That's where your military taxdollars are going. Freeman is a Jewish name, from Friedmann, and Palmer is a transported surname as well, no doubt linking him to that prominent family. He's the brother-in-law of Matt Gaetz, meaning Gaetz married his sister Ginger. That looks to many like a beard marriage, of the sort we are about to see with Taylor Swift, since [Luckey's other sister Roxanne has blown its cover](#), calling Gaetz weird and creepy and “a literal pedophile”.

Although Palmer majored in **journalism** at CSU Long Beach, and did not graduate, we are told he was building virtual reality headsets at age 16, in 2009, funding this by working as a groundskeeper (like Bill Murray in *Caddyshack* I guess). Palmer claims to come from nowhere, his parents not given in any bios, but I would assume he is closely related to Andrew Luckey the TV producer, since they are both from Socal. These Luckeys come from the [Ives, Noels, Funderburks and Bacons](#), meaning, yep, they are Phoenicians. Through the Funderburks they come from [Princess Elizabeth Wilhelm von der Berg](#). Funderburk=Vonderberg. Her father was Duke Phillip Wilhelm of Prussia. Her mother-in-law was Catharina **Berghman**. Jewish.

Among the many problems with Palmer Luckey's early bio, the greatest is that virtual reality headsets had been around since the 1980s, so we have to wonder why this guy, coming out of nowhere, got such promotion starting in 2012, when he was just 19. Two years later his VR was bought by Facebook for \$2 billion, telling us that Luckey's rise [was much like that Musk](#): manufactured to explain where the money was coming from, when it wasn't coming from there it all. It was coming from the treasury in the form of . . . that's right, **your taxdollars**.

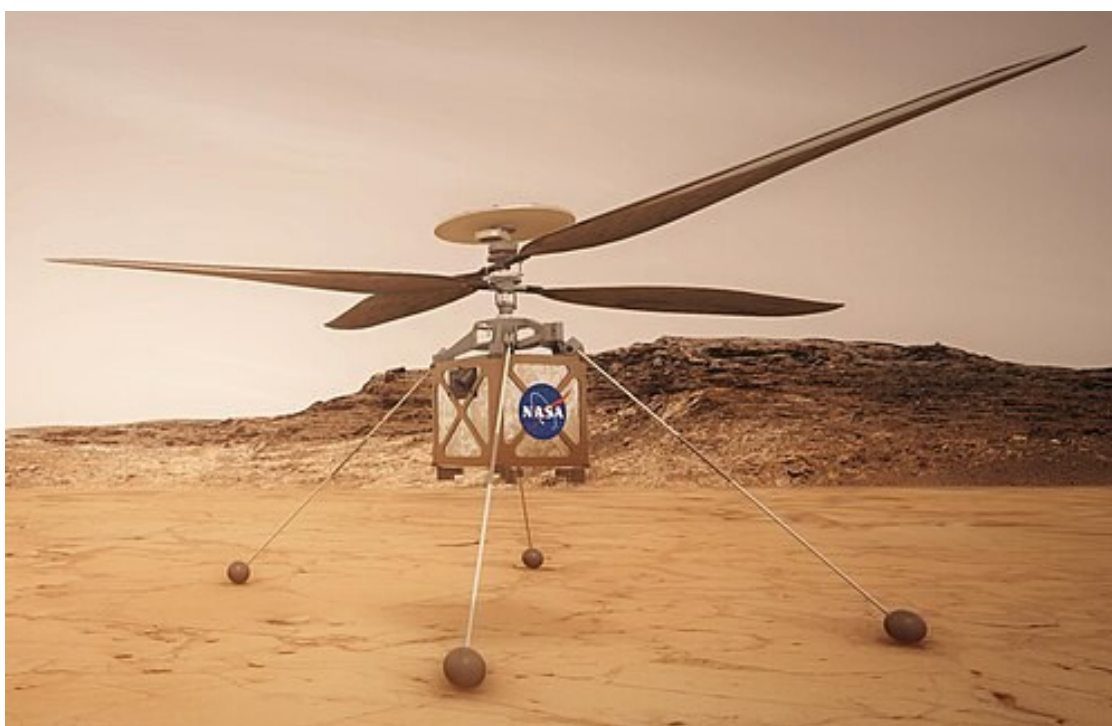
In fact, they sort of admit that on his Wiki page, where we find he stole most of the technology from ZeniMax, losing a big lawsuit to them in 2017 for breach of contract and copyright infringement. Facebook, which had kept Luckey on after the sale, immediately fired him in 2017. Wiki spins some tale about it being for his support of Trump, but it sounds like a cover story. Appearing like another cover story is the one about him being given a \$100 million payout on his way out, for improper termination. The reason this sounds like another tall tale is that there was no lawsuit involved, Luckey's lawyer supposedly just “negotiating” that sum. Yeah, right. Again, this is just to try to explain where his money came from, when it looks to me like it didn't come from there at all. This looks like the manufacture of an early bio from scratch, like we always see from these people. This set up Luckey for the founding of Anduril at age 24 with three fellow Jewish executives from Palantir. So Luckey is just another front for Thiel, who is a front for the DoD and Intel.

Anduril later won the Autonomous Surveillance Tower [Program of Record](#), resulting in the deployment of hundreds of Anduril Sentry Towers at a cost of "hundreds of millions of dollars".[\[43\]](#)[\[44\]](#)

This was for border security starting in 2018. Funny, since by 2021 that would all be moot: the border was then just opened. All the camera towers were turned off or mothballed at that time, I guess. But that brings up this question: why Anduril? No one had ever thought of putting cameras on the border, or putting them on towers? How hard or high tech is that? Should a camera on a pole cost a million dollars?



Even worse:



Anduril also makes UAVs like that one. What is a UAV? It stands for unmanned aerial vehicle, but again they have had those for years. That's just a remote-controlled box under a rotor, with a camera and maybe some other gadgets. You don't need AI for that and there is no reason for it to cost millions. But they give it a fancy name and tell you it was used on Mars or something. But of course all that was another NASA fake. You can't get something like that to Mars, much less land it there or unpack it there. That whole Curiosity landing was faked in the Utah desert somewhere, like the rest of them. Ditto for Perseverance.

So Anduril and Palantir are just part of the ever-expanding conjob and rape of the treasury, by which these people steal your taxdollars, overcharging you for cameras on poles and cameras on rotors and abbreviated search engines and fake robots.

Don't believe me about Mars? Have you seen this?



We are told the little helicopter was attached to the underside of the Mars rover, so how did the rover land on Mars? That is the illustration of it from NASA. Before I show you all the problems with that, we should ask, “Why not just show us that happening in a test run here on Earth?” Because they don't have any film of that. The best I could find is [a parachute on Earth opening in a Mach2 wind](#) in two seconds, but we can't see what it is attached to. We don't see a rover land or a little helicopter deploy beneath it. NASA also provides [a video of the landing on Mars](#), but it is from the lander itself, so all we see is the surface of Utah approaching and some dust flying up, proving nothing. If we ask AI about it, we are sent to a Youtube video, but the video is CGI, so again not helpful. The second of two results is the one I just linked to about the parachute.

Which takes us to this problem not mentioned anywhere: a parachute test on Earth at Mach2 is meaningless, since that capsule would be going way above Mach2. The Artemis lander was going about Mach24 when it hit the atmosphere of the Earth recently, we are told. Mars' gravity is .38 that of Earth, and its atmosphere is .006 that of the Earth, so no tests on the Earth will mean anything. So let's say the Mars lander was going only 1/3rd of Mach24, or Mach8. No parachute can withstand Mach8. You will say it can with 167 times less atmospheric density, which may or may not be true, but the problem is that with that little density, the chute will likely not fill at all. Before filling, the chute has a very small cross section, or area for the air to hit, and it is effectively 167 times smaller due to that lower density. So there is no reason to believe a chute would deploy at all on Mars, at any speed. And if it did it would not provide much slowing. The atmosphere itself would also not provide much slowing. It would provide 167 times less slowing from friction against the bottom of the capsule. So 2.63 times less pulling from gravity, but 167 times less slowing from the atmosphere, leaving us (with the simplest math) 63 times more incoming speed than a test on Earth. No parachute in a tenuous atmosphere can possibly counter that, whether it opens or not. So any incoming craft should crash at

high speed into the surface.

A second fatal problem for that last illustration is the jettisoning of the heat shield. Would a heat shield just drop off like that in a fall? No. Even if you released the bolts holding it on, it wouldn't just fall off like that, since pressure would be holding it on. Even with the parachutes braking the fall, the capsule is still feeling huge pressure from the atmosphere pushing up. So the heat shield would not separate like that without being blown off by a powerful charge. But that would mean the lander just above the heat shield would not only have to survive the incredible heat of re-entry, it would have to survive that explosion as well. And so would the little helicopter strapped to its belly, even closer to the heat shield. Do you think those little spider legs on the helicopter would survive that?

The next problem is those thrusters on the lander, which we are supposed to believe will just gently lower it to the surface. Have we been shown any successful tests of that? No, though I remember seeing a famous *unsuccessful* one from the Apollo tests. The lunar lander had similar thrusters on the four legs, but they never got those to work in tandem. Why? Mainly because of the wind. The lander would have to monitor and respond instantly to any wind and any changes in that wind, which is nearly impossible to achieve. One of many reasons the SpaceX reverse landings are so ridiculous.
