

Frenchmen are Pigs, Too

In the “people will believe anything” category, we find today the story from France of an old guy who allowed at least 50 men to rape his drugged wife, and got caught because he filmed it. He initially got caught for upskirt but the police found the rape pictures on his camera as well.

That is also what we are looking at here in France, since this rape trial was both public and filmed, and it had no jury of peers. Only a panel of five judges. **All fifty** rapists would have to wave their right to a jury trial, and that would never happen in a million years. Plus, from what I can tell it looks like all fifty were tried at the same time, since they tell us about 60 lawyers present. Why would Pelicot by himself have sixty lawyers? The investigation was also not done in the normal way. You would expect it to be investigated by police, but it was investigated by “investigating judge” Gwenola Journot. A lady judge, of course. In fact, it is forbidden for judges or jury to investigate the case themselves, and it can lead to a mistrial. I assume the same applies in France.

Eighteen of the accused were detained, while **32** were attending the trial as free men and one was being judged in absentia.[23] The courtroom was specially adapted to accommodate the large number of defendants and about sixty lawyers, with a separate transmission room for the press and public.[24]

Hmmm. A specially adapted courtroom, is it? Kind of like. . . Hollywood? A special room for press and public? What existing courthouse would have anything like that, especially outside Paris?
