

The Rodney King Beating was Faked

If you do a search on this, those two photos come up in the top spots, both tagged as Rodney King. See a little problem? It's the wrong eye in the second one. That isn't even King. The first one has also been tampered with, but we will hit that below.

Now that we know the [George Floyd event was faked](#), the [O. J. Simpson event was faked](#), and the [Emmett Till event was faked](#), it isn't too hard to out the Rodney King event as more of the same. That event happened on 3/3/91, three years before the Simpson event in the same city, and both were run for the same basic reason: to create race wars and keep your eyes off the real criminals running the city and the state and the country.

Going in, I just assumed the event was faked, but I wasn't sure until . . . until when? When I read this:

King had a daughter with his girlfriend, Carmen [Simpson](#). He later married Denetta Lyles (cousin of hate crime victim [James Byrd Jr.](#) and also cousin of rapper [Mack 10](#)) and had a daughter.

That's straight from the mainstream bio and I didn't make it up. If you forgot, James Byrd is the black guy who was allegedly dragged to death behind a pickup in Jasper, Texas, by a trio of "white supremacists" in 1998. [I have already hit that one as well](#), since it too never happened. In that paper on the fake Black Panthers, I say this:

Also remember that Jasper is the site of a later fake: the 1998 death by dragging of James Byrd, Jr. The Wikipedia page for that event is littered with numerology markers, including the fact that there were allegedly 81 places where the police found remains of Byrd. Chai. The murderers are said to have been known white supremacists, which, like Communists, don't really exist. Murderer John King, 23, was said to have been a neo-Nazi of the Confederate Knights of America, a KKK and Aryan Brotherhood affiliate. That is enough to blow this case as a fake, since both the KKK and the AB are FBI/CIA constructs. If that isn't enough, remember that the police are said to have caught the suspects because stuff flew out of their pickup during the dragging, including a wrench that had "Berry" written on it. Also a lighter with "Possum" on it, the prison name of King. Right. These bozos are going to murder a guy, dump his headless body at a black church, and leave behind multiple calling cards?

So what are the odds that these two events are linked through this lady Denetta Lyles? She is the first cousin of James Byrd and the wife of Rodney King. Despite the fact they live in widely separated states. Texas is four big states over from California, remember, Jasper being 1700 miles and 30 hours by car from LA. There isn't a lot of toing and froing between tiny Jasper and Los Angeles among poor blacks. If you think that is just a coincidence, I don't know what to say, except that you obviously aren't a mathematician. Spock would tell you the odds of there being such a close link between these two widely separated events—in space and time—are astronomically low. But I have yellowed a couple more “coincidences” for you, making the odds this is accidental even more remote. One of the murderers of Denetta Lyles' cousin Byrd is named **King**, and she marries a **King**. Rodney King's event mirrors and foreshadows the **Simpson** event, both causing major riots in LA, and his first daughter's mother is a **Simpson**.

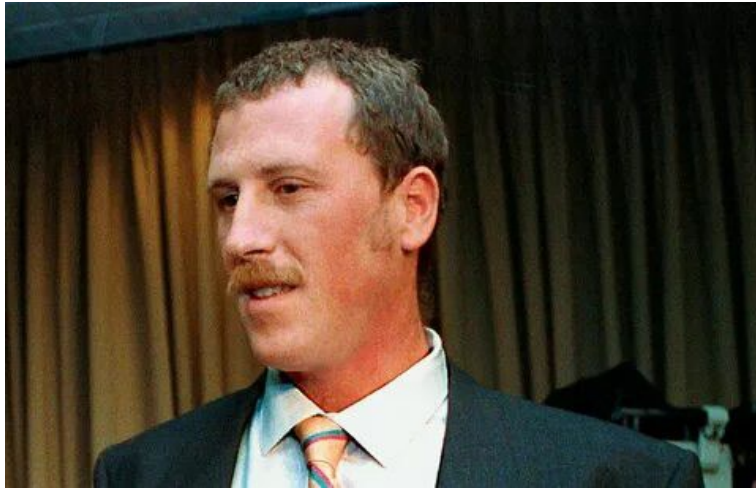
I guess now we know why Rodney King's genealogy is scrubbed everywhere, from Instantcheckmate to Findagrave. All these people are probably related, including O. J. Simpson. And possibly also including [Martin Luther King](#), whose event was also faked. Findagrave lists only Rodney's father, Ronald King, and he also has no information. Although Wiki tells us Rodney's mother is Odessa King, Findagrave doesn't list her, presumably so that they don't have to tell you her maiden name. Instantcheckmate also gives no information on Rodney King, with no relatives listed and no middle name. Just the dreaded *i*. Odessa is listed, but again with no maiden name. She is related to a **Hamilton**, but we don't know if that is her maiden name.

This is also an obvious clue we are looking at a fake run by agents: Rodney King allegedly died young at age **47** when he drowned in the swimming pool on Father's Day, **June 17**, 2012. His father Ronald King died at age 39 by drowning on . . . **June 17**, 1984. You don't think that fake death was an homage to his father, Rodney faking it for insurance money or something? Remember, he had already been paid \$5.5 million for his role as an actor here, the City of LA paying him that much when a jury allegedly awarded it to him. Of course that trial was also faked. Rodney probably moved to Rio or somewhere after the faked death.

And do you remember how long the beating lasted in the videotape? Exactly, in seconds. If not, go ahead and guess. Your first guess will be right. **81** seconds. Aces and eights.

The first two seconds of videotape,^[49] contrary to the claims made by the accused officers, show King attempting to flee past Laurence Powell. During the next one minute and 19 seconds, King is beaten continuously by the officers. The officers testified that they tried to physically restrain King before the starting point of the videotape, but King was able to throw them off physically.^[50]

That's straight from Wikipedia. Can you add? One minute and 19 seconds is 79 seconds. Plus two seconds, equals 81 seconds. I don't know if you have ever watched the video. I have to admit that until today I never had. I don't like to watch things like that. [But now that I know it is fake I pulled it up.](#) It's pretty obvious, since the beating takes place with batons. If you look closely, you can see they are made of soft rubber or sponge or something, like pool noodles, since they flex back when they land on King. One fake Hollywood cop whips his back and forth like a light wand and it just skims off King with no effect. They also pretend to kick him, but the kicks are even more ridiculous, since they don't land with any speed or aggression. They just sort of push on him with their feet, like they are trying to right a chair. I have never seen anything less vicious than that beating. I have seen scarier beatdowns in kindergarten. No jury of real people watching that closely would ever believe it was real, confirming the trial was faked like the rest. Even a jury of women wouldn't be fooled by that. But go watch it and decide for yourself.



We also have a problem with that amateur cameraman George Holliday, who allegedly lived within filming distance of the event on I-210. A search on him finds no match on a George Holliday of Los Angeles, died at age 61 in 2021. Neither Intelius nor Instantcheckmate can locate such a person. The closest they come is a George Holliday, otherwise scrubbed, age 56. But our guy should be 61 or—supposing there is no record of death—64 or 65. We do find a George Washington Holliday, 65, of Simi Valley, probably son of George Washington Holliday, 81, of Sacramento, Chesapeake, VA, and District Heights, MD. Although all the major outlets reported George Holliday's death, there is no obituary or findagrave page, which is odd. IMDB says he is from Canada. [Other websites say he was from Argentina.](#) Even his death notice is propaganda, since they say he was unvaxxed and died of Covid, while on a ventilator.

Here's your next clue:

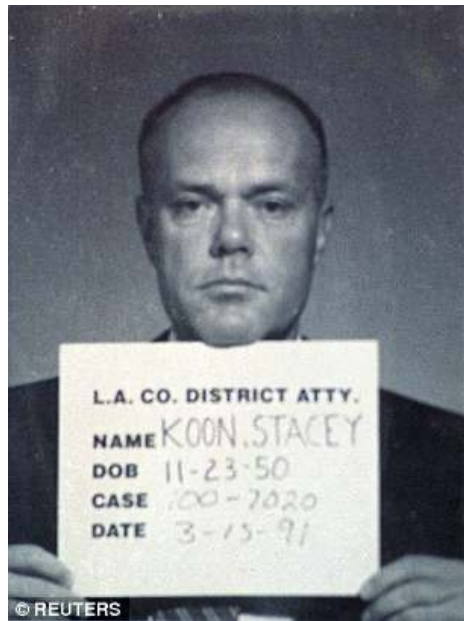
At 12:30 a.m., officers Tim and Melanie Singer, husband and wife members of the California Highway Patrol, noticed King's car speeding on the freeway. They pursued King with lights and sirens, and the pursuit reached 117 mph (188 km/h), while King refused to pull over.^{[12][13]}

Singer is a Jewish name. Husband and wife CHIPs team, eh? Who just happen to be assigned to the same car. And guess how fast he was going? 188km/h, aces and eights, of course. You can set your watch to this stuff. But remember, King was in a 1st generation Hyundai Excel, which will not do 117mph.



It's a 4-cylinder piece of junk [with a top end of 99mph.](#) *They are testing you.*

The commanding officer of the fake beaters was Stacey Cornell Koon, male, 40 at the time, who just happened to have two masters degrees from both UCLA and USC. He had been a sergeant since 1982 and was Air Force before that (no rank given at Wiki). Despite allegedly being sentenced to 2.5 years in jail for this event, he somehow stacked up over 100 commendations, including a medal of valor.



I love the way he is holding his card there. Not staged at all. And notice the card is laughably and obviously fake, since it doesn't say L. A. County Jail or something, it says L. A. County District Atty. District Attorney. I didn't realize the district attorney ran a prison. Does he keep them in his basement, or what? *They are testing you.* Apparently I am the first person who saw that in 34 years.

Here's some more fun with Koon:

In November 1995, a gunman, 35-year-old Randall Tolbert, entered a halfway house where Koon was completing the final weeks of his prison sentence and demanded to know where Koon was. Koon was away from the facility, on a holiday pass at the time. The gunman took three hostages, one of whom was 67-year-old Karl Milam. After fatally shooting Milam, Tolbert was shot and killed by the sheriff's SWAT team during a shootout.[\[3\]](#)[\[11\]](#)[\[12\]](#)

On a holiday pass from a halfway house, after just a few months in jail (actually none). We are told he was *sentenced* to 30 months, but if we look more closely we find that sentence was soon vacated (August 1994), and he was released while it was on appeal. In that way, we find that the two stories contradict one another. That last quote is from Koon's Wiki page. This is from King's Wiki page:

The low sentences were controversial and were appealed by the prosecution. In a 1994 ruling, the United States Court of Appeals for the Ninth Circuit rejected all the grounds cited by Judge Davies and extended the terms. The defense appealed the case to the US Supreme Court. Both Koon and Powell were released from prison while they appealed to the Ninth Circuit's ruling, having served their original 30-month sentences with time off for good behavior.

The trial had ended summer of 1993 and they were released on appeal August 1994, so even according to the mainstream story Koon spent about a year in jail, not 2.5 years. That is what they mean by time off for good behavior. Almost no one serves a full sentence these days, especially not police officers

with 100 commendations. But do you see what that means? He couldn't have been in a halfway house another 15 months later in November 1995, could he? But these scriptwriters can't add, so they always goof these dates.

And have you figured it out yet? Where the name Koon comes from? Take a few seconds and think it over.

Koon=Kuhn=Kohen. [See here for proof.](#)

Of course his middle name Cornell is another clue he is from these lines. They are among the first settlers of Boston, previously being Cornwalls. They were involved in the Puritan/Quaker projects from the beginning in the US, including [the fake witch trials](#). So they have been at it for a long time.

[**Added February 7:** I missed something the first time. Koon and the others were tried twice for the same thing, which is double jeopardy. The second trial wasn't a civil trial, it was a Civil Rights trial, which tends to fool you into thinking this was possible, if you aren't paying close attention. I was reminded of this when I noticed Koon was sentenced to prison, not to a payment. You will say the second trial was for violating King's federal civil rights, while the first was for police brutality, but both were *for the same action*. Renaming the violation doesn't make it two actions. So it was double jeopardy and would have been struck down on that basis by any appeals court had it been real—which it wasn't.]

The police chief at the time was Daryl Gates. A Mormon with a Jewish wife.



He looks like a lovely person, right? Her name is Sima, which means “treasure” in Hebrew. What is she doing: checking to see if his badge is real? He came out of the Navy, but again Wiki declines to tell us his final rank. He was probably in Intelligence, since they admit he specialized in intelligence as an LAPD officer.

Gates made substantial use of the LAPD's **Public Disorder Intelligence Division (PDID)** squad, even developing an international spying operation.[14] The lawsuit *CAPA v. Gates*, with the **Coalition Against Police Abuse (CAPA)** as one of two dozen or so plaintiffs, later sued the LAPD on **First Amendment** grounds that exposed the unlawful harassment, surveillance, and infiltration of the progressive movement in Los Angeles by LAPD agents. The lawsuit against

Gates and the LAPD proved successful. The PDID was ordered to disband and did so in January 1983.[15]

That's interesting in context, right, though I would say it is doubtful they did disband.

Gates's appointment as chief roughly coincided with the intensification of the War on Drugs. A drug-related issue that had also come to the forefront at the time was gang violence, which paralyzed many of the neighborhoods (primarily impoverished and black or Hispanic) in which gangs held sway. In response, the LAPD set up specialist gang units which gathered intelligence on and ran operations against gangs. These units were called Community Resources Against Street Hoodlums (CRASH), depicted in the 1988 film *Colors*. Allegations of false arrest and a general LAPD disdain for young black and Latino men were made. Gates himself became a byword among some for excessive use of force by anti-gang units and became a favorite lyrical target for gang-connected urban black rappers, notably Ice Cube.

Hmmm, are you seeing a pattern? I am. That looks like a psyop as well, with Gates as the Pentagon's pointman in LA. This whole gang thing was also faked for the same reason: the manufacture of race wars. Operation Chaos. Destabilization. Creation of Fear. They used this created fear to vastly expand the LAPD under Gates, just like they expanded FBI under Hoover. Taxes went up to cover that.

Gates was so gruesome even Wikipedia can't whitewash him, and they don't even try. His page makes him out to be a monster, which he was.

Many commentators criticized Gates for Operation Hammer, a policing operation conducted by the LAPD in South Los Angeles. After eight people were murdered at a birthday party in a drive-by shooting in 1987, Gates responded with an extremely aggressive sweep of South Los Angeles that involved 1,000 officers at any given time.[citation needed]

The operation lasted several years, with multiple sweeps, and resulted in over 25,000 arrests. This was not unprecedented: during the run-up to the 1984 Olympic Games, Mayor Tom Bradley empowered Gates to take all of the city's gang members—known and suspected—into custody, where they remained until shortly after the Games' conclusion. In the years after the Olympic games Gates, Mayor Bradley and city council officials found a way to continue the sweeping policies initially meant for the duration of the Olympic games by reviving old, anti-syndicalist laws, to jail predominantly black and Latino youth, even though the overwhelming numbers of people arrested were never charged.[18]

You will say that wasn't faked. No, not completely, but it was managed for maximum chaos. And of course the initial murder at the birthday party WAS faked, in order to justify the rest of this. And a large number of the gang leaders were planted. And most of the rappers were and are agents as well.

Which brings us back to rapper Mack10 (Dedrick Rolison), King's cousin by marriage. He was in *Westside Connection* with IceCube, who now also looks like an agent. If you remember, IceCube was also in a band named C.I.A. which supposedly stood for Cru in Action. A little obvious, ain't it? Amazingly, IceCube [later admitted on Bill Maher](#) that rap was a CIA front. At that link we find this:

John Homeston, a retired CIA agent, admitted on National Russian Television (NTV) that hip hop was a psy-op invented by the CIA in the 1980s and the agency has directed and financed household name artists including NWA, Dr. Dre, Jay-Z and Kanye West.

The government at the time spent “big money, serious money” on this covert operation designed to “corrupt the American youth to nihilist, anti-establishment and anti-American ideologies” and “sow division” in America, he explained in a half hour interview broadcast on national television.

At age 23, Mack10 came out of nowhere (supposedly a blood) and immediately went gold. He has no early bio at Wiki, being scrubbed of parents and everything else. We do notice he was allegedly born August 9, which would be the day of the Tate murders. As for Ice Cube (O'Shea Jackson),

Cube attended William Howard Taft High School in the Woodland Hills area of Los Angeles.[15] He was bused 40 miles (64 km) to the suburban school from his home in a high-crime neighborhood. [27][28]

You have to laugh. Straight Outta Woodland Hills. Just so you know, no one is bussed forty miles. That would kind of be a waste of gas, right. Plus, in LA traffic it would take three hours to get to school every morning. But they need to explain how this guy claiming to be poor ended up at Woodland Hills, at a charter school on Ventura Blvd. If you don't know, that area is just north of Pacific Palisades and Malibu, just below the scenic hills of Topanga. It is not a stronghold of the bloods, nor the crips.



That's his highschool photo. Not what you were expecting, I guess. He then got a degree in architectural drafting in Phoenix, so not really a bad boy. His mother comes from Baldwin Hills, also not a poor area of LA. It is just south of Beverly Hills and is sometimes referred to as the Black Beverly Hills. It is where Danny Elfman and Mike Love come from. Cube has a page at Ethnicelebs, but it tells us nothing about his ancestry. Even his parents are scrubbed. Instantcheckmate has no listing for an O'Shea Jackson in California, and that is because his name is Oshea, not O'Shea. It is Hebrew not Irish, a variation of Joshua. Cube's father was Hosea Jackson, also a Jewish name. So Cube's genealogy is scrubbed to hide the usual: he is half Jewish, like all the black Hollywood actors. Where do you think they got the promotion? Do you think these kids really came outta Compton, discovered off the streets by some record executive?

At Instantcheckmate we find Cube's brother and uncle are named Clyde Jackson. But the older Clyde Jackson is scrubbed down to *i* as well. Could it be because he is the Clyde Jackson who was a [founder of the United Black Front \(later Black United Front\) in 1968](#)? Here he is with Jesse Jackson:



A United Black Front that includes a white guy? Clyde is the one that looks like a woman, according to the tag. Are the three Jacksons related, including Cube? They will no doubt deny it, but then why scrub down the bios?

But the point is, we find Rodney King that close to Ice Cube. Not six degrees of separation, just two.

Now, let's tie up a few other loose ends before we finish. At the time of his death, King had been planning his wedding with partner Cynthia Kelley. She is the one that allegedly found him in the pool.



King with fiancée Cynthia Kelley a few months before his death. Kelley was one of the jurors in King's civil suit against the city of Los Angeles when he was awarded \$3.8 million.

Really? One of his jurors from 17 years earlier! What an amazing coincidence in a story already weighted down with them. Will wonders never cease! And if we do a people search on her, what do you know, she is also scrubbed down to white by the spooks, with nothing but the dreaded *i*. The giant computer that knows where you went to nursery school in 1970 knows nothing about her.

According to the bios, King was an ex-con who had done time for armed robbery. Checking the databases I found no confirmation of that. As you would expect, he has no record. He was never in any SoCal jails.

OK, back to that first photo under title. You can tell it has been tampered with just by looking at it, or I can. It reminds me of the young Norwegian [I led my Oslo paper with](#). They faked the same sort of eye damage there, but in twenty years hadn't gotten any better at it, even with CGI. All they did with

King is put some wadding in his check, like Brando in *The Godfather*, and then add some bruises in make-up. The eyes they did later in the lab, by retouching. Want proof?



Same day, same photoshoot, but what do you know, his eye isn't red. And I have news for you: if you had really gotten beaten with nightsticks by four vicious cops, you would look much worse than that. He has one little patch below his pec? That is just a prior scar, if it isn't make-up.

Also, look here:



Do you see it now? Look at his other eye, which has a line through it. There is a vertical line running down from his eyebrow past his nose, isn't there? That shows one way this was manipulated. Also notice that his iris on that eye doesn't look right. It should be curved, even at this angle, but the near side is a straight line. Impossible. Is your iris square? I didn't think so. How was that caused? It was caused because they went in to make the white of his eye whiter, to contrast even more with the other one. But they got too cute, as usual, bombing the correction.
