



**Inside J6 Podcast: Incredible Interview with J6er Ryan Samsel – Media Corruption, Prison Abuse, and His Interactions with Ray Epps on Jan 6**

His mainstream bio at Wiki tells us he is 41, living in Bristol, so the second one is him. Except that his name isn't Ryan Samsel, as you see. That may be his middle name, but his last name is Riffert. He has three parents listed, one of them a Samsel and the other two Deas, so it is not clear where the name Riffert comes from. Maybe it is his CIA codename. Notice he has DC on his list. You will say that is from his time in jail, but I have just shown you that was fake. He was never in jail. So that DC location is telling us something entirely different: probably that he is working out of the Pentagon or Langley.

Another problem is that [we have previously been told this Ryan Samsel was beaten so badly in that jail he lost an eye](#). Funny, since I seem to see two eyes there. Maybe one grew back. Now his story has changed, and he is claiming only a broken jaw and a tear in his kidney from a beating. But no mention of that lost eye. Hmmm.

Just so you know, Samsel is the guy whose ear Ray Epps was whispering in on January 6.



Remember that? But now the alternative press wants you to believe Epps is guilty, being an FBI plant, but Samsel is innocent, being a militant barber caught up in this real event. Aside from the problems you noted in your essay, the pics of the "DC prison cell" are consistent with that room being a janitor closet, not a shower/toilet combo, and most certainly not a prison cell. That is a mop sink and yellow mop bucket in the background of the pic with the "prisoner" sitting up and the pic on the right shows the center drain for the mop sink. Also notice the hinge to an access panel on the lower right of the first pic on the left. That is for access to plumbing behind the wall. I work in a hospital in facility maintenance and we have janitor closets similar to this throughout the hospital. I also notice the electrical outlet in the pic where he is lying down. Doubtful a prisoner would be in a cell with access to that - unless it was for charging his cell phone so he could watch youtube videos or read your essays to pass the time, hah.
