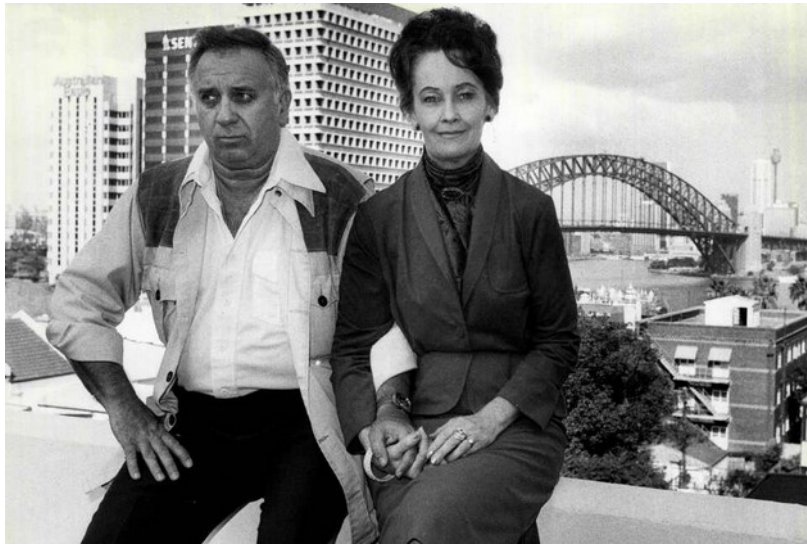


THE SATANIC PANIC

More Operation Chaos

If you don't know, the Satanic Panic refers to a widespread moral panic that occurred in the 1980s when everyone started believing that Satanic cults were kidnapping, abusing, and murdering children in large numbers. This one is easier than most to blow to smithereens, as Wikipedia has already placed the dynamite sticks for us.

Among the explanations of why the panic occurred when it did, or “took the shape that it did”, include

- ! Three films that opened and ran near the beginning of the panic having to do with Satanism, namely Rosemary's Baby (1968), The Exorcist (1973), and The Omen (1976).[8] According to scholar Joseph Laycock, patients hypnotized by therapists to recover memories of SRA [satanic ritual abuse], often "seemed to be recalling scenes from these films".[8]**

This is what the conspiracy theorists like to call predictive programming. In other words, Hollywood tells you ahead of time what shenanigans Langley is cooking up. Conveniently, the so-called memories these patients recalled were just scenes from these

films. But who's to say these are real patients to begin with? Given client confidentiality, there's no way to substantiate any of these cases. It is equally plausible that these cases were fabricated by scriptwriters who leaned too heavily on their own memories of the Hollywood films. In fact, they may have been the same scriptwriters behind those films. Also notice the citations above and below – all eights, indicating fakery.

! The reaction against the surge of new religious movements (NRMs) in the 1960s due to both the immigration reform allowing missionaries for Asian religions, as well as new religions, (including the Church of Satan), arising from the counterculture of the baby boomer generation. Sometimes called the "cult wars" or "cult scare".[8][9]

We know the Phoenicians have been pushing Eastern religions on the West for decades, and we also know the Church of Satan was entirely a CIA creation. For one thing, Anton LaVey has always maintained he's an atheist, which is very strange on the face of it. Why should we accept that Satanism is a real religion when its founder flatly denied the existence of both God and Satan? We also know LaVey was a consummate liar, having made up most of the stories from his early years, including working in a circus, having an affair with Marilyn Monroe, and working for the San Francisco PD.

It goes without saying that LaVey was Jewish, being born Howard Stanton Levey (Levy) —a descendant of the priestly caste. But his first two names are also a huge tip-off, being aristocratic. LaVey's online genealogy is heavily scrubbed, but they admit his grandmother was a Douglas—linking us to the top of the British peerage. The Douglasses were closely related to the Stuarts, Hamiltons, Campbells, and Staffords, which links them to the Howards. (See James Douglas, 9th Earl of Douglas, whose mother-in-law was a Stafford, and Thomas Howard, 3rd Duke of Norfolk, whose wife was a Stafford.) Oddly, they don't explain how LaVey's grandmother is a Douglas, since her parents were Russian-Jewish Goldsmiths. They'd rather admit she was a Russian Jew than that she was related to the Earls of Douglas and thus British Royalty. They also don't want you asking why Douglasses and Howards are marrying Levys and Goldsmiths.



LaVey (above left) was also a Primakov through his other grandmother, which is also scrubbed but probably links us to Yevgeny Primakov (above right), former Prime Minister of Russia, Director of the USSR Central Intelligence Service, and Director of the Foreign Intelligence Service. He got his start working as an undercover KGB operative for *Pravda* newspaper, where he was “sent frequently on intelligence missions” to the U.S. Hmm...are you getting the picture? If LaVey was taking up the family business, we can read the Church of Satan as just another intelligence project, but one being run jointly between Russian and U.S. intelligence. There’s an economic tie-in here, as well, since Primakov also worked as a senior researcher for what later became the Primakov Institute of World Economy and International Relations, named in his honor. Another World Economic Forum type of organization established to promote the interests of Jewish global capitalists. How would a project like Satanism promote such interests? By ramping up the level of societal chaos in the world’s largest consumer nation. Anxious people self-medicate through consumption. Another way that chaos = profit, which has been their fundamental operating principle since at least the industrial revolution.

Back to Wikipedia:

- ! **The Tate–LaBianca murders committed by cult members in the Manson Family which consisted of "mostly lonely teenagers from broken homes"[8]**

We also know [the Tate murders were 100% Hollywood fiction](#) and the Mansons were actors.

- ! **Mike Warnke's bestselling 1972 memoir *The Satan Seller*, in which he claimed to have led a group of 1,500 Satanists that engaged in rape and human sacrifice before he converted to evangelical Christianity. The book was praised by *Moody Monthly* and *The Christian Century*. Two decades later the book was debunked by an evangelical magazine, *Cornerstone*. [8]**

His Wikipedia page tells us that in 1966 “he began his tenure as a Satanist. On June 2, 1966, Warnke enlisted in the United States Navy.” So they admit he became a Satanist right around the time he joined the Navy. That’s not suspicious at all, is it? Like LaVey, most of Warnke’s autobiographical details are just lies, including when he allegedly converted to Christianity. It was later revealed that he was involved in Campus Crusade for Christ before joining the Navy, which explains everything. Campus Crusade is a premier spook organization run by U.S. intelligence. Founder Bill Bright was also Navy. It was created to delegitimize Christianity, not to promote it, hence the Warnke project. He was tapped by intelligence to make Christians look absurd and gullible, and it worked.

So of all the things that supposedly inspired the Satanic Panic, not one was real. Satanic ritual abuse = fake. Church of Satan = fake. Tate murders = fake. Warnke = fake. What about the McMartin daycare sex abuse scandal? [Miles has already debunked that](#). What about Lawrence Pazder’s 1980 book *Michelle Remembers*? This was the first published account of satanic ritual abuse, which investigators later ripped to shreds. Pazder was a key consultant in the McMartin trial, which proves he was a fraud. Nevertheless:

***Michelle Remembers*, along with other accounts portrayed as survivor stories, are suspected to have influenced later allegations of SRA, and the book has been suggested as a causal factor in the later epidemic of SRA allegations.**

And:

In 1987, a list of "indicators" was published by Catherine Gould [JEWISH], featuring a broad array of vague symptoms that were ultimately common, non-specific and subjective, purported to be capable of diagnosing SRA in most young children.

So it seems one of the main objectives of this project was to make everyone paranoid that they themselves had been victims of satanic ritual abuse and were repressing their memories. Why? To further mess with our heads, of course, and create a new market for psychotherapy and drugs. It also justified more government spending:

In 1984, [Kee] MacFarlane warned a congressional committee that children were being forced to engage in scatological behavior and watch bizarre rituals in which animals were being slaughtered. Shortly after, the United States Congress doubled its budget for child-protection programs.

Do you think any of that money helped protect children? If anything, child protection programs and laws are just another way to scare parents into doing exactly what they’re told. They want you to think you’ll be charged with child abuse for homeschooling or refusing to vaccinate. Just know it’s all a bluff. Remember, MacFarlane was the social worker who allegedly interviewed the McMartin preschool children. Not only did that

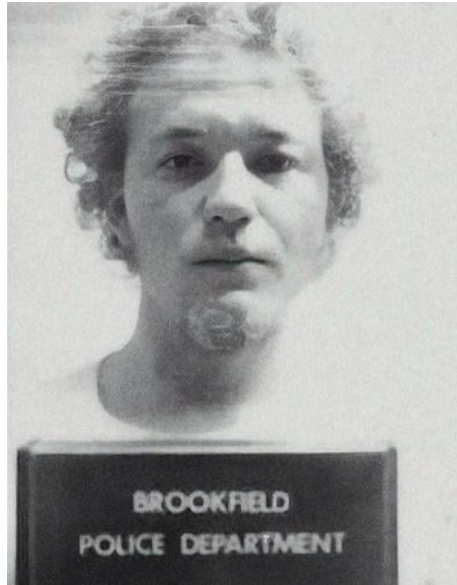
trial lead to zero convictions, but MacFarlane herself had no professional licenses despite claiming to be a psychotherapist. So why would Congress ever entertain such an obvious fraudster or take seriously any of her outlandish claims of a global Satanic pedophile ring? They wouldn't. They knew it was just more CIA theater and were playing along, ready to rubber-stamp the enormous budget increases at a moment's notice.

Where Wikipedia misleads you is in framing the Satanic Panic as an organic culmination of various, uncoordinated cultural phenomena. On the contrary, all evidence points to it being highly coordinated and aggressively foisted on the public via covert military and intelligence programs. Which means the only real victim in this debacle is you, the taxpaying citizen, not only because you're being fleeced, but because you're being low-grade traumatized on a daily basis with fake stories about ritually abused babies and mind-controlled serial killers.

On a related note, I've been looking into publicized cases of demon possession, a topic that interests me not only as a Miles Mathis contributor but also as a Christian. I honestly didn't know what to expect going in, but as you'll see, I've become highly skeptical of the whole idea. It started when a buddy of mine told me about the Arne Johnson murder case, famous for the slogan "the devil made me do it". It was the first U.S. court case in which the defense attempted to prove innocence based upon the claim of demon possession. Contrary to popular belief, this defense tactic didn't work, although the whole trial reeks of theater to me. The story goes that 11-year-old David Glatzel was possessed by a demon. His parents enlisted the help of noted paranormal investigators Ed and Lorraine Warren. (The Warrens are in the photo under title, and as you can see, they have 'spook' written all over them.) After several days of exorcisms performed by Catholic priests, the demon finally fled David and entered a bystander, Arne Cheyenne Johnson. A few months later Johnson killed his landlord, Alan Bono, during a party.

The first and most damning piece of evidence is that David's brother Carl later admitted that "the possession story was a hoax concocted by Ed and Lorraine Warren" and that "the Warrens told him the story would make the family millionaires". That unravels the whole story rather quickly, doesn't it? But let's add some more nails to the coffin. The big databases have no knowledge of the murder victim, Alan Bono. The closest instantcheckmate comes is an Alan Boro, who did live in Brookfield, CT, but it lists his current age (or age at death) as 66, whereas Bono died at 40.

Here's what they give us for Johnson's mugshot:



Was that shot from a Moon monitor? There's also no identifying information on the sign, which is convenient. And why does Johnson seem to be floating in the ether? Is this doubling as his model shot? He was sentenced on December 18, 1981. Aces and eights twice.

Johnson also got married while in jail...to David Glatzel's sister. Glatzel, by the way, is an Ashkenazic Jewish name. And she sure looks Jewish, doesn't she?



Funny how they let him keep his beard in prison. And how his best man, who I guess was also his cellmate, is allowed to wear a belt with a metal buckle. Typical prison garb in Connecticut, I guess. How much are you buying this? Those clothes don't even look like prison clothes, they look like military uniforms. Nice try, guys.

We also get this great Polaroid shot of David while “demon-possessed” with his mother attempting to restrain him. Besides proving nothing, it also reeks of AI tampering with the strangely blurred areas and inexplicable smoothness.

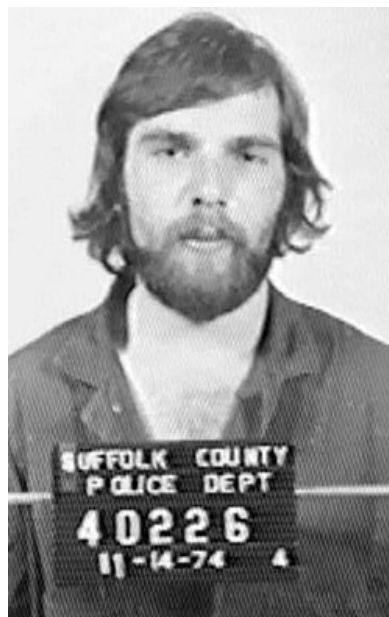


Most people already know Ed and Lorraine Warren were total hucksters. What you may not know is that Lorraine's mother was Georgiana Marie **Hamilton** of New Haven. There's a big clue, since it ties her to the very top of the British peerage. It also links her to Anton LaVey. [The Hamiltons of New Haven are married to Yales](#), as in the university. Lorraine's maiden name is Moran, which probably links her to Mary Moran, Bridgeport's first female mayor. Ed's grandparents are Creeveys, originally Krive, which looks like a fudge of Krivec, a variant of Kravetz, the Hebrew name for a tailor (think Lenny).

The Warrens were also famous for their involvement in the Amityville Horror case. We're told Ronald DeFeo Jr. shot and killed six members of his family at their home in Long Island. A year later, George and Kathy Lutz moved into the house where the murders took place (on **December 18**, no less, the same date Arne Johnson was sentenced) and were subsequently terrorized by paranormal phenomena. People continue to believe in this story despite the fact that William Weber, DeFeo's attorney who came up with the idea to write a book about the Lutzes, explicitly told *People* magazine, "I know this book is a hoax. We created this horror story over many bottles of wine." Weber even tried to create a company around the story known as the Hoffman, Weber, Burton and Mars Corporation. Notice, too, all the Jewish names: Lutz, Hoffman, and Weber, not to mention the two judges involved in the lawsuit between Weber and the Lutzes: Jacob Mishler and Jack Weinstein. Oi vey. At least Weinstein had the integrity to call out the whole thing for what it was, stating in his ruling: "Based on what I have heard, it appears to me that to a large extent the book is a work of fiction, relying in a large part upon the suggestions of Mr. Weber." The involvement of the Warrens also

blows the lid off this fiction. For a laugh, a “researcher” for the *Skeptical Inquirer* who helped debunk the Amityville story was Rick Moran. Does that ring a bell? Moran is Lorraine Warren’s maiden name. The same family was playing both sides of this fiction, both creating and exposing it. This suggests that we are dealing with more than a local case of fraud. This has the markings of an intelligence psyop.

That would mean not only that the Amityville Horror was a hoax, but that the original murders were also faked. And of course, that story also falls apart at the lightest touch, though they bury the lede at Wikipedia. Not until the “Controversies” section do we learn that DeFeo’s great uncle was Peter DeFeo, a noted mob boss with the Genovese crime family. We’ve already studied fake deaths linked with the Genoveses – see [Kitty Genovese](#). We also know the mafia was an FBI creation, so a mass family murder linked with this family that turns into a fake haunted house story should make you highly skeptical.



That’s DeFeo’s mugshot, which is more believable than Johnson’s. However, the area of his neck has been tampered with, no doubt to hide the seam where it meets his head.

Speaking of pasted heads, here are the photos of his siblings whom he allegedly killed:



Notice anything? Every single head has been pasted in. You can tell because the light exposure and/or level of blurriness on each head doesn't match the surroundings. My guess is these siblings never existed; they were created for the story, which is much easier than having to fake the deaths of four real people. Miles: the second photo is a recent computer-generated image. That leapt out at me immediately. The first is an old standard paste. The third and fourth are computer enhanced, and may be completely CGI. They all have big focus errors which are especially noticeable between the heads and the collars.

Here's further support for that theory:





That's supposed to be Dawn and Allison. How obvious are those paste-ins? Yes, that's been partially repainted by AI. The background is really bad.

DeFeo was also a Calabrese and a Bianco, [linking us to fake mobster Al Capone](#) (whose grandfather was a Calabrese) and the Patriarca crime family. Again, they were all Jewish

actors paid to stir up societal fear and justify massive federal budget increases – same thing as the Satanic Panic and these demon/ghost stories.

Instantcheckmate only knows of one Ronald J. DeFeo, though it thinks he's still alive. DeFeo allegedly died in prison in 2021 at age 69, so this Ronald is the right age if he didn't die:

Notice the *i*, indicating his records have been scrubbed, and he only has one location, Binghamton, which is nowhere near Long Island or Fallsburg, where he was incarcerated at Sullivan Correctional Facility. That's the same prison they supposedly put "Son of Sam" fake killer David Berkowitz and the Central Park Strangler Robert Chambers, indicating another fake wing for celebrity killers. [Miles blew the Son of Sam fake in his paper on the Unabomber.](#)

I was going to end this paper by saying I leave open the possibility of real demon possession cases, but I just don't buy it anymore. Maybe there are demons who have access to our plane of existence, but if so they're not taking over people's bodies and levitating or performing feats of superhuman strength or twisting their necks 180 degrees or doing any other *Exorcist* type horrors. If they can interact with us, I believe it's through much more subtle means, such as negative or self-destructive thoughts. But if so, they only have the level of influence over us that we allow. That's the definition of influence, isn't it? It's within the power of the influenced, not the influencer, to accept or reject those thoughts. I also don't believe in satanic ritual abuse, although we know from history that many aristocrats were pedophiles. As with everything else, the Phoenicians are using the idea of demons and Satan worship to frighten and distract us into compliance and complacency. But they themselves don't even believe in Satan; Anton LaVey is a prime example, admitting he thought the whole thing was bunk.



Study that photo and ask yourself: is this not all just a big joke to them? These people aren't Satan worshippers; they just love the idea of playing both sides. They think they're somehow doing El's bidding by playing the part of Satan themselves. You may know that *satan* is not a proper name in the Old Testament, it's just an office held by one of El's divine council members. It means "accuser" or "opposer", much like a prosecuting attorney – an important function in a courtroom. Maybe they think El will reward them for carrying out the duties of this office on earth, but like everything else they take it too far. The heavenly *satans* were supposed to expose moral weaknesses so that the divine council could more accurately judge a person's life here on earth. But the Phoenicians care nothing for truth, accuracy, justice, or anything like it. Instead, they intentionally manipulate and lie to us, obstructing truth and justice at every possible turn. They are victims of their own satanic traps, and it won't bode well for them when they meet the real *satans* in the next life.
