THE AARON SCHAFFHAUSEN MURDERS WERE FAKE

As usual this is just my opinion, come to by internet research anyone could do. . . but doesn't.

This is by request. Schaffhausen is the guy above who—we are told—murdered his three daughters in Wisconsin in 2012 to get back at his wife for a divorce. I will show this was yet another event manufactured to create fear and split the sexes. It was another in a long line of stories in Project Chaos and the Men-are-Pigs project.

I will start with the smallest red flags and move to the larger. We have the required numerology markers, of course, the biggest being the aces and eights, deadman's hand, Chai. The daughters' ages are given as 11, 8, and 5. Then we have the guy's name, which already points at the usual suspects. It has Jewish and peerage residue at a glance, but we will dig deeper there in a moment. Then we have the fact that Schaffhausen allegedly had joint custody of the girls, but lived over 550 miles away in **Minot, North Dakota**. That probably puts him at the huge Minot Air Force Base, making him military. I saw that coming from a mile away. You may remember that the Son of Sam fake also had ties to Minot. [See my paper on the Unabomber](#) for more on that.

So far, we just have circumstantial evidence, so let's now hit the two items that proved it for me. The first is that these Schaffhausens in Wisconsin and Minnesota [are closely related to the Hinckleys](#). That takes us to a Wikitree page, where we find Mary Ann Hinckley marrying Robert William Schaffhausen in 1939. There are actually very few Schaffhausens in the US, since they came over from Germany rather late. [Ancestry.com tells us](#) there were only three of them in the US in 1920, in New York and Connecticut. The genealogy sites still list only a few families currently, most of them in Minnesota and Wisconsin. Anyway, I suppose you remember the Hinckleys? As in John Hinckley, who supposedly shot President Reagan. He was from a very wealthy family that just happened to be best

friends with the Bushes. In fact, as it turns out John Hinckley's parents were dining with the Bushes when the shooting happened. Just a mad coincidence, right?

You will say that this link to the Schaffhausens is just a coincidence, so let's show it's not. Mary Ann Hinckley Schaffhausen had a brother. What was his name? [John Hinckley](#). Still not enough for you? Well, the John Hinckley who shot Reagan is [the great-grandson of Francis Hinckley](#), who co-founded the University of Chicago. Let's see, who else co-founded that? We just go back to [my analysis](#) of the fake Leopold and Loeb murders, reminding ourselves that John D. Rockefeller was a co-founder of University of Chicago. Both Rockefeller and Hinckley were friends of fellow Industrialist Jacob Franks, father of the fake victim of Leopold and Loeb.

Anyway, that proves the Hinckleys were from that part of the country. They fanned out from Chicago to nearby Wisconsin and Minnesota. Also at that next to last link, you will find that John Hinckley was closely related to Barack Obama, George Washington, Ulysses S. Grant, Rutherford B. Hayes, Warren G. Harding, Franklin D. Roosevelt, Gerald Ford, Calvin Coolidge, Richard Nixon, Howard Taft, and both Presidents Bush. They admit that. They also admit he is close cousin of Jodie Foster, who he was allegedly obsessed with. Also closely related to many other famous actors. Remember, [we found the same thing with Mark David Chapman](#), who is also related closely to all other famous people. In fact, Mark David Chapman and John Hinckley *are cousins themselves*.

Also of interest to my readers will be that John Hinckley is a [Stanley](#). His father was President and CEO of [Vanderbilt Energy](#). His mother is a Moore.

But if we return to the John Hinckley, brother of Mary Ann Schaffhausen, we find he is the grandson of Frank Scott Hinckley and Mabel Kurtz [Ford](#). These Fords take us back to the Sandersons and Morses of MA, who take us to the Lincolns. These are indeed the Lincolns of Plymouth, linking us to Abraham Lincoln. This reminds us that the last Governor of Plymouth Colony was Thomas Hinckley. Frank Hinckley was born in Baltimore, and his mother was Rebecca Robb. This takes us back to the same Hinckleys, proving the two John Hinckleys come from the same lines. The only question is, how far back. Our links are a bit distant, and we may assume they have scrubbed these people to keep us from finding more recent links. Despite the fact that they admit the famous John Hinckley is related to most Presidents and famous people, many lines are still scrubbed. Also, it is strange that neither Geni nor Geneanet post a genealogy of this John Hinckley. Tim Dowling posts the genealogies of ten John Hinckleys, proving they are from these famous lines, but he has nothing on this John Hinckley. According to his lists, we are supposed to believe the males lines of all these John Hinckleys died out, but that isn't very believable. More likely is that the links forward to our John Hinckley have been jettisoned on purpose.

But we can use Dowling to wheedle a bit more information. Through one of the John Hinckleys he does list, we can discover his link to the Stewarts. There, we find a Luther Hinckley of CT who married Eunice Stewart. We know she is a Stewart of the royal lines since Dowling admits she is a 4th cousin.

But let us return to Schaffhausen. The thing that really *proved* to me this was another fake is that the trial and its aftermath were filmed. I have told you many times before that only CIA trials are filmed. Trials are filmed to be used as propaganda, and the films in this project are very raw. If you don't believe me, I recommend you start with [this one at Youtube](#). In it, family members are giving their little speeches after the sentencing. I'll tell you a little secret: in real trials, family members are not allowed to give speeches. Courtrooms were not built so that outside parties could grandstand, tell

stories, and mug for the cameras. The only people that should be speaking during trials are attorneys, judges, defendants, and witnesses. No family member witnessed these fake murders, so they should not be standing behind microphones and being filmed here. Notice how the film starts—the girls' alleged aunt Mary Elizabeth Stotz is reading from a script:

Every child is afraid of the dark, the bogeyman, or the monster under the bed at some point in their lives. As parents we protect them, love them, show them that the dark is not bad. The bogeyman does not exist and there are no monsters under the bed. Amara, Sophie, and Cia learned that there is a bogeyman, and that the monster under the bed hides in even more sinister places. Aaron became the darkness, the bogeyman, and the monster under the bed. He was so evil, he took their unconditional love and used their love to lure them close enough so that he could kill them. Aaron did this with the promise of love, to only take their lives in such a manner that their last memories are the realization that their dad *never* loved them or cared for them. It was just a false illusion to cover up his evil darkness.

Wow. I have to tell you, folks, that that is one of the most transparently scripted stories I have ever seen or heard. I knew within the first seconds—after this Mary Elizabeth had spoken the first seven words—that this was another project. **Every child is afraid of the dark.** In other words, they are telegraphing to you immediately the thesis of the whole script: *the creation of fear*. This is propaganda 101, and it lacks all subtlety. Do you really think the aunt of these girls would write that or say that in such a situation? What is she, a professional Hollywood screenwriter? She is also way too calm and cool for the situation. If it had been me, I would have burst into tears after about three words. I wouldn't have been able to get through it. I can't even think of my recently killed mama cat without becoming a puddle, but if I had to give a speech in court next to my brother-in-law who had cut the throats of my three nieces, I would have been an emotional wreck. There is no way I could stand there and read some scripted garbage about the bogeyman.

Also notice what they call the youngest daughter: Cia. As in. . . CIA. I remind you that isn't the usual nickname for Cecilia. [Cecilia is normally shortened](#) to Cece, Cecil, Celia, Ce, Lia, or Chichi. According to that website, Cia is less common than Chile. Have you ever heard of a Cecilia going by the name Chile?

Next, one of the girls' cousins, Eryn Schlotte, age about 12, gives an unscripted speech, which is pretty impressive. She doesn't have to read from a paper or a teleprompter, though she is heavily cut. She says that Schaffhausen doesn't deserve a second chance, and that “he shouldn't be allowed to smell the fresh air or see the sun or feel the rain again”. Watch closely, and you can see that she has memorized those lines. They are a little too poetic, aren't they? The scriptwriters have once again gotten too cute, with that “feel the rain” nonsense. Do you think prisoners are mainly worried they won't feel the rain again? C'mon, this is so Hollywood. And this young girl, like her aunt, is way too composed.

Next, the girls' grandfather reads his speech, which is also ridiculously scripted, having him say things no human being would ever say in such a situation. He says that Aaron not only killed these girls, he killed “an infinite number of generations of descendants they could have had”. What? Who talks or thinks like that? These were three pre-pubescent little girls, but granddad was already adding up an infinite number of great-grandbabies?

Then, for some reason, they let Aaron's aunt give an unscripted speech, admitting his guilt but claiming she knows he has a mental illness. Since she looks like she has a mental illness herself, we are led to believe she would know. But just ask yourself why they would allow his aunt to testify for him **after**

the trial is over. The jury just found Aaron was sane and sentenced him to three life terms based on that finding, so why would the judge allow this lady to testify outside the stand moments later that he wasn't? It is absurd. This is supposed to be in a courtroom, not in a soundstage in Television City. This isn't supposed to be an episode of *Geraldo*, this is supposed to be right after sentencing, with Schaffhausen and the attorneys and the judge and the jury still sitting there.

Next, "Aaron's mother" Suzanne Allen gives her speech, and she is as cool as a cucumber. No, make that cold as ice. And, I have to say, she looks like a paid actress. She is *way* too slick. She says that Aaron should receive treatment, not prison, and that he is a good man who did a horrible thing. The camera pans back to get them both in frame, and that gives us a chance to see Aaron's huge adunc nose, reminding us of the Jewish angle here. It is all acting all the time with these people. They couldn't tell the truth to save their own lives.

As more indication this was all theater, we find that there was a large photo of the victims on a stand by the judge, and that the judge also made his own Hollywood speech at the sentencing. Judges don't make emotional post-sentencing speeches in court for the cameras, in front of blown-up photos of the victims, except when they are also agents.

At the *Daily Mail*, we find these photos of the girls:



To start with, notice how Jewish the eldest girl Amara looks. Nothing wrong with looking or being Jewish, but it does confirm this project comes from the usual place. However, both those photos appear to be pastes. The first one is very obvious, since the youngest child is in different light. The two older girls are in very yellow light, but the youngest isn't. The second one is suspicious for a number of reasons. One, the youngest girl Cia looks quite different. Two, Sophie, to your right, isn't looking at the camera, though the other two are. What is she looking at? We have seen this in many previous pastes, where people appear to be looking at different monitors. Then we have that all-black background, which acts as a sort of greenscreen. Where are they supposed to be? I will be told that is a professional photographer's studio, but the lighting is amateur. They are overlit for one thing, and the pose is very odd for a studio shot. Bluejeans and bare feet, lying down with feet crossed?

But let's return to the first photo for a moment. Sophie looks to be dressed as Cleopatra, which is an odd costume for a girl that age. And of course it plays into the overall theme here, which is—as usual—Phoenician Navy. And what is Amara dressed as? It looks like she may have wings, so she is some kind of black bird. . . or phoenix. The photo seems to have been cropped to keep us from seeing her headdress. She might even be an owl. I can't figure out what the heart signifies. But again, I think we are being signaled here, as we were by the photos of the children at Sandy Hook—[who were throwing up horn handsigns and showing us drawings of owls](#).

Then there is the odd fact that Schaffhausen was ordered to pay his ex-wife for time she lost at work after the murders and for therapy. That makes no sense, neither the cause nor the amount--\$14,000. If she had sued in civil court for monetary damages, she should have asked for a lot more than that. Schaffhausen was ordered to pay witness and court costs as well, in the amount of \$10,000. Again, that number is far too small. Rather than a total of \$24,000, we would expect something north of \$100,000, and perhaps double that or more. Beyond that, we are told the same judge that ordered the payment also sentenced Schaffhausen to jail. But the same judge wouldn't be ruling in criminal and civil cases. You will say the order to pay restitution was just part of the criminal trial, but it wasn't. It didn't happen until 2014. The criminal trial ended in the summer of 2013. So once again the reports in the media don't make any legal sense.

Now for the second best evidence I found this was a fake. It also comes from the fake trial. [More digging shows](#) that Schaffhausen had been charged with harassment earlier that year (2012) for threatening one of the girls. [The mother testified in court](#):

His ex-wife testified that in March 2012, he called her from Minot, North Dakota — where he was working — and told her he 'wanted to drive down there and tie me up and make me pick which child he killed and make me watch while he killed them.'

Also according to her testimony, Schaffhausen had called her up to 30 times a day threatening to kill her new boyfriend. But that makes no sense, because the mother would have gotten a restraining order. She also would definitely not have allowed Schaffhausen to visit the girls while she wasn't there just four months later. That is the story you know: he called her in July and asked if he could make an unscheduled visit while she was away. The girls were with a babysitter, who left when he showed up. So do you still believe that? At least one of the girls had been threatened, there had been previous domestic violence, and—according to Schaffhausen's own aunt—he had a history of mental illness, but the mother is going to allow him to visit the girls alone? No effing way.

The ABCNews story that information comes from has been deleted, and it can only be found via the

Wayback Machine. There is a page two, and the Wayback Machine says it is available on the web, but it isn't. ABCNews deleted it and the Wayback Machine failed to archive it.

So let's go back to the name Schaffhausen. As I said, there aren't that many of them in the US, so we may assume they are all closely related. Which means Aaron is probably related to [Captain Frederick Schaffhausen](#), WWII pilot born in Metuchen, NJ. During the war he was stationed in London and Thorpe Abbots airfield. He just died in 2011 and he even looks like Aaron, with a very long face, so I would guess he is a close relative. Schaffhausen spent a lot of time at Hadley Field, and was a friend of both Charles Lindbergh and Jimmy Doolittle—[two other famous hoaxers](#). His page there also has the requisite numerology markers, since we are told he had **33** accredited missions.

Also at the same Wikitree page I referenced above, we find Clara Louise Schaffhausen of Minnesota marrying Daniel James **McKenna** in around 1920. Of course McKenna is yet another spook name like Hinckley, since it probably links us to fake “psychon(a)ut and mystic” [Terence McKenna](#). Wikitree links Daniel McKenna to an Earl J. McKenna and his daughter Jennamarie McKenna, born in the 1960s. She later married a Hamili. Her mother was a L'Heureux from CT and before that Canada. The L'Heureux were also from the family **St. Cyr**. [The McKennas of MN](#) are related to Kowalskis, Wieners, Gulners, Pitmans, Baumgaertners, Andersons, Rogers, and James. The McKennas of Wisconsin are related to Byrons, Hennagins, Wecks, [Gottschalk-Huntzigers](#), Davises, and Segers. They were originally from Bridgeport, CT, like the Schaffhausens.

Does this definitely link us to Terence McKenna? Hard to say, since Terence's genealogy is completely scrubbed. His middle name is Kemp, which almost certainly links us to the McKennas of the peerage. If so, it links him to the famous actor Denholm Elliott, who married a McKenna of the peerage. Also see Lt. Col. David McKenna, whose mother was a Jekyll, and who married a Keppel, daughter of the Earl of Albemarle, Walter **Egerton** Keppel. The Earl's wife was a Wynn-Carington, of those Marquesses. They link us to the Drummonds and Barings, as in Barings Bank. The Keppels then lead us forward to the Vane-Temple-**Stewarts**, Marquesses of Londonderry, as well as the Chaplins, as in Charlie Chaplin. They also link us to the **Villiers**, Earls of Clarendon, and the **Lindsays**, Earls of Crawford.

More digging takes us to Findagrave, which is for some reason not listed on a basic search for Terence McKenna. But he is listed there, and we find his great-grandmother is a Fearnely, which is purposely misspelled. It should be Fearnley. This links us to the peerage Fearnleys, who then link us directly to the Kirkpatricks, Baronets of Closeburn. Also to the Kirks, and through them to the Stuarts. Also to the Baillies, Baronets of Polkemmet, who also link us to the Stuarts, Maitlands, and Sinclairs. Also to the Sykes, Baronets, who married the Monckton-Arundells, Viscounts of Galway. The Moncktons were also Manners, Dukes of Rutland; Russells, Dukes of Bedford, and so on. At Findagrave, we also find that McKenna's 2g-uncle was Joe Leo **Kennedy**, who died in Marin Co in 1968. So he was a contemporary of JFK's dad Joe, who has almost the same dates. McKenna's mother was the Kemp, and her father was Joseph Luce Kemp. So McKenna was also a Luce, linking him to the big time once again. The Luces were also in Wisconsin at that time. I remind you the Luces founded TIME magazine and were related to the Booth(e)s. See Clare Boothe Luce, US Ambassador, daughter of William Boothe. The common bios don't admit she was related to John Wilkes Booth, but she was. Many of John Wilkes Booth's relatives spelled the name Boothe, and they all came from the vicinity of Baltimore, just like Clare's Boothes. So that is where Terence McKenna came from.

But let's back up. That name Gottschalk-Huntziger kind of jumps out at us, doesn't it? It reminds us of the French General Charles Huntziger who was Petain's Commander-in-Chief and who signed the

Armistice instead of Petain. I wrote about him in my paper on the [Battle of France](#), joking that the top French General was really German. It's a German name, not a French name. And it isn't just kind of German, like from Alsace or something, it is Jewish German, from the old Phoenician lines. They had to fake his death his death at age 61 just a year later, on November 11, 11/11, 1941. You may be interested to know that this French general had cousins living in Chicago. See [Charles Huntziger](#), b. 1881, whose father Gustav was b. Alsace-Lorraine, 1852. His mother was a [Braun](#).

Which brings us to another “coincidence”. General Charles Huntziger of France went to military academy at [Saint-Cyr](#). The academy is the top military academy in France, founded by Napoleon. Well, see above, where we found that the Schaffhausens of Minnesota were related to the St. Cyr of Connecticut and Canada. This indicates there *is* a connection between these Huntzigers of Wisconsin and Chicago and the French general. Also curious is that Wikipedia gives us no biographical information on General Huntziger, hoping to hide his connections. Wiki France also gives us no parents. General Huntziger's great-nephew Jacques Huntziger became a member of the Socialist Party, then became [ambassador to Israel](#). He also was a head of the [Holocaust](#) Remembrance Task Force. That should look kind of strange, since his great-uncle was allegedly an anti-Semite, signing the Statute on Jews in 1940. Except that. . . that was controlled opposition and Huntziger was a Jew himself. That is another reason why they scrub his bio.

For more signals/coincidences here, we can search on the name Stotz, Schaffhausen's wife's maiden name. It takes us right to Max Stotz, Nazi and Luftwaffe pilot who allegedly shot down 189 enemy aircraft. That is far more than the Red Baron, who only claimed 80. Stotz was awarded the Iron Cross twice. His parents are also hidden. That is probably because Stotz, Stutz, Stoltz is often a Jewish name, and there are not only many of them in Germany, there are many in Brazil and Argentina. Remember the Boys from Brazil? Also see the Stotz-Broschius Group at Morgan Stanley, which is led by top Jewish financiers in the firm, including also Drivers and Pasackows. All Jewish names. Think Minnie Driver and Adam Driver.

Now, if we do a people search on Aaron Schaffhausen, we find at Intelius and InstantCheckmate a listed alias of Aaron Cruit-Schaff. But if we do a Google search on that name, we find a different inmate in the MN prison system, with a different picture.



Looks like another joke to me, since they wouldn't allow someone to make a face like that in a mugshot. If they accidentally got a pic like that they would trash it, not post it on the internet. Plus, you can tell from his eyes he is laughing inside. So are there two people with this strange name? No, a nationwide search only pulls up one, this one in MN. So is Intelius getting the two people mixed up? If so, Instantcheckmate is mixing them up as well, since they also list Aaron Schaffhausen aka Aaron Cruitt-Schaff. So how to explain this? I explain it by assuming there are not two people here, only two sets of photos. The same military actor from Minot is involved in both sets of fake crimes, he isn't in jail either in MN or WI, but they manufacture these stories using aliases and stock photos. More indication of that is that the second Aaron Cruitt-Schaff we found is from St. Paul, MN, and Aaron Schaffhausen also has that location on his list. It all works until you start digging deeper, and they forget to cleanse the computers of all contradictions. They figure no one will do what I am doing, since no one had ever done it before. No one had the time or inclination to cross-check media stories or recent history for consistency.

Here's another clue from the people searches. In Aaron Schaffhausen's relatives list we find the oldest daughter Amara but not the other two. Why is that a clue? Because these searches don't include children under 18. But remember, Amara, if alive, would now be 19. This indicates the computers think she is still alive, since they don't have a death listing.

We also find Aaron's mother [Suzanne T. Allen](#), 72, related to Schaffhausens and Hewitts, and she has a surprisingly long list of 18 locations, including Ft. Benning, GA; Starkville, MS; Springdale and Paris, AR; Prattville, AL; and Tracy, CA. Ft. Benning is our big clue, and leads us to check the other locations for military bases. Starkville, MS, is paydirt, since it is not only the location of Mississippi State University, it is very near both the Columbus AFB and the Mississippi Ordnance Plant. Prattville, AL, is a suburb of Montgomery, location of Maxwell Gunter AFB. Tiny Tracy, CA, just happens to be the location of San Joachin Depot, Joint Operations. So I think we have this military actress pegged.

We saw the young cousin of the girls above, with the surname Schlotte. This also leads to paydirt, since we find someone in her family named [Beverly Schlotte](#), age 71, living in Webster, SD. We know it is a relative, since we find both the names Schlotte and Stotz. But we get some other surnames as well, including Brickey, Strande, and [Townsend](#). It is the last one that jumps out at us, doesn't it? We know it is a big peerage name, taking us right to the top and linking us to the Stuarts. Beverly links us to Timothy Dewley Townsend, age 62, who has lived in 24 states! Intelius lists 43 locations, including Baltimore, Phoenix, Detroit, Nashville, Fresno, Springfield IL, Jefferson City MO, and Alpharetta GA. Another is Helendale, CA, which is of course on the edge of Edwards AFB. Another is Meridian, ID, on the edge of Mountain Home AFB. Alpharetta puts us near NAS Atlanta. Riverdale puts us near Ft. Gillem. Statesboro puts us near Ft. Stewart. Elizabethton, TN puts us at Holston Army Plant. So this guy is looking pretty spooky. Beverly's husband is Clayton Townsend, recently deceased, and that name reminds us of Hollywood producer Clayton Townsend, who has worked extensively with Oliver Stone. I was able to connect them, though it wasn't easy. The Clayton Townsend producer is related to Colin Townsend, who is related to Dorinda Townsend. That uncommon name gives us only one result, and she is listed as related to Edward and Timothy Townsend, as well as Najarra Allan. Edward is the brother of the first Clayton Townsend, who is also related to Timothy. If we search on Najarra Allan, we find her listed only as Najarra Townsend, but I suspect she may link us to Suzanne Allen above.

Webster, SD, is also a clue, since until 2015 it was the site of one of the State's few National Guard armories. So the town had a military presence. It also has a link to previous fakes, since faux serial killer Jerry Brudos was from there. His project worked out of [Salem](#), Oregon. You may have seen him

promoted on the Netflix series *Mindhunter*. And Brudos links us to other agents, since his performance as this fake murderer was used by both J. K. Rowling in her book *Troubled Blood* and by Ted Levine in his performance of Buffalo Bill in *Silence of the Lambs*. Both books, like the Netflix series, sell the idea that serial killers are real, though they aren't. Brudos, like Schaffhausen, is just as fictional as Hannibal Lecter. He was nothing more than a sick fantasy in the heads of these bastards in military intelligence responsible for this long project of manufacturing fear and sexual distortion. I may hit Brudos in more detail later.

By the way, good to see Rowling, children's book author, is now selling serial killers. [Pretty much outing herself as an MI5 front.](#)

With more digging, we find Aaron Schaffhausen's sister Kara, who married a Cronin. Her father-in-law is listed as Jerome P. Cronin, who is not the same as, but *is* related to the Jerome P. Cronin who invented Marketron. Which leads us to Hollywood once again. The Cronins have also long been involved in major fakes, see [Dr. Patrick Cronin](#), allegedly killed by Clan na Gael 1889, an IRB spinoff. His fake murder trial was like the Manson trials, and was at the time the longest running in US history. All this was used to blackwash Irish opposition to the British, and that is pretty much admitted now. Even Wikipedia admits Cronin was probably a spy for the British, but of course they don't admit his death was faked to make the Irish look like a bunch of feuding mobsters. The Cronins are still working the same project, see Sean Cronin, former Chief of Staff of the IRA. The IRA is just another MI6 front organization, so Cronin looks to me like a complete fraud. He worked for a long time as a journalist—ie agent—in the US, then moved back to Ireland to be an editor for the *Evening Press*. So I don't know why anyone thought he was a revolutionary. His wife was a [Rubenstein, explaining a lot.](#)

Judge Howard Cameron is also an enigma, since he retired from the bench soon thereafter, though he was not yet 65. In fact, nothing about his career makes any sense, and most information has been memoryholed. There are only two pictures of him online, and one [links to a dead page](#) at wicourts.gov. We see why it has been deleted [if we dig it](#) out of the Wayback Machine. Compare his section to the section of the other retiring judges. It says nothing. The content is zero. We learn a lot about the other judges, but nothing about Cameron. His page at [Martindale](#) is likewise empty. It doesn't even mention his time as a public defender or as a judge, much less list any cases. [This article on his career](#) tells us a lot about his earlier life, including milking cows in Alaska, but has almost nothing to say about his time on the bench. Only the Schaffhausen case is mentioned.

According to his bio, he didn't become a judge until 2008, then was re-elected **without opposition** in 2014. But after re-election he almost immediately announced early retirement. Then why run for re-election? His page at ballotpedia makes no sense, and throws up a forest of red flags. He got his law degree 13 years after his bachelors, at age 35. He became a public defender in 1991, but none of his cases are listed. He finally became a judge at age 56, but again none of his cases are listed. He went straight from public defender to circuit court judge, which is pretty rare. Remember, a circuit court is an appeals court, but in the Schaffhausen case, we are not told there had been an appeal. On the Wiki page, we are told Cameron was a St. Croix county court judge, but according to [ballotpedia](#) that is not true. It was a county court, but a county *circuit* court, [which hears appeals](#).

A search on his name takes us to [another Howard Cameron](#) who, with Victor Mitchell, allegedly planned to kidnap Mississippi billionaire Tommy Duff in 2019. This looks like another fake CIA trial, so either the name Howard Cameron is an alias the CIA likes to use, or the Cameron family likes to be involved in these hoaxes. It is of course a peerage name, as is “Howard”.
