

My Site is Now “Secure”

My webhost has graciously bought SSL secure certificates for my two sites, so my default URLs are now <https://mileswmathis.com> and <https://milesmathis.com>. The old URLs <http://mileswmathis.com> and <http://milesmathis.com> also work. This removes just one of the many ways CIA/Google/etc has been messing with me in the past five years.

Some of my tech expert friends who have been in the field for years wrote me and said they had never heard of anyone parking on an unused https and diverting traffic that way. They said they couldn't believe GoDaddy would allow it. But apparently it has happened before. It is all very suspicious of course, and you can come to your own conclusions.

Unfortunately, Google continues to divert 90% of my potential new traffic by failing to list my papers on general searches. [After I went superviral several years ago](#), Google was instructed to delist me. We know this happened because other search engines like Bing, Yahoo, and Yandex either didn't get the message or got it later. Yandex is still listing me pretty much normally, “normally” meaning based on the true popularity of the pages. Through Yandex, one can see that my papers are still superviral, going to the top of general searches immediately and often staying there for many years, outranking big sites like Wikipedia, Britannica, and Dictionary.com. My science papers are still drubbing the university sites like Harvard, Columbia, MIT and Stanford, so you can see why they would be pissed. If they can't win by being better than me, they win by censoring me. But that shouldn't surprise you since it is happening worldwide, in all fields, and not just to me. And of course the Supreme Court just ran interference for them, ruling people like me don't have standing to sue [*Murthy v. Missouri*]. Pretty amazing ruling, seeing that this is not only suppression of trade, but a civil rights violation of the first order—killing the First Amendment. As in the lawsuits concerning Presidential elections, every citizen should have innate standing, since our interest in this—financial and otherwise—is clear. “Justices” pretending not to see that proves once again the entire government has been bought.

Even more amazing is that the Supreme Court ruled the States themselves don't have standing to sue. Here is the ruling, verbatim:

To establish standing, the plaintiffs must demonstrate a substantial risk that, in the near future, they will suffer an injury that is traceable to a government defendant and redressable by the injunction they seek. Because no plaintiff has carried that burden, none has standing to seek a preliminary injunction.

Really? No plaintiff was able to demonstrate the likelihood of future injury? Though they had proved injury in the past and most of the mechanisms of that injury were still in place (like Google rigging search engines), a majority of the justices couldn't add that up to equal likelihood it would keep happening?

Just to be clear, the standing of the States like Missouri and Louisiana was based on the fact that the Feds were censoring “conservative” or Red viewpoints, which of course was harming Red states both politically and financially. So the Supreme Court should have been swift to rush in to protect the out-

of-power party from obvious censorship by the ruling party. This they should have done even if they hadn't been (allegedly) of a conservative majority themselves. So, many people were shocked that conservative judges would let this slide on the mealy issue of standing. Judges only fall back on standing when they are at their most corrupt, so the Supremes should have made every effort to avoid that old dodge.

But, as with voting machines, this censorship is beneficial to both parties in the long term, so the Republicans are actually glad at the ruling. When they take over in November, they can flip the censoring in the other direction, keeping CHAOS at a maximum. This is why the Democrats didn't go after hacked voting machines when BushII used them to steal the 2000 and 2004 elections. In addition, Vivek just happens to be the chairman of TrialNetworks, a pharmaceutical and biotech company specializing in drug trials. He started that before he was 30. He is also on Biden's coronavirus advisory board. How's that for a spectacular conflict of interest? But there's more. Through the Murthys, he is also a cousin of Rishi Sunak, until recently Prime Minister of the UK.

I had to rebuild elsewhere.

Plus, I remind you that people congregated and chatted before the computer was invented. Talk to your neighbors face to face. Go to the pub and talk. Go to church and talk. Go to the park. Go to the mall. Talk about important things instead of sports and movies. Start local political groups and get involved in your community rather than wasting your time in chatrooms and forums. By keeping everyone bottled up online, the governors have killed much of the real grassroots organization that is required for a healthy society. For it to be effective, that organization has to be face-to-face and boots-on-the-ground, and it has to be linked out to other towns and cities and states and countries. Without that, the resistance will always be airy and feeble.
