

The Phil Spector Events were Fake

I have already told you this in passing in previous papers, since Spector's first trial was televised in LA on **CourtTV**, and all televised trials are fake CIA trials, filmed in some dummy court. That is doubly true of CourtTV, which has been a CIA front from the beginning.

And why was this faked, you will ask? Again, easy, since this is just another in a long line of Men-are-Pigs project fakes, manufactured to split the sexes and destroy the family. It makes women fear and mistrust men, so it blows the relationship from one side. If it is blown from one side, it is blown—like Spector's wig.

That's all you really need to know, but I will give you more just to be nice. And because we may have some fun with it.

The next clue is that Spector was a fake to the end, since they claimed he died of Covid in jail in 2021 at age 81. After a certain point in his life, Spector was done and signed up to be part of any project that came down the pike. Like many of these LA/Hollywood people.

The next clue is the pic under title. That's a wig, of course. Spector had been wearing bad wigs since the 1960s, but that one takes the cake. They tell us he wore them due to scalp damage from a traffic accident, but that isn't true. He had gone bald long before that and had been wearing wigs all along. Did you ever consider that maybe, just maybe, Spector and his directors were just effing with you with those wigs in court? It was all part of the big joke. The joke on you, the credulous Gentiles who will believe anything.




Yes, Spector was Jewish, of course. Russian Ashkenazi, previously Spektor. His mother was a **Baruch**, linking us to the Cohens and the top priestly class of rabbis.



That last one is what he became later. He is supposed to be in jail there, but isn't. He was never in jail for a second.

Remember, they waited four years to take him to trial. Why? Because they needed to milk it for all it was worth. During those four years he was in the headlines every month for one reason or another. Trials eventually end, at which point the main project is over. So the pre-trial period is the most fertile. You can make up any stories you like.

The easiest way to prove this was fake is to look up his "victim" Lana Jean Clarkson at Instantcheckmate. We get three results, but in none of them is she 40, as she should be. That was her age at death, and the big computers should have a death record.

I don't think the second one is her, but the other two probably are. The first definitely is, which is a major problem because the computer thinks she is still alive. That is how old she would be now. The third one may be her as well, since we have a match both on the middle initial and on Hollywood. Also a match a Eureka, which pretty much decides it. It looks like she married Waymond Starritt, changed her name to Storm, and Wesley is her son. That's why this Lana Clarkson isn't related to any Clarksons. Either way, it is interesting, because this Wesley [Starritt of Eureka, age 25, was arrested for murdering](#) an 84-year-old man in 2020. In 2021 he was charged with a second murder. He had already been convicted of stabbing a man in 2018 and was out in 2020 when he stabbed the old man to death.



That is Peter Marks, who Wesley Starritt allegedly stabbed in 2018. He was also arrested on an outstanding warrant from Ventura County for resisting arrest. Marks=Marx.

What does that tell us? Well, since the odds of finding anyone named Lana Clarkson linked like this to a recent double murderer are vanishing, best guess is these murders are fake as well, and that we are looking at a family of hoaxers. Wesley is taking up where his mother left off, the whole family being owned by CIA theatrical. For more of that theater, [see here](#).

I told you this was going to be fun.

While awaiting trial, Wesley Starritt assaulted guards at Humboldt County Correctional Facility. Despite that, it looks like he was judged incompetent and sent to a mental hospital. Or sent back to the CIA soundstage.

Any other evidence these Wesley Starritt murders were staged? Lots. The old man he allegedly killed [was an ex-officer of the LA County Sheriff's Dept](#). Also ex-military. They don't tell you that in the stories. In his obituary it says he passed away at home: no mention of being murdered. Since he was 84, he probably died of natural causes and they just used him in this story. Or he may still be alive since Instantcheckmate tells us he is 87. Again, no death record.

The other victim, “transient” Charles Levaugh, has two records at Instantcheckmate, being both 55 and 61. Both alive and dead. Aka Charles Gonzales. He doesn't seem like a transient, since he has lots of living family in the area, including many women. He also has links to Hoopa, which probably means he is linked to the Starritts through the Karuk Tribe, see below. This would mean he knew his fake killer, contradicting the mainstream story. He also links us to [Noble-Hofmanns](#), which may give us another Jewish link here.

The father Waymond Starritt also appears to be a fake criminal. Waymond Starritt of Eureka [is also supposed to be in jail](#) for heroin and weapons possession and resisting arrest.

Also note that we have Westminster, MD, on the lists of these California criminals. Westminster is north of Baltimore, so not a normal CIA community, but McDaniel College there is a training camp for the Colts and Ravens, so maybe Waymond Starritt used to play or work for one of those teams.

We find more information on these Starritts [here](#). According to that site, they are Natives of the Karuk Tribe, which would seem to indicate I am on the wrong path here. Except. . . we see there they are related to [Jacobs and Tripp](#), two Jewish names. Not normal surnames for Natives.

But let's return to Lana Clarkson. Her mother Donna Clarkson is now 78—so she was 17 when she had Lana—but we are given no maiden name. Big red flag. Wiki gives Lana's father as James M., but the computers do not confirm that. They list no James M. Clarkson of Long Beach. We do find a James E. Clarkson related to Donna, of Beaumont (near Riverside), and he also links us to Westminster, MD. We saw Westminster above, so that is either a big coincidence. . . or not.

[With more digging](#), we find that James Clarkson supposedly died in a mining accident in the 1970s. Very unlikely, since the fathers of movie stars are not miners. That pretty much goes without saying. Where was he mining in Long Beach or Sonoma Valley? Wikipedia says nothing about her father being a miner or dying young. They do admit she went to Pacific Union College in Angwin, though they tell us she went to a prep school there. But I found no indication PUC has a prep school. She is on their alumni list, class of 1984, and she would have been 22 in that year, so not a prep school. I don't believe she is a true alumna, since there is no indication she graduated. They admit that in the

early 80s she was already in Hollywood, working in both film and TV, so she could not have also been going to college in northern California in those years.

Another clue is that PUC is a spooky Seventh Day Adventist private college. Let's see, who else celebrates the Sabbath on Saturday? That would be . . . Jews. But I have hit all that before. PUC is quite expensive, so I guess her father struck it rich in some gold mine in the area.

Lana's page links her to a Jeff R. Clarkson, age 57, so probably a brother. Wiki says her brother is Jesse J., so no match there, either. We do find her sister Fawn, married to a John Cory Edwards of Studio City. That would be [Cory Edwards](#), since I matched his birth town of Anderson, IN. He wrote and directed *Hoodwinked* in 2005.

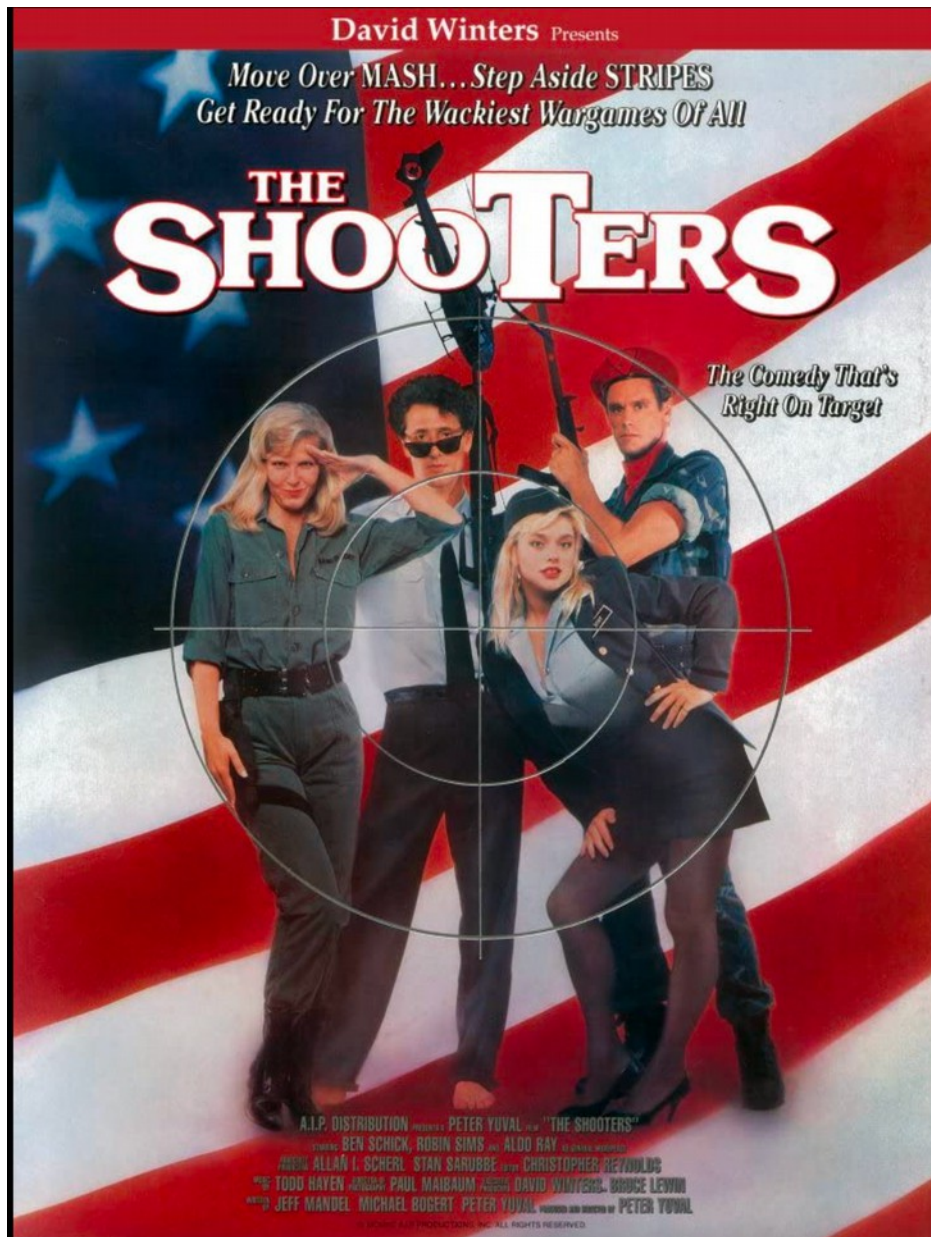


That title sort of fits our theme here, doesn't it? It was released by Weinstein, linking to all that as well —yet another Men-are-Pigs project.

Lana Clarkson is also linked to a Tani Barton, who just happens to be the same age as her:

She is aka Clarkson, but is not listed at Wikipedia as a sister of Lana. It is unlikely that a cousin or sister-in-law would be listed. Tani is also aka Lynch, Kircher, Grimley, and Lavender. Also uses Grimley as a first name, indicating we are looking at a bunch of aliases. We find Tani Barton at IMDB, as a working actress in the same period as Lana, and in the same sort of B-movies, so it may be another working name of Lana. Curiously, the internet has been scrubbed of all photos of Tani Barton. She has a nude scene in 1989's *The Shooters*, so she should be featured at one of the nudie sites. She isn't. One of the blondes on the cover of *The Shooters* looks like Lana, but I could not confirm that.



If so, Lana may have lived on as this Tani Barton.

If we keep searching on her, we find her related to a Deborah Kircher. Not only are these Kirchers related to Stuarts, this Deborah looks like a spook.

Only 36, but with 27 aliases, including three last names, seven middle initials, and two first names. Many of those locations are military. If that is another of Lana's daughters, it looks like she is also in the family business.

But let's leave all that and study the fake trial. Like the others we have looked at, [including OJ](#) and the [Menendez brothers](#), this one makes no sense. Spector's prints weren't found on the gun or unshot bullets. Even worse, the judge allowed prosecutors to bring in previous lovers of Spector, who testified he had pointed guns at them. Wikipedia admits “the law generally forbids the introduction of evidence showing a defendant's previous transgressions”, but tells us it was allowed anyway. But not on what grounds it was allowed. That should have been cause for an appeal, but Spector strangely never appealed*, though he had been tried for the same thing twice. The jury in the first televised trial hung, with two jurors not finding him guilty. But in our weird system, that didn't end it. They tried him again with no cameras, found him guilty, and he didn't appeal. Very strange. If nothing else here makes you suspicious, that should.

The judge in 2007 was Larry Paul Fidler, and he is still working. So we [look him up at Ballotpedia](#). Here is the first thing we find:

Fidler won re-election for judge of the Superior Court of Los Angeles County in California outright in the primary on June 7, 2022, after the primary and general election were canceled.

What? The election was canceled but he won re-election? How does that work, exactly?

He also ran unopposed in 2016. That's convenient. And what district did he win in? C'mon, you know it! He is the judge of district 88. The perfect number for a dummy court. So he must be getting pretty old, right? He was born around 1947, so he is now about 76. Don't these spooks ever retire? He was installed in Superior Court by Pete Wilson in 1992, so he has been at it 31 years.

So what other fakes has Fidler presided over? Well, for one the Hollywood Ripper Michael Gargiulo, from 2021, where Fidler gave him the death sentence. Ashton Kutcher testified in that trial, since one of the fake victims was supposed to be going on a date with him the day she was murdered. Right. That's believable. Kutcher actually found the body. She had been stabbed 47 times. I guess you saw that coming.

Two years earlier Fidler [sentenced a former federal police officer to 27 years](#) to life for murder. Hmm. A federal police officer, you say? But that's not suspicious. Pierre Romain was convicted of a 1987 murder, so 32 years earlier. He was allowed to wear a long beard in court, though he had already been in jail for many months, where that is not allowed on murderers. You can also see that Fidler allowed [the now usual theatrics in court](#), where the victim's mother was allowed to grandstand, show pictures, fake cry, and thank the Academy and her producers.

Remember that Spector had some of the same attorneys as OJ, including Robert Schapiro. Linda Kenney Baden is the one that won the first trial, and she is also known for representing Michael Skakel, Casey Anthony, Jayson Williams, and Aaron Hernandez. Were all those faked as well? I will let you come to your own conclusions.

And now for the cherry on top:



They are required to give you all the evidence to prove this was fake, but they are not required to look at it for you. You have to do that yourself. You have to turn your brain on. Spector is supposed to have put the gun in her mouth and pulled the trigger, but all we see is a small amount of fake blood coming from her nose and mouth. That isn't what happens when you shoot someone in the mouth. There would be huge amounts of blood, including splatter forward and backward. So we start with that.

This picture would be very easy to fake. I created scarier effects on Halloween with “vampire blood” bought from the drug store when I was 12. You can also zoom in on her face in other photos, if you want to look them up. When you do that you can tell she is not dead because she has too much color in her skin. Same thing we saw with Sharon Tate. Her mouth is also way too nice here, since if she were really dead she would have lost control of the muscles. Her mouth would be open in some ghastly gape. Instead, you can tell she is still in control of it, showing us she is alive.

But the best evidence is given you by the mirror behind her. Do you think that is just an accident? No, they staged it that way so that you could get the clue if you wanted it. You can see the back of the chair, can't you? So where is the bullet hole? No hole in the chair, no hole in the mirror. You will

say, “maybe she was sitting up real straight, and the bullet went over the top of the chair when it came out.” Nope, since in that case it would hit the mirror.

Also notice that the chair is white. Again, not an accident. They staged it that way on purpose, just to prove how stupid you are. A murder in a white chair, and no blood on the chair at all? And no one ever noticed that? It was never brought up in court. How could it be, since defense never argued this was faked.



They even give you all angles, to rub it in good that you are not Sherlock. There you see the mirror is right behind her in the first pic, and only a few inches back in the second pic. So the bullet would have to hit the chair or mirror. But it didn't.

You will say, “No, the bullet lodged in her skull”. But they show you the gun, too, on the floor beside her. It isn't a derringer or .22, so the back of her head could not possibly stop that bullet. At most angles, a bullet going in the mouth will come out the back of the neck, not having to pass the skull. But even if the angle is up, and the bullet goes through the skull with no problem. The bullet will go right through the bone. Just think about it: If the human skull was capable of stopping bullets at point-blank range, no one would ever die from a head hit.

I also note that she is sitting with her purse. That's very strange. That would indicate she never moved once she came in the door. Makes no sense if she was on a date, but makes perfect sense if she was just there to get photographed with some fake blood on her face. “Hi Lana, just sit here and we will get this done as fast as possible. We are just going to put a bit of moulage on you, take a few photos, and then you can go.”

He [Renteria] noted that a large smear of blood on the banister of a staircase next to her body showed only her DNA.

The only way that could be true is if she put it there. But if she was dead, how did she get up and smear her blood on the banister?

With the emphasis on forensic evidence as the trial entered its seventh week, Renteria also testified about the unexpected absence of blood spray from Clarkson on a wall near her body or on the carpet in front of it, suggesting something or someone in front of her could have blocked it.

That makes absolutely no sense. Don't you think Lana might have gotten suspicious when Spector said, "Here, Doll, sit in this chair. Don't mind the gun, I am just going to put this tarp behind you, and then drape another in front of you like a bib. It is just a little fetish I have with tarps."

Also consider this: if Spector was such a genius he was able to block all blood splatter by surrounding Lana with tarps while she was still alive, why did he leave the gun lying on the floor beside her? When disposing of the tarps, why didn't he just dispose of the body and gun in the same place? Who disposes the tarps but leaves the body and gun there?

Renteria testified that an old-fashioned cloth diaper found in a downstairs bathroom contained three bloodstains matching Clarkson's DNA and that a fourth stain with Clarkson's DNA and a little bit of DNA that could be identified only as from a male.

Really? And what was Spector doing with cloth diapers? Do you have cloth diapers lying around the house? I don't. And what kind of novel DNA test finds it is from a male, but can't tell you anything else? They are just spitting in your face here.

Spector's chauffeur said that at 5 a.m. he heard a loud noise and saw Spector emerge from his home holding a gun and saying, "I think I killed somebody."

So why was Spector's chauffeur Adriano de Souza hanging around at 5am outside Spector's house? He sleeps in the car, just in case, with one eye on the front door? And why was this young, highly trained "Brazilian military officer" working as a chauffeur for Spector? No one ever asks that question, do they?



Wouldn't you like to know his rank and previous assignment? I would. I am guessing something like Special Forces or Intel. Is he related to the Brazilian world surfing champion of the same name? He is listed twice by Instantcheckmate, as both 53 and 51, of LA, Manhattan Beach and Santa Monica. In one listing he has no relatives, in the other he is related to a Pereira. We have seen these Souzas and Pereiras before, since they are Marranos.

I think that is more than enough to go on, so I would say we have another one in the can. The wall of sound has finally been pierced.

*We are told there was an appeal to the California Second District of Appeal, but I could find no information on that. The California Supreme Court declined to review, as did the US Supreme Court. In this fiasco, the event is blown again, since they admit prosecution introduced evidence in trial that included videotapes of pretrial comments by the judge, and the judge then refused to allow cross examination of that evidence. This would make the judge a witness for the prosecution, something that is so outre it is not to be believed. Except as proof this was a dummy court.
