

The Fake “Scream Killers”

This is the 2006 event from Pocatello, Idaho, where those two highschool juniors supposed killed a female friend and classmate for sport with knives, to be like the movie *Scream* and their heroes from Columbine. So we can already tell it is an Intel fake just from that, since they are referencing their own previous fakes. Columbine was also a fake, run out of the nearby Air Force Base in Denver, and of course Hollywood is a CIA production.

Torey Adamcik, the second guy there, is listed in the Idaho prison, Kuna, but strangely the big computers don't know he is there. Only the local prison computer knows he is there. Prison records are very easy for government computers to tap, since they are government and public records. But none of the people searches like Instantcheckmate, FastPeopleSearch, or Radaris have ever heard of him. He doesn't exist nationwide and never did. His mother is given as Shannon, 58, and she is listed in Meridian, wife of Sean, 61. They are related to [Watson \(Gary and Dana of Merlin, OR, linking us to the Stoddarts below\)](#), Adams, Parsley, Vandiver, Novak, and Simental. With more digging I found the name Adamcik is Jewish and comes from [Moravia](#), where they had names like Alois and Aloysius.

Same for Brian Draper, listed in the jail but the big computer does not know he is in Kuna. Instantcheckmate does have a possible listing for him, but with no age, no relatives, and a location of [Meridian](#), ID. Very suspicious that no relatives are listed, just like at Wikipedia. FastPeopleSearch tells us this Brian Draper is 70, so apparently not him. Maybe an uncle. I found a Brian Draper, 38, of Saint George, UT, and he also goes by Alexa Woodbury, so either a tranny or a mistake by the search.

With some digging, I found our Brian's parents given as Pam and Kerry Draper, so that may help. I found Kerry, formerly of [Meridian](#), possibly linking us to that 70-year-old Brian Draper. Also of Herriman, UT, linking us to the Mormons. He links us to the Lunds, Muriettas, Manwarings, Lathams, and Edwards, the [Edwards famously being close cousins of the Stoddards](#). Why does that matter? Because the fake victim is a Stoddart. Kerry is still married to Pamela Draper, formerly of Riverton, UT, and she is related to [Byington, Folger and Campbell](#). FastpeopleSearch lists over 50 relatives for

Kerry and Pam, but not one is Brian Draper.

We wouldn't expect Cassie Jo Stoddart to appear in these records, since she was underage at the time of the event, and allegedly died at age 16. They don't list under 18. However, I ran a check anyway, because we have often found these “dead” people still alive in many other fake events. She doesn't come up for Idaho, age 36, but there is a Cassandra Stoddart, 34, in Ohio and a Cassandra Stoddart, 38, in Massachusetts. There is a Cassandra Orr Stoddart, 82, of Henrico, VA, who may be the namesake of Cassie. Why do I say that? Because Henrico may be FBI. Which reminds us of two things. Listing the victim as Cassie Jo doesn't make much sense, since both those names are nicknames, shortenings of Cassandra Josephine, probably. Telling us we are being yanked from the get-go, as usual. I pegged this as fake from the start due to stuff like that. CIA often lists names this way, even in court documents, just to mess with us. It also reminds us that the Stoddarts are a big spook family and have been for centuries, back to the American Revolution and before. They have come up in my papers many times. So that surname is also a huge red flag off the top. It is also suspicious that the Wikipedia page for this event hides most relatives of Cassie, giving no parents. We have to go to Grokipedia, which tells us they are Ronald J. Stoddart and Anna Maria Sisneros.

Wikipedia does tell us her uncle and aunt, Frank and Allison Contreras. A search on that finds Frank Contreras, 67, attorney, related to Allison, formerly of San Jose and Mountain View. Which is Google: a big government spook hub. Frank has a brother or alias of Francisco Contreras, age 56, also of San Jose. Allison is Allison Serr Contreras, 56, listed as working for AVCenter Inc. which is a private jet service in Pocatello, setting up rich people with Lears. Which reminds us that Pocatello Airport used to be an Air Force Base, and four large hangars from that still exist. FBI also has offices there. So as usual, everything we discover points us right at the FBI/CIA/Air Force.

Ronald Stoddart, 65, is now listed for Palmdale, CA, though his current wife is Yolanda, 75, not Anna Maria. Anna, 61, still lives in Pocatello. Yolanda's maiden name appears to be Cardenas. Browsing and collating the pages at Findagrave, I found proof of what I already suspected: those Stoddarts of Pocatello are Mormons related to Judds, which means they are crypto-Jews. Same for the fake perps Draper and Adamcik, Draper being born in Sandy, UT. I already knew that because the famous Stoddarts/Stoddards of the East Coast have always been prominent Jews/Phoenicians. I remind you of Arthur Stoddard, son of Solomon Stoddard, a billionaire from carpets, silks and tapestries, Jewish trade #2 after banking/goldsmithing. These Stoddards were closely related to the Downings, Eyres and Winthrops, linking them to the Stuarts.

Now that you have a lay of the land from those people searches, we can look at the “facts” of the event. We also know this is fake because a tape survived of the boys planning and bragging about the whole thing. It allegedly survived a burning and burying, after the boys got spooked. They tried to hide all evidence, but couldn't figure out how to burn a tape?



Also couldn't figure out how to burn paper. Is that what you would do? Burn the edges, but be sure to leave “murder”, “kill”, and “Cassie” and then bury it poorly, then tell the police where it was? Genius.

Here's another problem:



That's a more recent picture of Brian Draper, but it's an obvious fake since the jail would never shoot him from below like that in that terrible orange light, since it makes it hard to identify him. See how the reflection of the overhead lights hides his eyes? The eyes are the most important thing in an identification. Even worse: they didn't bother to get his ID# right.

The current page for him at the jail says #85763. The picture above says #86328. Similar, but not the same. Busted.

Next I checked the address of the house where this allegedly happened, 11372 W. Whispering Cliffs. We are told it is in Pocatello, but it isn't, precisely. It is in Tyhee, a suburb, which was way out on the edge of town back in 2006. The perfect place to run such an event. From satellite photos, we can see that it is a large house, though not huge or expensive, but it appears to be connected to the house next to it by a walkway, which is strange. Together they would be worth over a million and cover a bit of land, also being on the edge of fields. So there's that, for what it's worth.

But that got me thinking. If these rural folks had dogs and they were going to be away for days, they would either put them in a kennel or have neighbors drop by and feed them. They wouldn't tap their teenage niece to house sit, since as we see from the story she was expected to spend nights there as well. But this was September 22, so school had started. How could this teenage girl be living full time way out on the edge of town during school? You will say that day was a Friday, so she didn't have school the next day, but even so no one would tap a teen girl to house sit by herself in a huge house on the edge of town, next to open fields. She wouldn't want to do it and her parents wouldn't let her regardless.

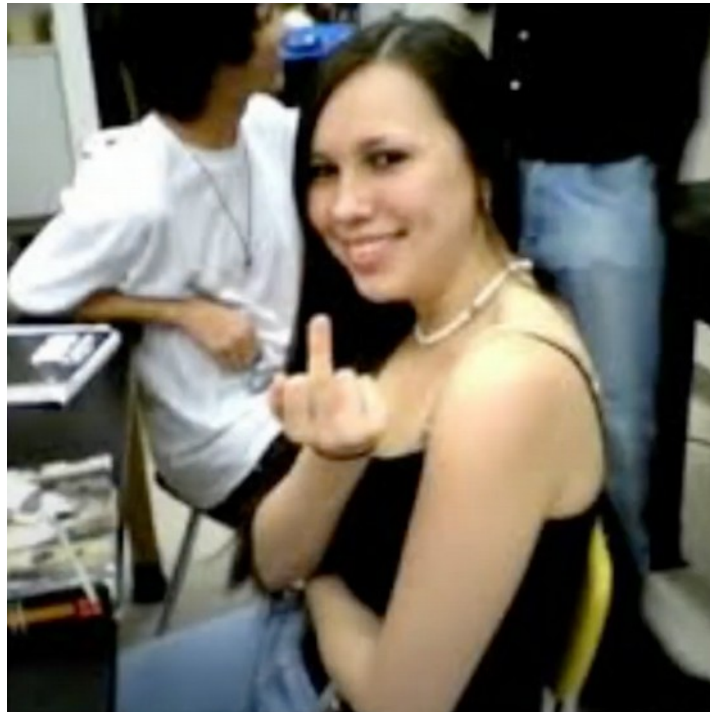
Also interesting is that that house backs up to the Buffalo river, having river access. This creek runs through Pocatello like a series of canals, connecting in places to the larger Portneuf river, which is suggestive. FBI is about 4000ft from Buffalo creek and 5000ft from the Portneuf river, which also goes to the airport. The house is about 1000ft from the Shoshone Indian Reservation. Even weirder: there is a Mormon church just over the boundary of the reservation, *on* the reservation, less than a mile from the house! So are Shoshones now Mormons? Huge red flag here, given these families.



Why is that so blurry? I suggest to hide the fact she looks way older than 16 there. This is also strange, since it looks like a paste, to put her in front of the school:

We have seen stuff like that many times. They also got AI to redo the first one above:



Spooky.

Also a problem is that they admit Stoddart and her boyfriend were close friends of Draper and Adamcik. So Draper and Adamcik decided to kill their best friends as part of their big plan to get famous? Is that what you would do? No, you would kill your worst enemies, right? You would kill someone you hated, not your best friends. My guess is all these people were related, which is one of the things I was looking for above. But because they are all so scrubbed, it is quite difficult to do. So let's try again on the way out, seeing if we can get in through the boyfriend Matt **Beckham**, who would also be 36 now. Yep, he comes right up, though he is only 35. He now lives in Boise, and I was right: he is related to Keith **Sumner** Edwards, 70, and we saw the Edwards above, closely and famously related to the Stoddards. He is related to **Owen, Chase, Carson, Lemons, Meyers, Bohan, Westermeyer, Zwart, and Sears**. Sting is a Sumner. So Cassie's boyfriend was a Jewish cousin, taking us halfway there.

These Stoddarts of ID go back to **Cleveland** Stoddart, b. 1907, and to Francisco **Villaverde**, Cassie's great-grandfather mentioned in her obituary. They are also related to Watsons (Brittini, of Nampa), which I remind you may take us back to the Adamciks, who are also Watsons. Brittini is related to Brett Watson, who is related to a Jennifer **Ball**, 55, of Daytona Beach, aka Watson and **Glaczinski**. I remind you that George **Washington** was a Ball. She links us to the Balls of Myrtle Beach, SC. We also link to the **Cowans and Copelands**, and you know what that means. The name Glaczynski is Polish, of Jewish nobility, being a part of the Lubicz coat of arms. They are related to Gogol, Wroblewski, Abramowicz, Bogdanovich, Brzezinski, Jankowski, Katski, Kozinski, Polanski, Romanowicz, Wojtkiewicz, Wysocki, and Zielinski (Zelensky).

Now let's switch to the Watsons related to the Adamciks. Hitting their oldest relatives takes us back to Chicago, where we find them related to . . . the **Washingtons, Carters, Flemings, and Armstrongs**. See Charlene Watson, 102. So, yes, the Adamciks and the Stoddarts are related to the same Jewish

American royalty that comes up every time in our searches. Which means I proved my point: all these people in Pocatello are close cousins, indicating an inside job.

More proof this is all a fake is its connection to the Nori Jones fake. Jones was allegedly killed in 2004, a guy named Brad Compher was arrested ten years later, and convicted ten years after that . . . which makes no sense. They kept him in jail for ten years with no trial because he was “mentally unstable”. But that is impossible, due to the right to a speedy trial. Ten years is not speedy. If there was a finding of incapacity, he should have been moved to a mental facility until the trial. They had no legal right to hold him in a jail for ten years, especially since the only evidence they had was DNA on an old cigarette butt. I remind you that DNA evidence is not enough to convict of murder.
