

Another Fake CIA Trial

Zerohedge is reporting today the conviction of Dexter Taylor, a 53-year-old black software engineer in New York, of multiple gun violations, including many counts of criminal possession. All for allegedly hobby gunsmithing firearms for his own personal use. He now faces 10-18 years in prison. Oh, what do you know, aces and eights, Chai. Just a coincidence, I'm sure.

But that isn't how I first knew this was fake. It was here:

Do not bring the Second Amendment into this courtroom. It doesn't exist here. So you can't argue Second Amendment. This is New York.

That is the judge, Abena Darkeh, speaking to Taylor's attorney Vinoo Varghese (above, center, in a previous trial). So we are supposed to believe we have a judge telling people the Constitution doesn't exist in her courtroom. Where did she go to law school, Ixtapa? This isn't even remotely believable. If any of this were real, not only would the case be immediately overturned, this judge would be recalled and permanently disbarred.

The comments from Varghese are funny as well. He says they have a shot at winning on appeal. Yeah, you think? He says Darkeh prosecuted the case herself from the bench, interrupting his opening and closing statements and instructing the jury to find the defendant guilty or "face consequences."

It reminds of Alex Jones' fake Sandy Hook court cases, doesn't it, where his fake judge told him and his attorney that they could not bring up the First Amendment in her court.

Also notice the joke name. Abena Darkeh, who just happens to be black.



Since Darkeh=Darky, that is either a highly unfortunate real name or a CIA joke name, testing our gullibility.

At Lawenforcementtoday.com, we find more on the case. Darkeh was the **third judge** to preside over this one simple case. Why? We aren't told. I guess we are supposed to assume the other two died prematurely of the death shot.

Darkeh recently moved from New York County to Kings County Supreme Court, and instead of a judge she is listed as an “**acting** justice”. What does that mean? Why a justice and not a judge? Normally it means she is part of a set of judges, like the US Supreme Court, which acts as a group. But she did not do that here. And what does “acting” signify? That she is a CIA actor here? Again, we aren't told.

Trellis tells us Darkeh was appointed by Mayor Warren Wilhelm, Jr. Who is that? Well, if we search it turns out that is Bill de Blasio's real name. He changed his name in 2002 at age 41, and we are told it reflected his alienation from his father. His father was an economist for Texaco and then for the Dept. of Energy. His uncle is CIA. His mother was also CIA, working for the Office of War Information. She wrote a book selling the whole Mussolini thing as real. **It wasn't.** His wife is from Barbados, and you may think that is why he likes to appoint black lady judges. But **with a little research I discovered that wasn't the case.** It can't be the case because judges in the Kings County Supreme Court **are not appointed by the mayor**. Neither are judges for the criminal court of New York County. Only family court judges in New York City are appointed by the mayor, and Darkeh is not a family court judge. So she could not have been appointed by De Blasio.

In the New York State court system, the vast majority of state judges are elected; while some are appointed, the methods vary. Justices of the Supreme Court, New York's trial court of general jurisdiction, are elected by the voters of the judicial district in which they serve. Candidates do not run in primaries; rather, they are nominated by judicial conventions in their districts.

We also have this problem: if De Blasio legally changed his name in 2002 and appointed Darkeh in 2015, why does Trellis list him as Warren Wilhelm? They must know something we don't: namely, that he never legally changed his name. It is a CIA alias more than anything, I guess. We knew the country was being run by the CIA, we just didn't realize it was this directly.

De Blasio sells himself as an Italian, but he is Jewish, being from Jewish/Italian/French noble lines as well as German Jewish lines, including Lutz, Warren, Rikart, Gaudet, Navarre, Briganti, and Schiavone. The Brigantis are big New York clothiers, proving that. The Warrens are the Warren knights from Cheshire who helped found Maryland. They are related to the Asshetons, Davenports, Booths and Talbots. The Navarres are French nobility and bankers, being the treasurers of Villeroy and then treasurers and governors of Detroit. In that line De Blasio comes directly from the Kings of Navarre. Another thing Ethnicelebs hides from you is that De Blasio is also a De Laurentiis, linking him to Dino de Laurentiis.

It is commonly known that De Blasio's wife Chirlane McCray is a black writer. What is less commonly known is that she is a lesbian. Who marries a lesbian? De Blasio, apparently. One of her first published articles was for *Essence*, entitled "I am a Lesbian". So it doesn't require any guessing or decoding or outing. She led both the Mayor's Fund to Advance NYC and ThriveNYC, both of them appearing to be just fronts for money laundering or something. Although she was the chairperson for the former, the *NYT* reported in 2018 she hadn't been seen in their offices for over a year. As for the latter, Wiki now reports that ThriveNYC spent about a billion of taxpayers money over five years, with 85% of that unaccounted for. How is that possible? Maybe De Blasio should have started a Mayor's Fund to Advance Accounting.

But back to the current fraud. We also have this little problem: Dexter Taylor doesn't even live in New York. [He lives in Jersey City](#), so how did New York SWAT bust in and arrest this guy [in New Jersey](#), charging him under New York laws?

And more red flags:

That's from the lawyer's own website, in the "about" section. Tends to confirm my line here, doesn't it? He teaches trial advocacy at Harvard but gets his client 18 years for private gunsmithing? He teaches at the New York City Law Department but this guy Taylor hired him to argue against the . . . New York City Law Department? Amazing that didn't work out for him, right?



Notice that Vinoo has also appeared on **CourtTV**. I have shown you in many papers, [including my long one on OJ](#), that CourtTV is a CIA front. This guy is another obvious agent.

So what is this story really about? Obviously it is about scaring you away from gunsmithing of any kind, including legally modifying any guns you have. You are supposed to believe you may need a gunsmithing license, and that you may end in jail for 18 years if you misread some law. It would be like telling me I need a bike repair license to work on my own bikes. Ridiculous on the face of it, but the governors are clearly frightened by the possibility of an uprising. They are busy as bees trying to bluff you out of resisting them in any way. They want you hiding under the bed, waiting in fear to be swatted by the Feds for nothing.

And we find a second fake conviction today, that of John Sullivan, the guy who filmed the fake death of Ashli Babbitt in the Capitol building on January 6, 2021. *The Epoch Times*—supposedly a revolutionary magazine—is reporting [this](#), but they forget to tell you all the important stuff, the main thing being [what I told you three years ago](#): Sullivan is the son of three-star Air Force lieutenant general Kevin Sullivan. Ashli Babbitt is Air Force. And Air Force theatrical had lots of other players in the Capitol on January 6, along with CIA, FBI, Homeland Security, and everyone else.

Sullivan was allegedly sentenced to six years, but of course that will all be thrown out in June by the Supreme Court, along with 353 other fake convictions, since they are all based on a fantasy reading of felony obstruction. Even if they aren't thrown out, it won't matter, since none of those people are really in jail and never were. Like Sullivan they are just government actors pretending to phone in reports from jail in DC. When they are really on some soundstage in Television City, Hollywood, or Langley, Virginia.
