

# Problems with the 2020 Nashville “Suicide Bombing”

This is by request, so I am going to hit it at full speed.

Warner said to have no prior arrests back to 1978, when he would have been 21. So what is the photo above? Looks like a booking photo, see the cords of the mugshot ID around his neck, conveniently cut off before the FBI released this. Is he 21 there?

VIN number allegedly found for camper. Nearly impossible given the damage to surrounding buildings. The explosion blew parts two blocks away. So the odds of finding an intact or readable VIN are vanishing. Almost as unbelievable as the hijackers' passports being found on the street after 911.

Police arrived at 5:30 and heard the bomb warning, so they should have called it in immediately. The bomb went off a full hour later and the bomb squad arrived about ten minutes later. Not believable. That is so much time they actually had time to tow the camper to the river and dump it in.

Why would Warner arrive at 1:22am and sit there for four hours? He wanted to take a nap before killing himself? It makes no sense. There were many security cameras, and parking there on Christmas Eve in a camper should have raised immediate suspicions. It could have ruined his plans. Better to arrive at a given time and immediately put the plan into action. The fact that the camper was

parked hours earlier indicates Warner wasn't in it when it blew. As does the stupid story that there were any remains to identify. Any human tissue should have aerosoled in such an explosion, making DNA recovery impossible, which is precisely why they had to pretend to reconstruct a VIN number so that they could identify him. If they could identify him from a DNA match, they didn't need a VIN match, did they?

If Warner was a crazed maniac, full of anger at ATT or anyone else, why did the event have so many joke elements, like the tape playing Petula Clark's *Downtown*? Sounds like an FBI or CIA joke to me, boss. Same with his name, which is probably fake: **Anthony Quinn** Warner. As in the actor Anthony Quinn. We often see that, since these jokers love to reference Hollywood.

If there had been warnings from the camper and police to clear the area for a full hour, how did **eight** people manage to get injured? They just wanted to get that number eight in there?

We are told that a year and a half earlier police had been alerted to Warner making a bomb by his girlfriend and housemate Pamela Perry and her attorney, but they did nothing. They made no contact with Warner, did not enter his home, yard, or vehicles, but closed the case based on an officer driving by. The FBI also did nothing, though it was reported to them. Instantcheckmate has no death record for him, since it thinks he is still alive, now age 66/67. Swing was working at AEG Presents in LA at the time of the event. That's curious since AEG is owned by billionaire Philip Anschutz, also involved in the Aurora event. He owned the theater where fake shooter James Holmes allegedly killed 12.

Warner allegedly retired from his job as a tech specialist for Fridrich and Clark Realty just 20 days before the event. Company president Fridrich said Warner was a "nice guy". That doesn't match what neighbors said about him or a description of his property. So someone is lying. I assume everyone is lying.

Pamela Perry's previous addresses all match to military bases, including Smyrna, TN, and Sand Springs, OK. Both happen to be National Guard bases.

So as usual, this story doesn't hold any water. Best guess is Warner was never in the camper and is still alive somewhere. Then why was the explosion staged? The bank wouldn't wish to publicize it, especially in this case where it appears FBI/military may have been a player. Just a theory.

If it isn't that, next best guess would be insurance fraud, with one of those buildings demolished on purpose as we have seen many times before.
