

# Today's Stage Notes from Minneapolis

*Just my opinion, as usual, based on the free internet research I do below*

I was about to tack this on to yesterday's paper, but decided to make it one of its own. The vaudeville continues in Minneapolis, home of the George Floyd fake, as fake federal police faux-arrest three of the people who stormed the Cities Church in St Paul on [January 18](#) (aces and eights) with Don Lemon, proving that was faked. The most photogenic was "William Kelly", above, who soiled the stage daring Pam Bondi to arrest him and calling her a traitorous bitch. You have to laugh at the poor scriptwriting and direction, as well as the chew-the-scenery acting from Langley. He's so angry and brave, but can't dare to put the word "fuck" on his hat. Has to put "f\*ck", as all tough guys do. Then he has the Muslim scarf, as if he is in the direct line of Muhammad. And his "resist the coup" patch that he has ironed on to his CIA-issue high visibility jacket. The ensemble really clashes, don't it? Kelly is the worst actor since Jacob Chansley of the J6 fake event. Chansley was an idiot, but at least he had a cool name—the QAnon Shaman—and a buffalo headdress.

And who are those policemen? Feds, but not ICE and not FBI. Since they aren't ICE, we have to ask why they are masked? Are all Feds masked now? How is that legal? And why don't they match? The two uniforms don't match. Do federal police really wear their caps on backwards? You think that isn't a clue this is fake?

I looked it up, and [they are telling us those guys are FBI](#). They don't look FBI to me, since FBI normally has FBI on their vests and/or hats.

So let's look up this stooge. To start with, they seem to recycling names again, since there was a [William Kelly in the Rittenhouse event in 2021](#). He was the Virginia police lieutenant allegedly fired for donating \$25 to the Rittenhouse legal defense fund. Again impossible, since it is illegal to fire someone for giving to a charity, just because you don't like the charity. It is a Civil Rights violation. They want you to think this may be legal, because it might keep you from giving \$25 to someone like me, you see. But it isn't.

Plus [the story never made any sense](#):

**Lt. William Kelly, who worked in internal affairs for the Norfolk Police Department, was terminated after he expressed support for Rittenhouse and made an **anonymous** \$25 donation to his defense fund. The officer's message at the time read, in part: "God bless. Thank you for your courage. Keep your head up. You've done nothing wrong."**

Note the anonymous part. How would the Norfolk Police Department even know Kelly had made an anonymous donation? Unless they were spying on him, which is also a Civil Rights violation. We are supposed to believe the Rittenhouse fundraiser was hacked, with the list of credit cards given to *The Guardian* newspaper in London, which published a piece on it naming Kelly, which Norfolk PD saw online. Right, and you believe that? If this weren't staged, *The Guardian* would have opened itself up to huge lawsuits for naming anonymous donors, since this was private financial information. But even if we ignore that pertinent fact, in your private capacity as a citizen you can donate to anyone you like and support any political cause you like, and there isn't a damn thing your employer can legally do. Even if you are a cop or are in the military. It is part of your Constitutional right to free speech and free association. Only if you were doing something illegal could you be fired for cause, but feeding someone's kitty is not cause. Besides, I shouldn't need to remind you that Rittenhouse was acquitted, so the PD had no case against Kelly. You can't be fired for supporting an innocent man. But of course it is deeper than that, since the whole [Rittenhouse event was staged as well](#), so you should assume this firing of William Kelly was staged as part of that vaudeville. As it turns out Kelly was just a couple of weeks short of retirement, so we may assume he simply did that, with the rest of this just a story fed to the papers by CIA.



One of the others arrested with the current William Kelly is [Nekima Levy Armstrong](#), a black female attorney who was the organizer of the church invasion. She is a former president of the Minneapolis NAACP, the current CEO of a cannabis company, and [manager of a civil rights non-profit](#) that paid her a \$250,000 salary in 2024. Note her name, which is two big red flags, Levy being Jewish and the [Armstrongs being a top Phoenician Navy family](#). Indicating she is some kind of half-Jewish spook working for the Feds.

She was born Levy-Pounds (Pound also being a Jewish name, [think Ezra Pound](#)) and has her own Wiki page, but they fail to give parents for her, which is suspicious. They also fail to name her husband,

where I assume she gets the name Armstrong. She has been working with BLM since at least 2014, and was involved in the Jamar Clark protests of 2015 and the George Floyd protests of 2020, both of them staged. So she is some kind of professional agitator/actor. In the name of thoroughness, I looked her up on a people search. She has Hyattsville, MD, on her locations list, though her Wiki page doesn't mention her ever living in Maryland. That is just north of DC and is probably another bedroom community for Langley, is my guess. She also has a lot of Los Angeles-area locations, including Inglewood and Palmdale, so we can assume that is where she studied acting. Her first relative is Marques Armstrong, so I guess that is her husband. And you are about to find out why he is hidden in her bios. He does have a [LinkedIn page](#), where we find this:



In the current vaudeville, we are told these people invaded the church because its pastor, David Easterwood, is the acting field director for ICE in Minneapolis. Which of course makes no sense. Why would ICE be run by a pastor? Either the story is false, which blows Levy-Armstrong's claims, or it is true, which would mean the church is just a front. In which case the event is blown as fake from the other end. Either way, it looks staged.

Nor is it explained why Don Lemon was there, since he lives in New York. His presence just proves again this was a gathering of agents and assets. The judge who accepted the charges against the other three refused to sign the complaint against Lemon, on the grounds he was a journalist. But we should assume it is because Lemon agreed to be there but didn't agree to be part of the arrest or trial theater afterwards. I guess he doesn't like the prison jumpsuit style as much as Maduro. It doesn't go with his yellow cashmere turtleneck and wingtips.

I wanted to check to see if David Easterwood really worked at Cities Church, [and apparently he does](#).

This small church has eight pastors, all young men, so it continues to look very suspicious. Why do they need eight pastors and six deacons? It appears to be non-denominational, since I couldn't find any indication it had any affiliation, but at the same time it claims to be fundamentalist, selling the Bible as true in every word. Those two things don't normally go together. It is progressive churches that tend to be non-denominational, with non-descript titles like "Cities Church". This is also weird:



What do you notice there? All young good-looking white people, with no one over thirty. At a fundamentalist church in St. Paul? So that's staged in some way, either by AI or by CIA. You may say, "Ah, so Levy-Armstrong and Lemon were right: this places IS a community of Nazis." But that isn't my reading. Those people don't look like Nazis, either. They look like college students hired to be models. My guess is that photo is just a generic photo used to mock-up this website, and that Cities Church is just another in a long line of churches taken over by CIA.

Although church attendance is up since 2021, for decades it was way down, especially among the young, and everyone knows that. In Europe it is even worse, and most of the churches over there have been taken over by other entities and repurposed. But to a lesser extent that happened in the US as well, especially in the period 1980-2020. These old churches in the big cities went bust and many of them sat empty for years. The bigger they were the harder they were to heat, especially in the north, so no one wanted to buy them. Which left an obvious opening for CIA to move in and use them to run their Operation Chaos projects. I have shown you many examples of that in NYC, since they have been doing it there for almost a century. We saw the Modernists taking over churches in Manhattan and using them for wild art and music "happenings". Admitted CIA agents became pastors and pushed ahead various projects. See William Sloane Coffin, as just one example of many. A member of Skull and Bones, he pretended to be at various times a Presbyterian, Baptist, and Church of Christ head minister at Riverside Church in Manhattan. That's rich, since as I have reminded you, Presbyterians and Baptists don't normally have much in common.

And another thing is strange about the pastors at Cities Church: their names. Segal, Schumann, Kozak, Polley, Helstrom, Easterwood. Six of the eight look Jewish. One of the deacons is a Fuehrer and one of the deaconesses is an Andrea Hoglund.

Easterwood is a variant of Eastwood, and may be fudged here to throw you off. The first three names are definitely Jewish, and Polley probably is too. See actress Sarah Polley, admitted to be Jewish, her father is Harry Gulkin and her grandmother is Raya Schinderman. Helstrom is Swedish but also can be Jewish. Eastwood can also be Jewish, see Clint Eastwood, who is also a Reitz and had a child with Frances Fisher, Jewish. That was probably a cousin match, since the Fishers and Eastwoods have been marrying for centuries. See the peerage for John Fisher [Eastwood of Surrey](#), b. circa 1850. The Eastwoods of the peerage are related to the Mountbattens, tying them closely to the King. The Mountbattens go back to the Princes von Hessen and the Saxe-Coburg-Gothas, German/Jewish kings. The Eastwoods are also related to the Hares and Dillons, and through them to the Lathams and . . . Kellys. I remind our perp here is William Kelly. Also related to the . . . are you ready? . . . [Armstrongs](#). The Eastwoods in the peerage are also Kellys and Armstrongs. Strange, isn't it, that the very same surnames started popping up at [thepeerage.com](#) that were coming up at Cities Church in St. Paul, on the pastors' page. If that is just a coincidence, it is quite a doozy.

A people search on this David Easterwood shows he is related to Rebecca Easterwood nee Wysocki, as a wife or perhaps sister-in-law, and that name is again Jewish, supporting my line of reasoning here once again. Through Angela Easterwood he is related to Buechners, again Jewish. See Wolf Buchner and of course Ernst Buchner, apropos here since he was also a fake Nazi. Ernst was a Bavarian State art curator, famous for looting many works from Jews for the Nazis and for himself. One problem: his dissertation at university was on Jan Polack, a Jewish artist working for the Jagiellons. Why would a Nazi write his dissertation on a Jewish artist? Now you know. If you don't know what I am talking about, you haven't read [this paper](#).

The third person arrested today was Chauntell Louisa Allen, another black lady lesbian who just happens to be a sitting member of the St. Paul Public School Board. So that isn't suspicious. Doesn't look staged at all. A people search on her also blows this event sky high, since through her first relative Darnell Allen she is related to Sharon Renee Kelley, 56, of Maple Grove. I remind you again our perp here is named William Kelly. But the media has given us no information on him yet, including age or location, and there are thousands of William Kellys. So nothing to go on yet. But he may be

William Kelley for all we know.

Sharon Kelley, 56, is related to Walter Kelley, 54, husband or brother, of South Bend, IN, who we find at Radaris as occupation: trial practice. So a trial attorney. No results at LinkedIN, and no results Google.

But what the mainstream doesn't tell us about Chauntyll Allen, her LinkedIN page does. Not only is she a schoolboard member, she is Director of Criminal Justice Policy and Activism at the Wayfinder Foundation, which she lists as her full-time job. She is also the founder of Twin-Cities BLM, proving she is an agent, since BLM is a CIA-creation. According to LinkedIN, this Wayfinder invests in women and girls. But the first result on a general websearch takes us to [wayfinder.foundation](http://wayfinder.foundation), an **expired website**. The second result is a fandom site, where we find the wayfinder foundation is an explorers guild on planet Eberron, of Dungeons and Dragons. So we are just being yanked again here. The next result is withwayfinder.com, but it is not the right website since it is not ladies only. Its lead pic is two black boys with a white girl in the background. Then we find an [every.org](http://every.org) page for the right Wayfinder Foundation in Waite Park, MN, but the page hasn't been claimed by the organization.

## This nonprofit hasn't claimed their profile.

Hmmm. That's curious, wouldn't you say? Another ghost organization. Proving my point again.
